Note 1: Test distance for frequencies at or above 30 MHz, measurements may be performed at a distance other than the limit distance provided they are not performed in the near field and the emissions to be measured can be detected by the measurement equipment. When performing measurements at a distance other than that specified, the results shall be extrapolated to the specified distance using an extrapolation factor of 20 dB/decade (inverse of linear distance for field-strength measurements, inverse of linear distance-squared for power-density measurements).







Electric field tests shall be performed in the frequency range of 30 MHz to 1000 MHz using a calibrated bi-log antenna. the antenna height shall be varied from 1 m to 4 m.




