

## **2. TEST CONFIGURATION OF EQUIPMENT UNDER TEST**

### **2.1. TEST MANNER**

- a. The EUT has been associated with personal computer and peripherals pursuant to ANSI C63.4-1992 and configuration operated in a manner which tended to maximize its emission characteristics in a typical application.
- b. The HP Printer, ACEEX Modem, HITACHI Monitor, SONY TV, HONEYWELL PS/2 Keyboard, GENIUS PS/2 Mouse and EUT were connected to the FIC PC for EMI test.
- c. The following display resolution were investigated during the compliance test:
  1. Horizontal frequency (640x480 to 1,600x1,200, 31 KHz to 106 KHz)
  2. Vertical frequency (60 Hz to 85 Hz)
  3. 640 x 480 (31KHz/ 60Hz) TV mode.
- d. According to the above tests, we listed the following display modes as the worst cases:
  1. 640 x 480 (31KHz/ 60Hz) TV mode.
  2. 1,280x1,024 (non-interlaced 91 KHz), refresh rate 85 Hz.
  3. 1,600x1,200 (non-interlaced 106 KHz), refresh rate 85 Hz.
- e. The V-video and S-video were tested in order to find the maximum emission. Since The V-video generates the worst case, the mode was used as the final data for TV mode.
- e. Frequency range investigated: conduction 150 KHz to 30 MHz, radiation 30 MHz to 2,000 MHz.

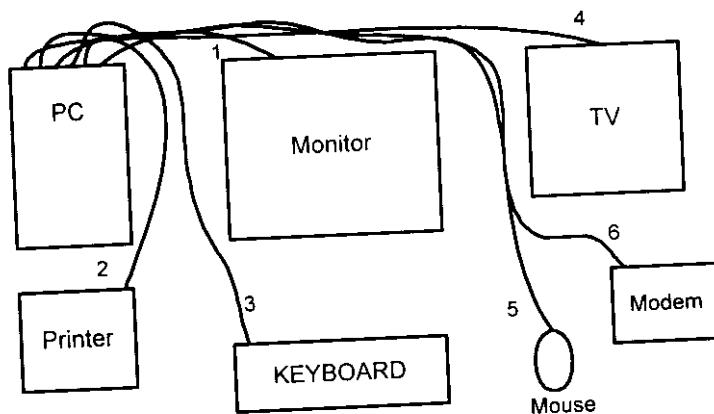

## 2.3. CONNECTION DIAGRAM OF TEST SYSTEM



1. The I/O cable is connected from EUT to the support device 3.
2. The I/O cable is connected from PC to the support device 1.
3. The I/O cable is connected from PC to the support device 6.
4. The I/O cable is connected from EUT to the support device 4.
5. The I/O cable is connected from PC to the support device 7.
6. The I/O cable is connected from PC to the support device 2.

### **3. TEST SOFTWARE**

An executive program, WINFCC.EXE under WIN98, which generates a complete line of continuously repeating "H" pattern is used as the test software.

The program was executed as follows :

- a. Turn on the power of all equipment.
- b. The PC reads the test program from the floppy disk drive and runs it.
- c. The PC sends "H" messages to the monitor or/ and TV, and the monitor or/ and TV displays "H" patterns on the screen.
- d. The PC sends "H" messages to the printer, then the printer prints them on the paper.
- e. The PC sends "H" messages to the modem.
- f. The PC sends "H" messages to the internal Hard Disk, and the Hard Disk reads and writes the message.
- g. Repeat the steps from b to f.

- a. Conduction : from 150 KHz to 30 MHz
- b. Radiation : from 30 MHz to 2000 MHz.

### **4.5. TEST DISTANCE**

The test distance of radiated emission from antenna to EUT is 10M.

## **5. TEST OF CONDUCTED POWERLINE**

Conducted Emissions were measured from 150 KHz to 30 MHz with a bandwidth of 9 KHz on the 115 VAC power and return leads of the EUT according to the methods defined in ANSI C63.4-1992 Section 3.1. The EUT was placed on a nonmetallic stand in a shielded room 0.8 meters above the ground plane as shown in Figure 5-3. The interface cables and equipment positioning were varied within limits of reasonable applications to determine the position produced maximum conducted emissions.

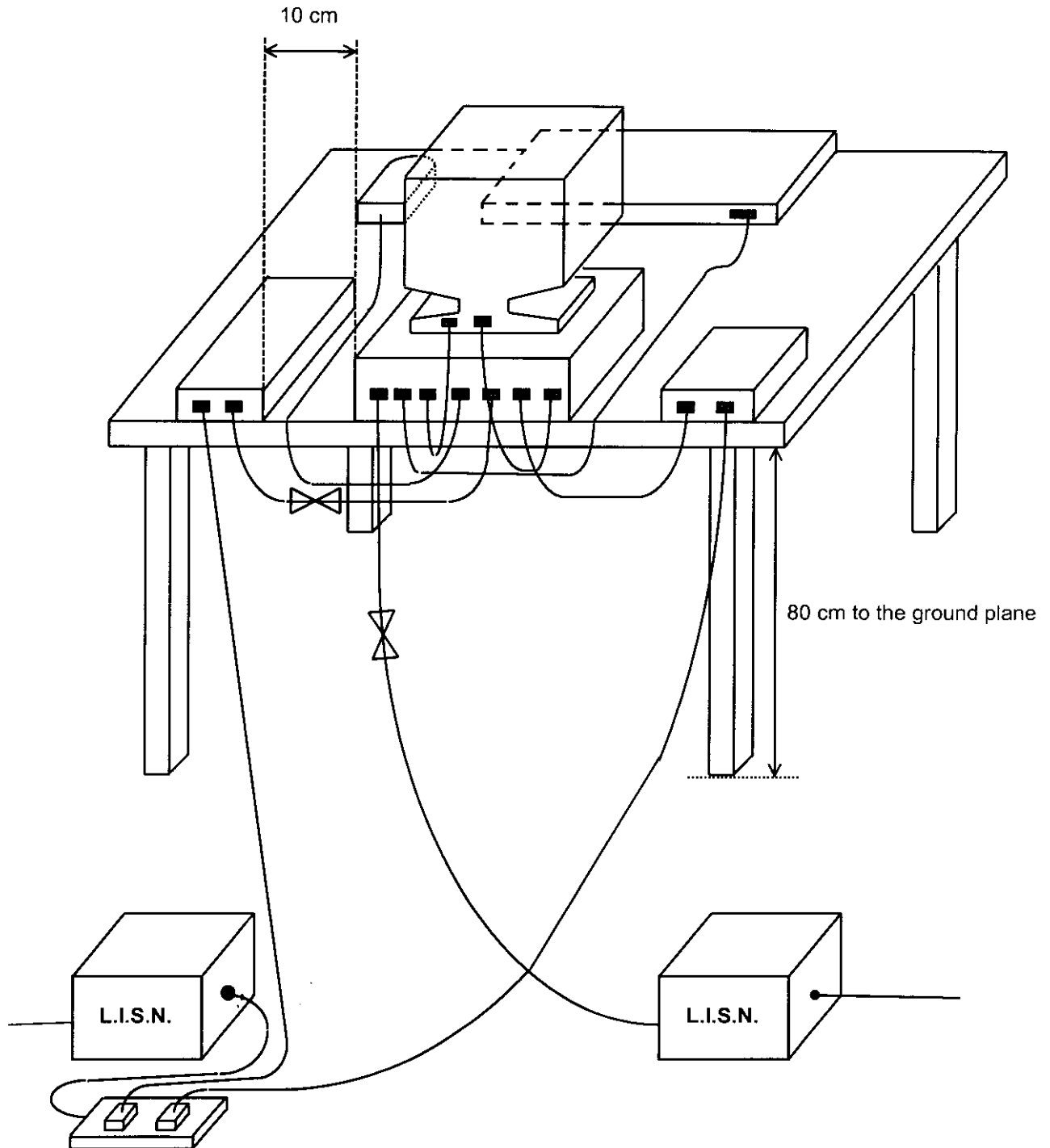

**5.2. TEST PROCEDURES**

- a. The EUT was placed 0.4 meter from the conducting wall of the shielding room and was kept at least 80 centimeters from any other grounded conducting surface.
- b. Connect EUT to the power mains through a line impedance stabilization network ( LISN ).
- c. All the support units are connect to the other LISN.
- d. The LISN provides 50 ohm coupling impedance for the measuring instrument.
- e. The FCC states that a 50 ohm , 50 microhenry LISN should be used.
- f. Both sides of AC line were checked for maximum conducted interference.
- g. The frequency range from 150 KHz to 30 MHz was searched.
- h. Set the test-receiver system to Peak Detect Function and Specified Bandwidth with Maximum Hold Mode.
- i. If the emission level of the EUT in peak mode was 6 dB lower than the limit specified, then testing will be stopped and peak values of EUT will be reported otherwise the emissions which do not have 6 dB margin will be retested on by one using the quasi-peak method and reported.

## **6. TEST OF RADIATED EMISSION**

Radiated emissions from 30 MHz to 2000 MHz were measured with a bandwidth of 120 KHz according to the methods defines in ANSI C63.4-1992. The EUT was placed on a nonmetallic stand in the open-field site, 0.8 meter above the ground plane, as shown in Figure 6-3. The interface cables and equipment positions were varied within limits of reasonable applications to determine the positions producing maximum radiated emissions.

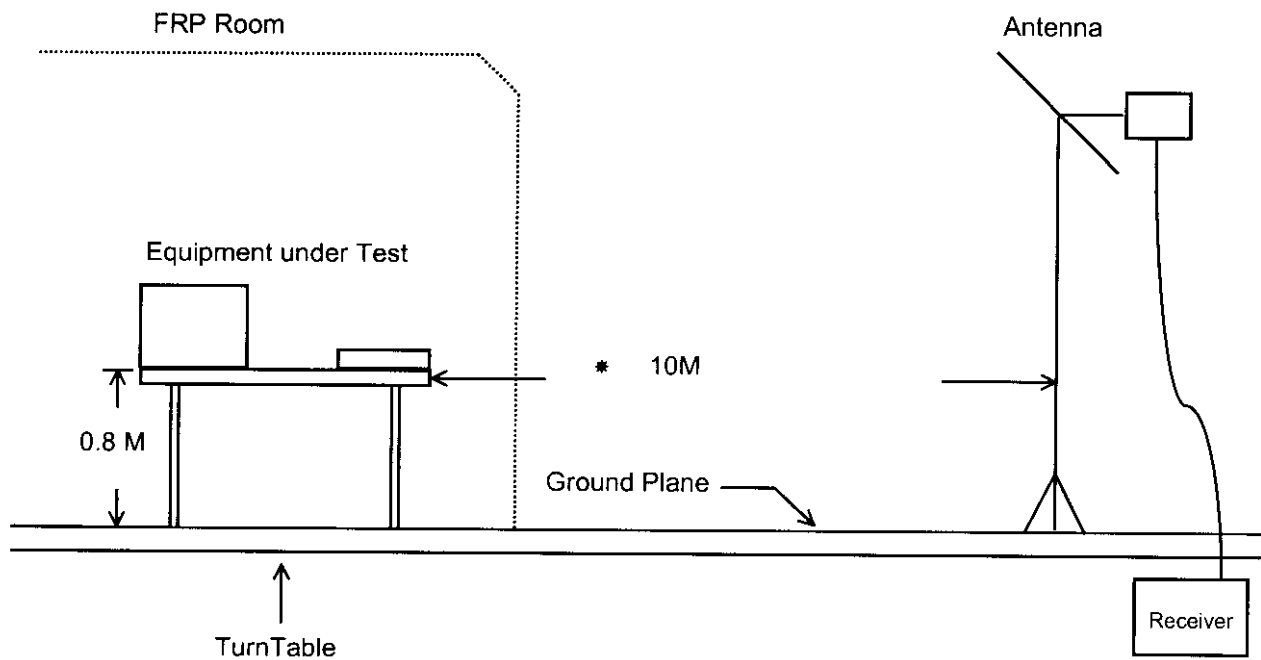

**6.2. TEST PROCEDURES**

- a. The EUT was placed on a rotatable table top 0.8 meter above ground.
- b. The EUT was set 10 meters from the interference receiving antenna which was mounted on the top of a variable height antenna tower.
- c. The table was rotated 360 degrees to determine the position of the highest radiation.
- d. The antenna is a half wave dipole and its height is varied between one meter and four meters above ground to find the maximum value of the field strength both horizontal polarization and vertical polarization of the antenna are set to make the measurement.
- e. For each suspected emission the EUT was arranged to its worst case and then tune the antenna tower ( from 1 M to 4 M ) and turn table ( from 0 degree to 360 degrees ) to find the maximum reading.
- f. Set the test-receiver system to Peak Detect Function and specified bandwidth with Maximum Hold Mode.
- g. If the emission level of the EUT in peak mode was 6 dB lower than the limit specified, then testing will be stopped and peak values of EUT will be reported otherwise the emissions which do not have 6 dB margin will be repeated one by one using the quasi-peak method and reported.


