#### 3. TEST METHODOLOGY

The tests documented in this report were performed in accordance with ANSI C63.4 and FCC CFR 47 2.1046, 2.1047, 2.1049, 2.1051, 2.1053, 2.1055, 2.1057, 15.207, 15.209 and 15.247.

#### 3.1 EUT CONFIGURATION

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner that intends to maximize its emission characteristics in a continuous normal application.

#### 3.2 EUT EXERCISE

The EUT was operated in the engineering mode to fix the TX frequency that was for the purpose of the measurements.

According to its specifications, the EUT must comply with the requirements of the Section 15.207, 15.209 and 15.247 under the FCC Rules Part 15 Subpart C.

#### 3.3 GENERAL TEST PROCEDURES

#### **Conducted Emissions**

The EUT is placed on the turntable, which is 0.8 m above ground plane. According to the requirements in Section 13.1.4.1 of ANSI C63.4 Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30MHz using CISPR Quasi-peak and average detector modes.

#### **Radiated Emissions**

The EUT is placed on a turn table, which is 0.8 m above ground plane. The turntable shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna, which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the maximum emissions, exploratory radiated emission measurements were made according to the requirements in Section 13.1.4.1 of ANSI C63.4.

#### 3.5 DESCRIPTION OF TEST MODES

The EUT (model: TB120) had been tested under operating condition.

Test program used to control the EUT for staying in continuous transmitting mode was programmed.

Software used to control the EUT for staying in continuous transmitting mode was programmed. The worst case data rate is determined as the data rate with highest output power.

After verification, all tests were carried out with the worst case test modes as shown below except radiated spurious emission below 1GHz and power line conducted emissions below 30MHz, which worst case was in normal link mode only.

Channel Low (2402MHz), Mid (2441MHz) and High (2480MHz) with 3Mbps data rate was chosen for full testing.

The field strength of spurious emission was measured in the following position: EUT stand-up position (Z axis), lie-down position (X, Y axis) and laptop mode. The worst emission was found in laptop position and the worst case was recorded.

Conducted emissions are measured with Line Impedance Stabilization Networks and EMI Test Receivers.

Calibrated wideband preamplifiers, coaxial cables, and coaxial attenuators are also used for making measurements.

All receiving equipment conforms to CISPR Publication 16-1, "Radio Interference Measuring Apparatus and Measurement Methods."



whichever is greater. Alternatively, frequency hopping systems operating in the 2400-2483.5
MHz band may have hopping channel carrier frequencies that are separated by 25 kHz or
two-thirds of the 20 dB bandwidth of the hopping channel, whichever is greater, provided the
systems operate with an output power no greater than 125 mW.


#### 7.2 BAND EDGES MEASUREMENT

### **LIMIT**

According to §15.247(d), in any 100 kHz bandwidth outside the frequency bands in which the spread spectrum intentional radiator in operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. In addition, radiated emissions which fall in the restricted bands, as defined in §15.205(a), must also comply with the radiated emission limits specified in 15.209(a) (see Section 15.205(c)).

- 5. Repeat the procedures until all the PEAK and AVERAGE versus POLARIZATION are measured.





Detector mode: Peak Polarity: Vertical




## Detector mode: Average Polarity: Vertical



## Detector mode: Peak Polarity: Horizontal




## Detector mode: Average Polarity: Horizontal





Detector mode: Peak Polarity: Vertical




## Detector mode: Average Polarity: Vertical



## PPSD (CH Low)




## PPSD (CH Mid)


## 7.4 FREQUENCY SEPARATION

According to \$15.247(a)(1), Frequency hopping systems shall have hopping channel carrier frequencies separated by a minimum of 25 kHz or the 20 dB bandwidth of the hopping channel, whichever is greater. Alternatively, frequency hopping systems operating in the 2400-2483.5 MHz band may have hopping channel carrier frequencies that are separated by 25 kHz or two-thirds of the 20 dB bandwidth of the hopping channel, whichever is greater, provided the systems operate with an output power no greater than 125 mW.






## **Test Plot**

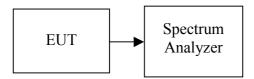
#### 7.7.1 Conducted Measurement

### **LIMIT**

According to §15.247(d), in any 100 kHz bandwidth outside the frequency bands in which the spread spectrum intentional radiator in operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. 



#### **CH Low**






