





here's a few essentials:

about this guide

Press the Left Soft Key to open the Main Menu and select **Options**. Use the Navigation Key **up**, **down**, **left**, or **right** to scroll to an item, then press the Center Key to select the highlighted item. Press the Right Soft Key to select **Back** and move up to the previous level.



This guide shows how to locate a menu eature as follows:

Find it: Press Menu > Messaging > (received call)

- 1 Press the Left Soft Key to open the Main Memu.
- 2 Press the Navigation Key to scroll to Call Center, then press the Center Key to select it.

basics

turn it on & off

Press and hold the Power/End Key of for a few seconds to turn the phone on and off. If prompted, enter your unlock code to turn it on.

activate SIM cards

Your phone supports the Dual SIM cards mode, enabling you to use two SIM cards at the same time without changing them. When two SIM cards are both installed, you can activate one of two or both SIM cards as well as the flight mode.

Find it: Press Menu > Settings > Dual SIM Settings

Note: If only one SIM card is installed, this SIM card would be activated as default

access the main menu

- 1 From the home screen, press the Left Soft Key to open the Main Menu.
- You can press the Right Soft Key to move up the previous level. You also can press the Power/End Key to return to the home screen at anytime.

basics

menu shortcut

You can press the Navigation Key to quickly open an application on your phone. The default setting is:

- Up: write a mesage
- · Down: phonebook
- Left: media player
- Right: tone settings

You also can set your desired function on the dedicated Navigation Key by pressing Menu > Settings > Phone Settings > Dedicated key.

make calls

From the home screen, enter a number and press the Call/Answer Key .

Note: If the Dual SIM Open mode is activated, you must choose which SIM card as voice call.

answer calls

Press the Call/Answer Key when your phone rings or vibrates.

end calls

Press the Power/End Key when your phone rings or vibrates.

redial a number

- 1 From the home screen, press the Call/Answer Key to see a list of All Calls showing recent missed calls, dialled calls and received calls.
- 2 Scroll to the entry you want to call and press the Call/ Answer Key .

Note: If the Dual SIM Open mode is activated, you must choose which SIM card as call history and voice call.

go handsfree

During an active call, press the Center Key to turn the handsfree speaker on. To turn the handsfree speaker off, press the Center Key again. You can also use a wired headset to go handsfree

Note: The use of hadnfree speaker while driving may cause distraction. Discontinue a call if you can't concentrate on driving. Additionally, the use of wireless deivces and their accessories may be prohibited or restricted in certain areas. Always obey the laws and regulations on the use of these products.

speed dial

You can set the speed dial to call the entries in your phonebook.

Find it: Press Menu > Phonebook > Options > Phonebook settings > Speed dial

- 1 Select **Status** to switch it on, then select **Set number**.
- 2 Scroll to the speed dial number (2-9) you want to set, then press **Edit**.

- 3 Scroll to the desired contact and press OK.
- 4 To call speed dial entries, press and hold the single-digit speed dial number for a few seconds.

Note: Speed dial 1 is reserved for calling your voicemail.

in-call menu

During an active call, you can access the in-call menu by pressing **Options**:

- Hold Single Call: put a call on hold.
- End Single Call: end a call.
- New Call: make a new call during an active call.
- Phonebook: shortcut to phonebook menu.
- Messaging: shortcut to messaging menu.
- Sound Recorder: record your conversation during an active call
- **DTMF:** swith DTMF (Dual Tone Multi-Frequency) tone dialing system.

emergency calls

To call an emergency number, enter the emergency number and press the Call/Answer Key .

Your service provider programs one or more emergency phone numbers, (such as 112 or 911), that you can call under any circumstances, even when your phone is locked.

Emergency numbers vary by country. Your phone's pre-programmed emergency number(s) may not work in all locations, and sometimes an emergency call cannot be placed due to network, environmental, or interference issues.

user profiles

Your phone provides 6 different profiles to adapt to different environment conditions. In each profile, you can set the desired ring tones and alert types.

1 Press Menu > User Profiles.

- Meeting: Ring tone is set to be off. Only vibrator is activated. After activating this profile, your phone shows an indicator .
- Outdoor: The Volume of ring tone and key tone is set to maximum. After activating this profile, your phone shows an indicator .
- Headset: After plugging a wired headset into your phone, your phone shows an indicator n.

customize

- **Bluetooth:** You can set the desired ring tone and alert type when using Bluetooth headset.
- 2 Scroll to a profile you want to customize, then press Options > Customize to set the desired ring tones and alert types.
 - Tone Settings: Set the ring tones of incoming call and message respectively for two SIM cards.
 You can also select different types of ring tone for power on/off.
 - Volume: Adjust the volume of ring tone and key tone.
 - Alert Type: Select an alert type (Ring only, Vibrate only, Vibrate and Ring, Vibrate then ring).
 - Ring Type: Select a ring type (Single, Repeat, Ascending).
 - Extra Tone: Change the switch of Warning, Error, Camp on and Connect.
 - Answer Mode: Answer an incoming call by pressing any key or only the Call/Answer Key.

date & time

You can set home city, date, time and format.



text entry

give you comfortable and quick typing

With your phone's QWERTY keypad, you can enter text or numbers and create messages or notes. When you open the text input field, an indicator at the top left of the display shows the text input mode you are currently using.



- You can change the text input mode by pressing Options > Input Method.
 - **abc:** Enter the letter shown on a key (such as **M**).
 - Numeric: Enter the number shown on a key (such as 0).
 - Insert Symbol: Select the symbol in a list.
- 2 Use the following keys to acess functions:
 - To delete letters, press the Back Key C.

text entry

- To edite the subject and content, use the QWERTY keypad to enter text or numbers.

e-mail

take a photo

camcorder

playlists

create a playlist

- 1 Enter a name for the playlist, then press **Options > Done.**

In My Playlists, tap the playlist you want to play, then tap one of the songs.

music player tips

You can use other phone features when playing music. But, using applications like **Games** or **FM radio** turns the media player off.

If you receive a call while playing music, the music pauses automatically. You can answer or reject the call and send the caller to voicemail. Playing will resume when you end the call.

radio

listen to your favorite channels

Plug a wired headset into your phone.

Note: The FM radio works only when a headset is plugged in.

- 2 Press Menu >Multimedia > FM radio.
- 3 Use these keys to control the radio:

radio

- Settings: Change the skin of FM radio, the switch of loudspeaker, record format, audio quality, and record storage.
- · Record: Record your favorite radio programs.
- Appends: Resume the previous recorded file and continue to record at the same file.
- File List: Manage the previous recorded files.

calendar

Find it: Press Menu > Organizer > Calendar

- 1 Press Options to add, delete or view the event. You can set three types of event including Reminder, Meetings, and Course.
- When you highlight an event in the calendar, more details appear at the bottom.

tasks

Find it: Press Menu > Organizer > Tasks

You can press **Add** to add tasks of **Date**, **Call**, and **Anniversary**.

alarms

Find it: Press Menu > Organizer > Alarm

You can set the FM radio as your alarm tone by pressing Edit > Alarm Tone > FM radio.

lock & unlock phone

You can lock your phone to keep others from using it.

Find it: Press Menu > Settings > Security Settings > Phone Lock

- 1 Enter a password to turn this lock on. The Phone Lock is originally set to 1122.
- 2 In Security Setting, you can change the password by pressing Change Password > Phone Password.

lock & unlock keypad

You can lock the keys to prevent any unwanted phone operations.

Find it: Press Menu > Settings > Security Settings > Phone Lock

- Select the amount of time for the phone to be inactive before automatically locking.
- 2 To unlock, press the Left Soft Key and follow the onscreen instructions.

crash recovery

In the unlikely event that your phone stops reponding to taps and key presses, try a quick reset. Remove the back cover and battery, then replace and turn your phone on as usual.

reset

Find it: Press Menu > Settings > Restore Factory Settings

Your phone will be reset to factory settings, and all data on your phone will be deleted.

Legal, Safety & Regulatory

Battery Use & Safety

Important: Handle and store batteries properly to avoid injury or damage. Most battery issues arise from improper handling of batteries, and particularly from the continued use of damaged batteries.

DON'Ts

- Don't disassemble, crush, puncture, shred, or otherwise attempt to change the form of your battery.
 - Don't let the phone or battery come in contact with water. Water can
 get into the phone's circuits, leading to corrosion. If the phone and/or
 battery get wet, have them checked by your carrier or contact Motorola,
 even if they appear to be working properly.
 - Don't allow the battery to touch metal objects. If metal objects, such as

Battery Charging

Notes for charging your phone's battery:

- When charging your battery, keep it near room temperature. Never expose batteries to temperatures below 0°C (32°F) or above 45°C (113°F) when charging.

- New batteries or batteries stored for a long time may take more time to charge.
- Motorola batteries and charging systems have circuitry that protects the battery from damage from overcharging.

This model wireless phone meets the government's requirements for exposure to radio waves.

Your wireless phone is a radio transmitter and receiver. It is designed and manufactured not to exceed limits for exposure to radio frequency (RF) energy set by the Federal Communications Commission (FCC) of the U.S. Government and by the Canadian regulatory authorities. These limits are part of comprehensive guidelines and establish permitted levels of RF energy for the general population. The guidelines are based on standards that were developed by independent scientific organizations through periodic and thorough evaluation of scientific studies. The exposure standard for wherees indone prince enjugity a unit of measurement known as the Specific Absorption Rate, or SAR. The SAR limit set by the FCC and by the Canadian regulatory authorities is 1.6 Wkg. Tests for SAR are conducted using standard operating positions accepted by the FCC and by Industry Canada with the phone transmitting at its highest certified power level in all tested frequency bands. Although the SAR is determined at the highest certified power level, the actual SAR level of the phone while operating can be well below the maximum value. This is because the phone is designed to operate at multiple power levels so as to use only the power required to reach the

network. In general, the closer you are to a wireless base station, the lower the power output.

Before a phone model is available for sale to the public in the U.S. and Canada, it must be tested and certified to the FCC and Industry Canada that it does not exceed the limit established by each government for safe exposure. The tests are performed in positions and locations (e.g., at the ear and worn on the body) reported to the FCC and available for review by Industry Canada. Privacy & Data Security

Motorola understands that privacy and data security are important to everyone. Because some features of your mobile device may affect your privacy or data security, please follow these recommendations to enhance protection of your information:

- Monitor access—Keep your mobile device with you and do not leave it
 where others may have unmonitored access. Lock your device's keypad
 where this feature is available.
- Keep software up to date—If Motorola or a software/application vendor releases a patch or software fix for your mobile device that updates the device's security, install it as soon as possible.
- Secure personal information—Your mobile device can store personal
 information in various locations including your SIM card, memory card,
 and phone memory. Be sure to remove or clear all personal information
 before you recycle, return, or give away your device. You can also backup
 your personal data to transfer to a new device.

- Online accounts—Some mobile devices provide a Motorola online account (such as MOTOBLUR). Go to your account for information on how to manage the account, and how to use security features such as remote wipe and device location (where available).
- Location-based information—Location-based information includes
 information that can be used to determine the approximate location of a
 mobile device. Mobile phones which are connected to a wireless network
 transmit location-based information. Devices enabled with GPS or AGPS
 technology also transmit location-based information. Additionally, if you
 use applications that require location-based information (e.g. driving
 directions), such applications transmit location-based information. This
 location-based information may be shared with third parties, including
 your wireless service provider, applications providers, Motorola, and
 other third parties providing services.
- Other information your device may transmit—Your device may also transmit testing and other diagnostic (including location-based) information, and other non-personal information to Motorola or other third-party servers. This information is used to help improve products and services offered by Motorola.

Smart Practices While Driving

Drive Safe, Call Smart

Check the laws and regulations on the use of mobile devices and their accessories in the areas where you drive. Always obey them. The use of these devices may be prohibited or restricted in certain areas — for example, handsfree use only. Go to www.motorola.com/callsmart (in English only) for more information.

Your mobile device lets you communicate by voice and data—almost anywhere, anytime, wherever wireless service is available and safe conditions allow. When

driving a car, driving is your first responsibility. If you choose to use your mobile device while driving remember the following tips:

- Get to know your Motorola mobile device and its features such as speed dial and redial. If available, these features help you to place your call without taking your attention off the road.
- When available, use a handsfree device. If possible, add an additional layer of convenience to your mobile device with one of the many Motorola Original handsfree accessories available today.



- Position your mobile device within easy reach. Be able to access your mobile device without removing your eyes from the road. If you receive an incoming call at an inconvenient time, if possible, let your voicemail answer it for you.
- Let the person you are speaking with know you are driving; if necessary, suspend the call in heavy traffic or hazardous weather conditions. Rain, sleet, snow, ice, and even heavy traffic can be hazardous.
- Do not take notes or look up phone numbers while driving. Jotting down a "to do" list or going through your address book takes attention away from your primary responsibility—driving safely.
- Dial sensibly and assess the traffic; if possible, place calls when your
 car is not moving or before pulling into traffic. If you must make a call
 while moving, dial only a few numbers, check the road and your mirrors,
 then continue.
- Do not engage in stressful or emotional conversations that may be distracting. Make people you are talking with aware you are driving and suspend conversations that can divert your attention away from the road.
- Use your mobile device to call for help. Dial 911 or other local emergency number in the case of fire, traffic accident, or medical emergencies (wherever wireless phone service is available).
- Use your mobile device to help others in emergencies. If you see an
 auto accident, crime in progress, or other serious emergency where lives
 are in danger, call 911 or other local emergency number (wherever

- wireless phone service is available), as you would want others to do for you.
- Call roadside assistance or a special non-emergency wireless assistance number when necessary. If you see a broken-down vehicle posing no serious hazard, a broken traffic signal, a minor traffic accident where no one appears injured, or a vehicle you know to be stolen, call roadside assistance or other special non-emergency wireless number (wherever wireless phone service is available).
