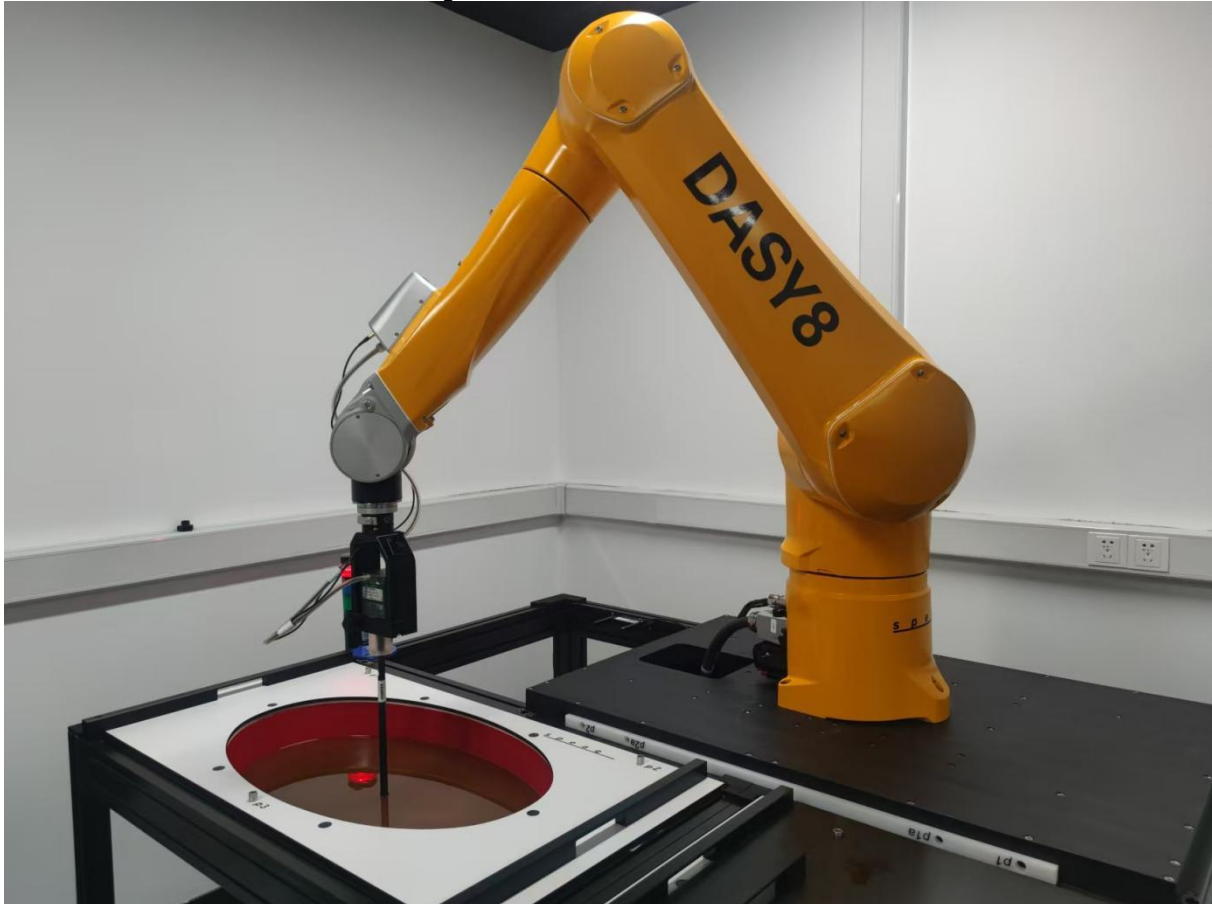

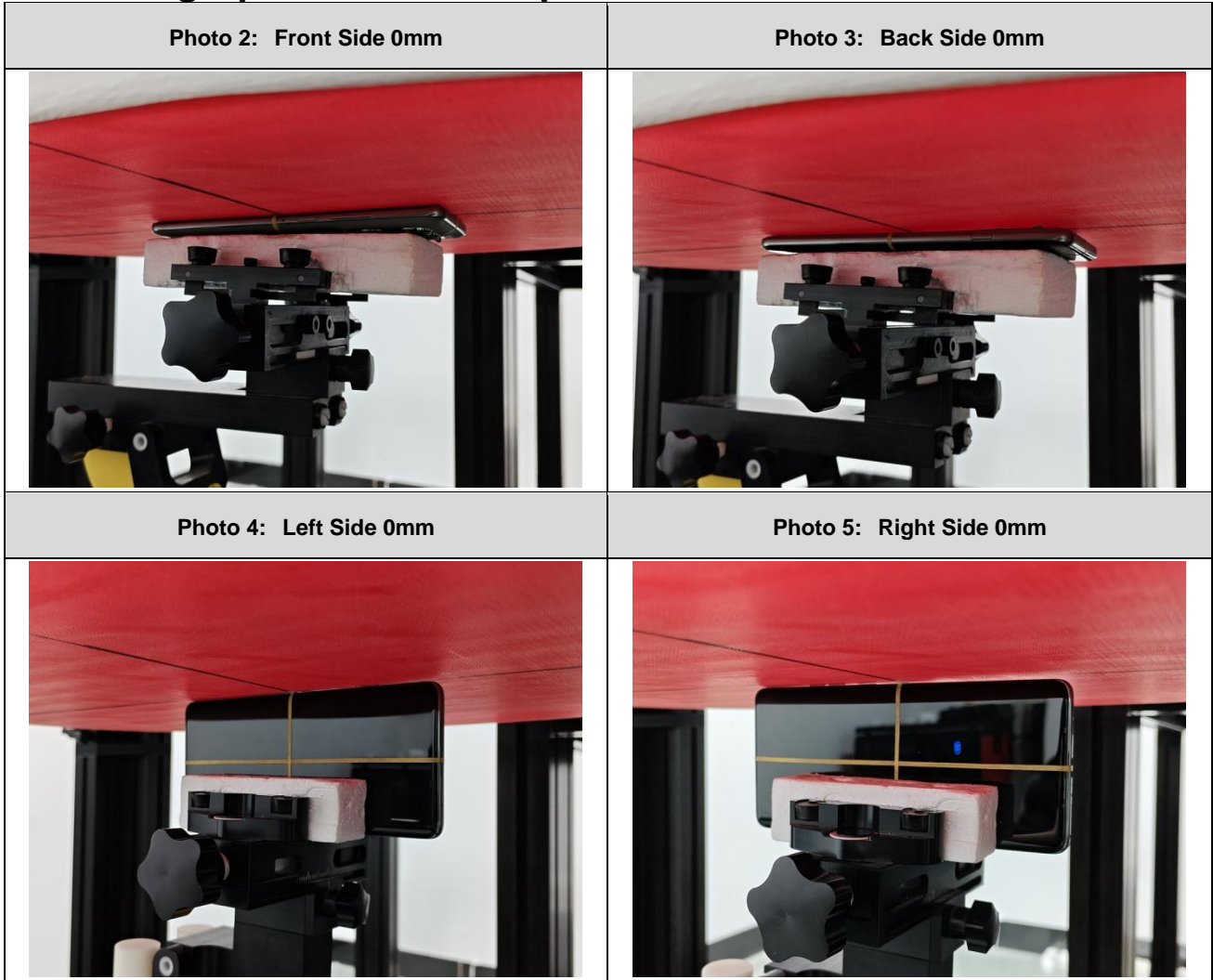

Photo 7: Bottom Side 0mm

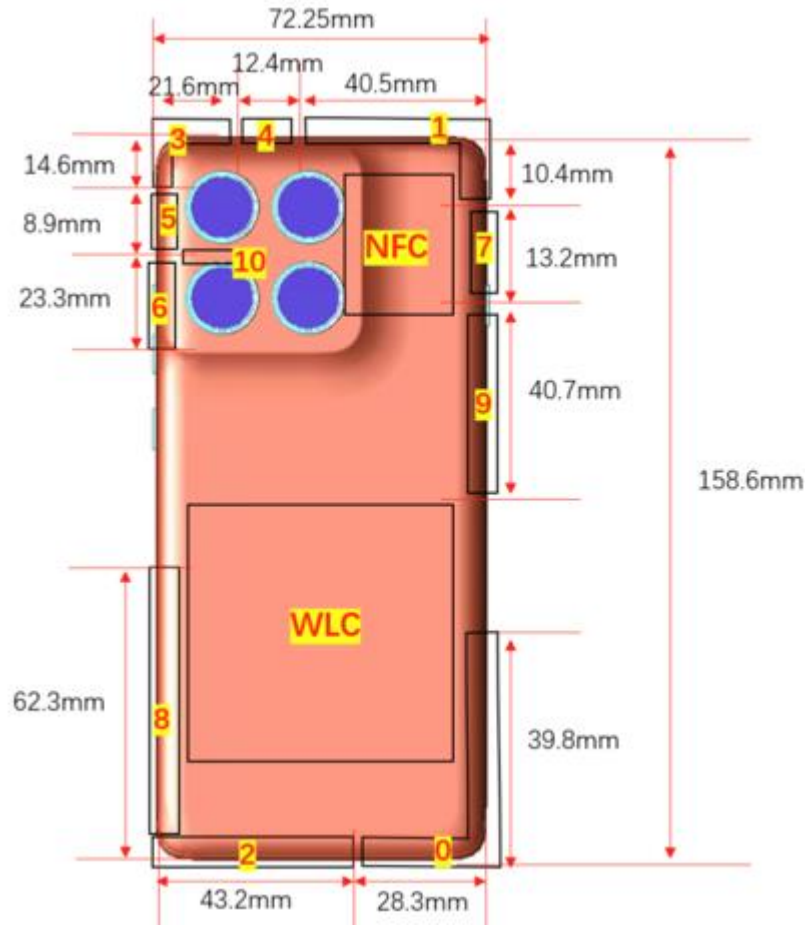

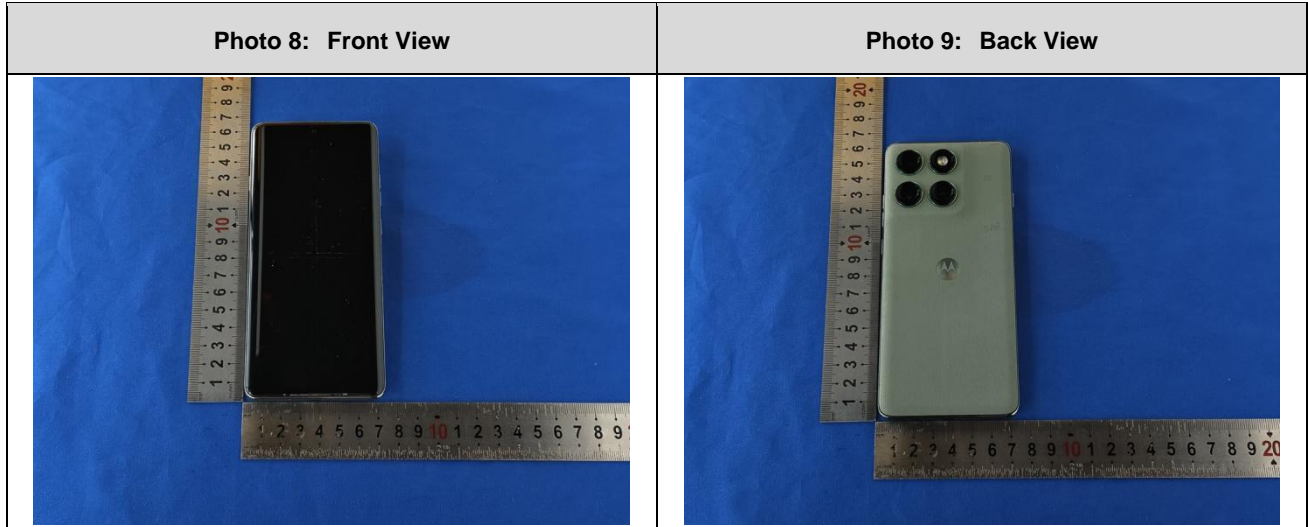
