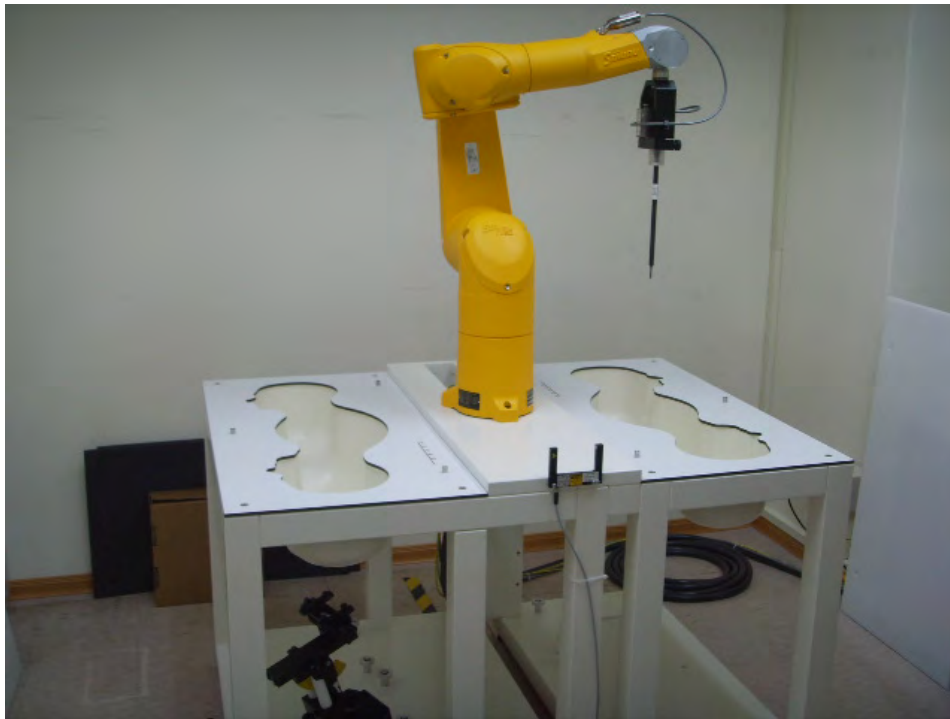

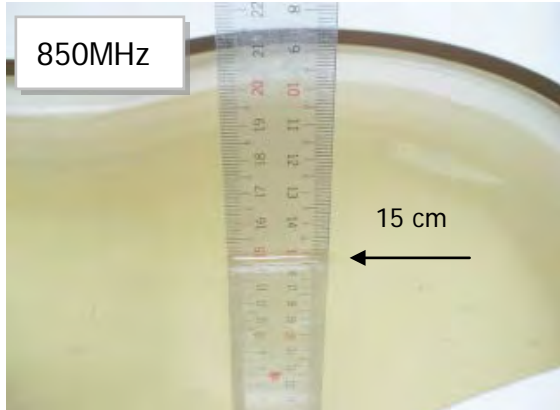
**Fig.1 Photograph of the SAR Measurement System**

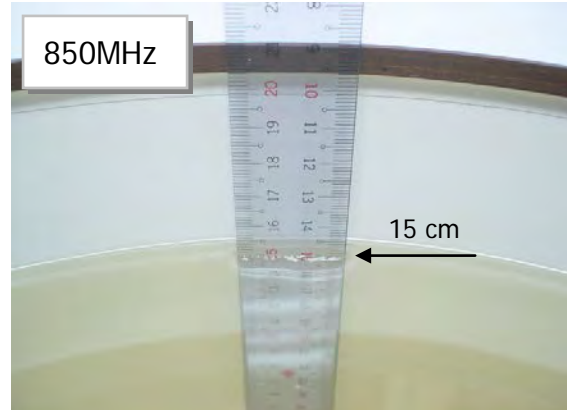

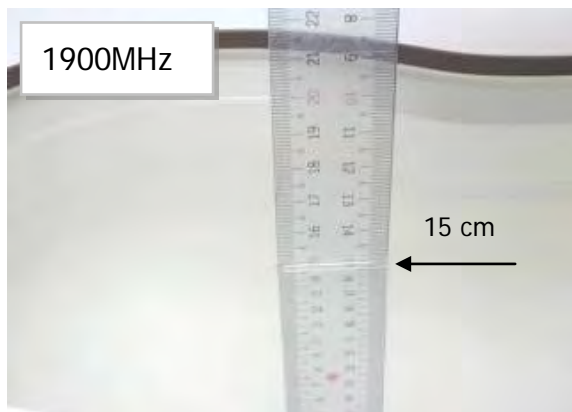
**Photograph of the Tissue Simulant Fluid Liquid Depth 15cm (Head & Body)**



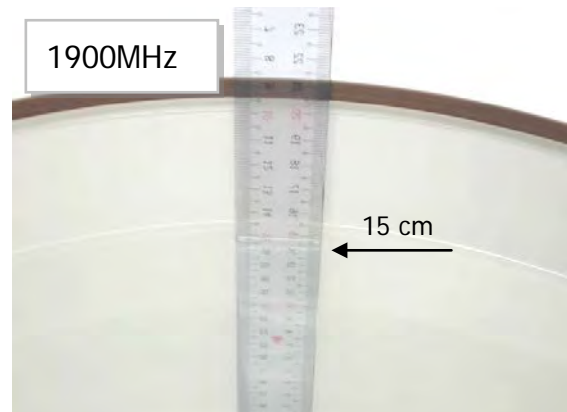

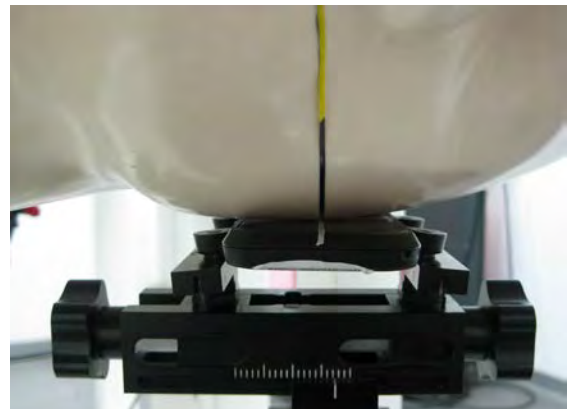
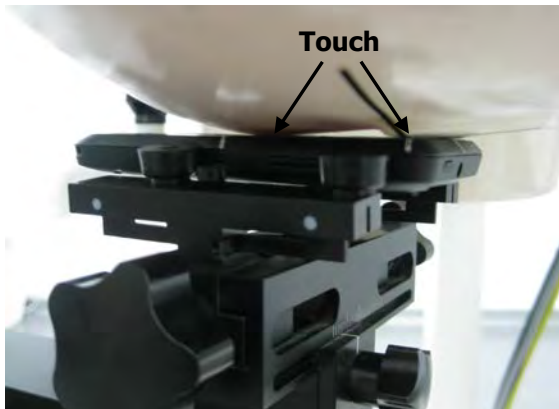

**Fig.4 Right Head Section / Ear-Tilt Position(15°)**

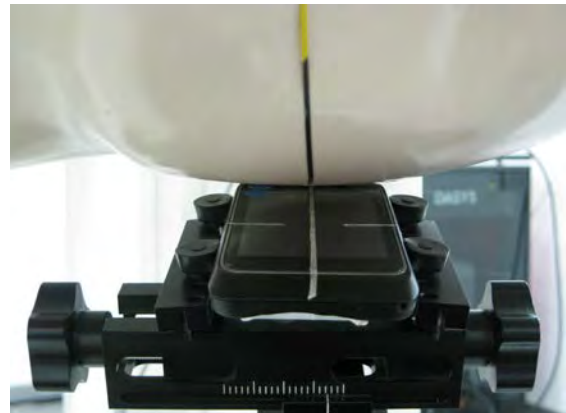


**Fig.5 Left Head Section / Cheek-Touch Position**

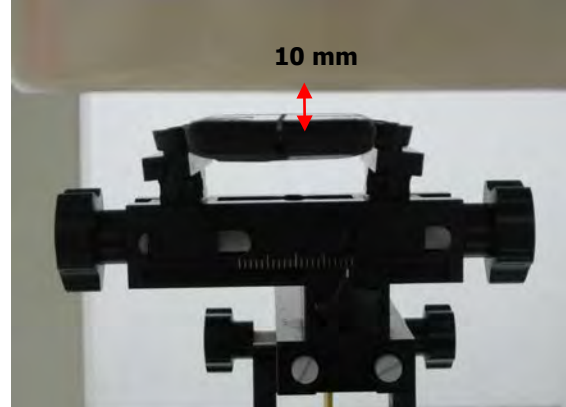

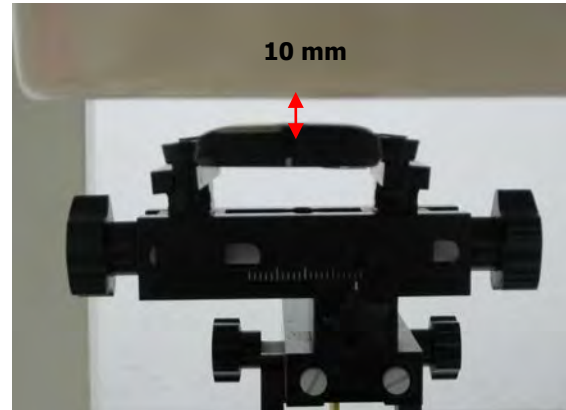

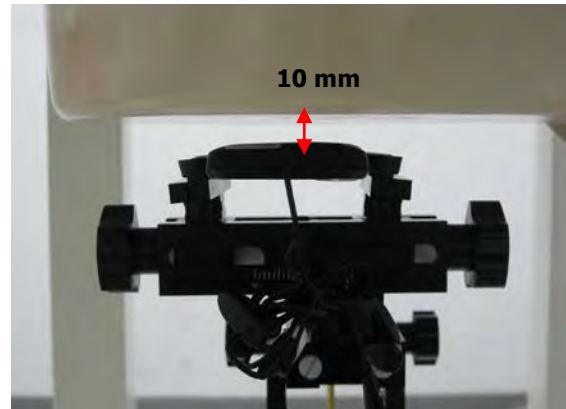
**Hotspotmode - distance between flat phantom and mobile phone is 10 mm**

**Fig.9 EUT back to flat phantom with headset**

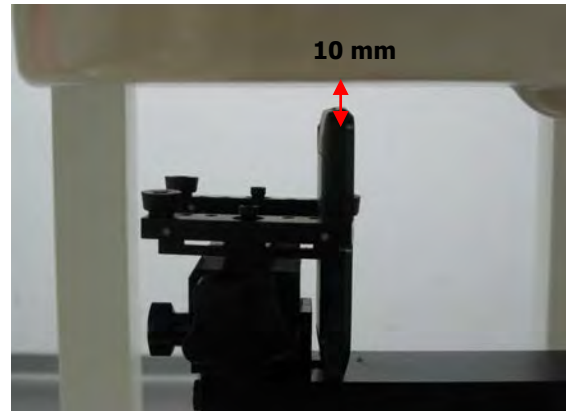

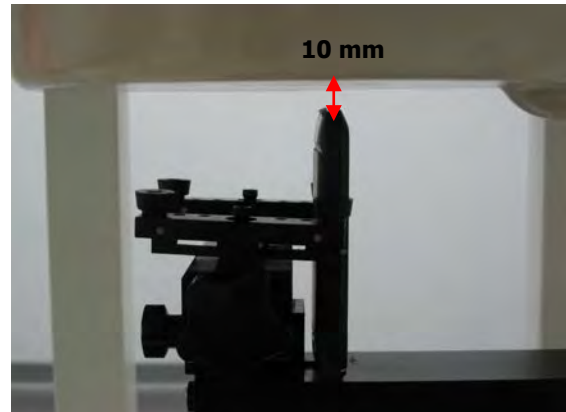

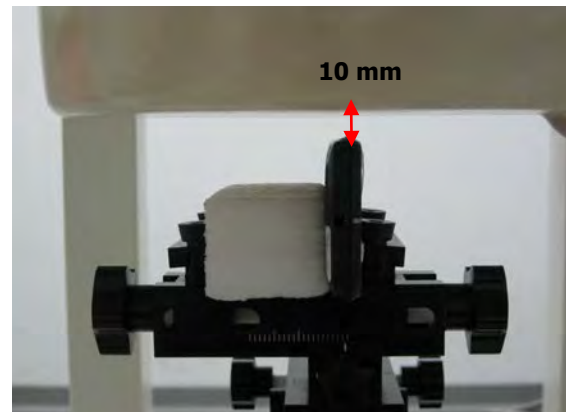
**Fig.10 EUT Top to flat phantom**



**Fig.11 EUT Bottom to flat phantom**



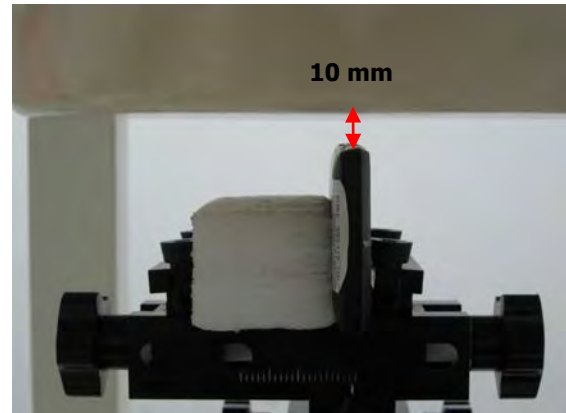
**Fig.12 EUT Right to flat phantom**

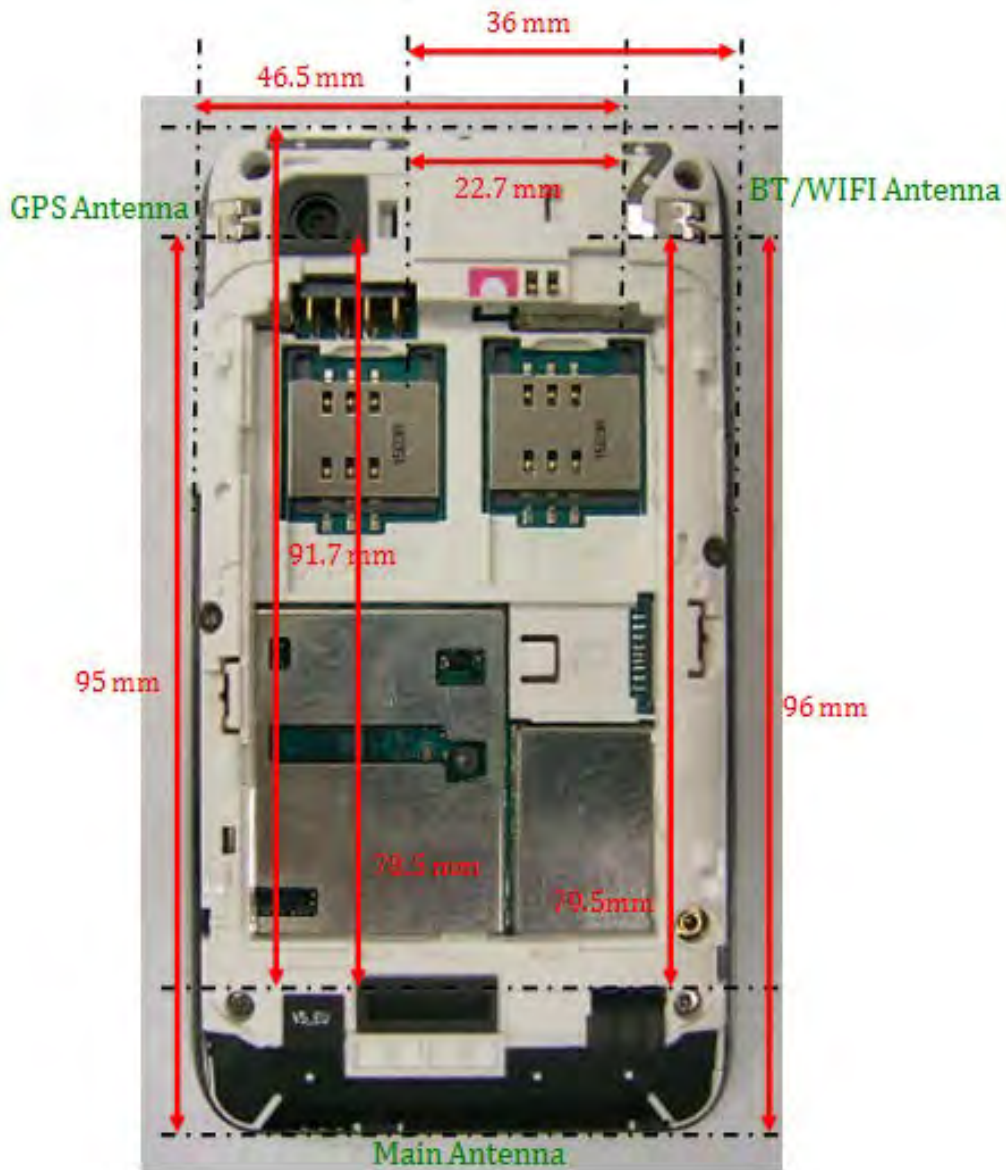
