

## **Exhibit 1: Identification Label -- Pursuant to 47 CFR 2.925 and 2.1033(c)(11); and RSP100, Section 5; RSS Gen, Section 5.2; and Notice 2014-DRS1003.**

### **1.1 Electronic Labeling**

This device will employ electronic labeling for all required FCC and Industry Canada regulatory marks, consistent with the KDB Publication KDB784748 D02 and Notice 2014-DRS1003.

### **1.2 Accessing Electronic Label Information**

End users can access electronic labeling of regulatory information using the procedure described below. These instructions are also presented in the User Manual provided with this device (see Exhibit 8):

1. Enter the **Settings** Menu of the device.
2. Scroll to the bottom of the available options, and select the **About Phone** option.
3. Select the **Regulatory Information** option, and scroll as needed to access the desired information.
4. When finished, press the **Home Key** to return to the device's home screen.

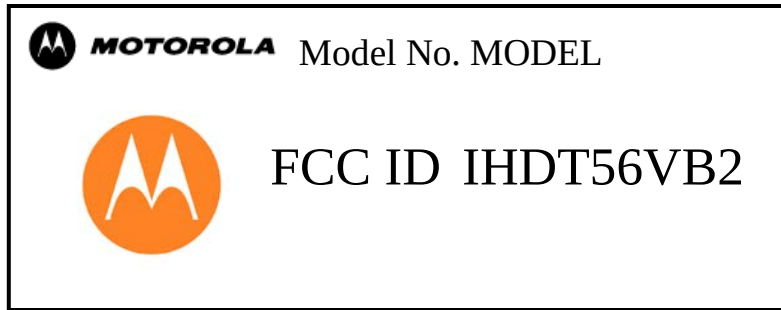
