1.4.1 Introduction Section

This application re-uses data collected on a similar device. The subject device of this application (Model 7975, FCC ID IHDT56VD1) is electrically identical to the reference device (Model 7383, FCC ID IHDT56VD4) for the portions of the circuitry corresponding to the data being re-used, as treated by KDB Publication 178919 D01.
