The subject device of this application (Model: 9370, 9842, FCC ID: IHDT56VE2) is electrically identical to the reference device (Model: 9836, FCC ID: IHDT56VE1) for the portions of the circuitry corresponding to the data being re-used, as treated by KDB Publication 178919 D01.
