The subject device of this application (Model: 9843, FCC ID: IHDT56VE5) is electrically identical to the reference device (Model: 9840, 9841, FCC ID: IHDT56VE4) for the portions of the circuitry corresponding to the data being re-used, as treated by KDB Publication 178919 D01.
