The subject device of this application (Model: 10713, FCC ID: IHDT56WC5) is electrically identical to the reference device (Model: 10714, FCC ID: IHDT56WC6) for the portions of the circuitry corresponding to the data being re-used, as treated by KDB Publication 178919 D01.
