The subject device of this application (Model: 10648, FCC ID: IHDT56WF3) is electrically identical to the reference device (Model: 10718, 10719, FCC ID: IHDT56WF1) for the portions of the circuitry corresponding to the data being re-used, as treated by KDB Publication 178919 D01.
