This application re-uses data collected on a similar device. The subject device of this application (Model: 10812, FCC ID: IHDT56WJ3) is electrically identical to the reference device (Model: 10807, 11154, FCC ID: IHDT56WJ4) for the portions of the circuitry corresponding to the data being re-used, as treated by KDB Publication 178919 D01.

### 1.6.3 Spot Check Verification Data Section
