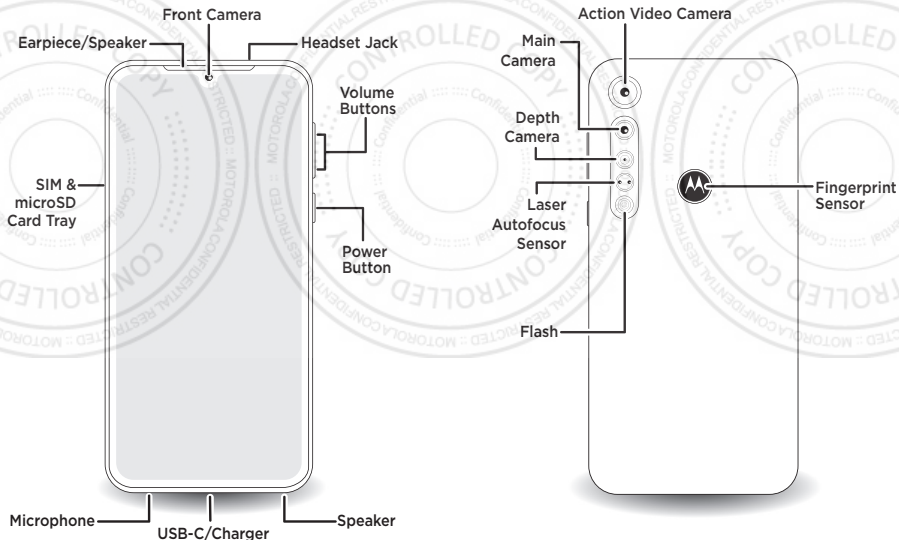

Put in the cards

Depending on the model, your phone might support using two SIM cards.

Insert the SIM card(s) with the gold contacts down. Insert an optional microSD card (sold separately).
