



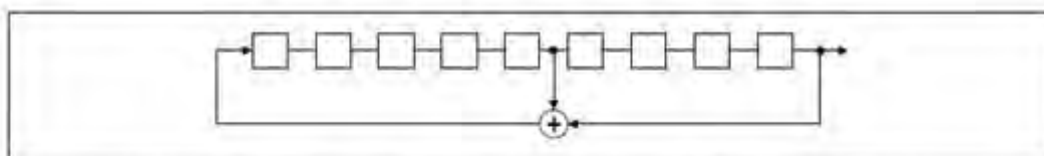

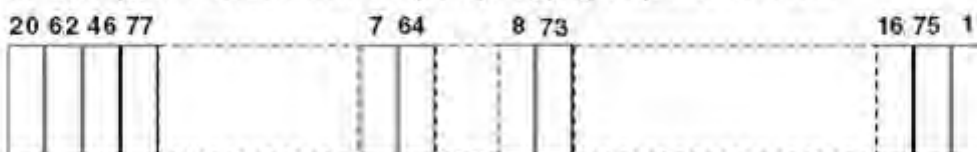
Linear Feedback Shift Register for Generation of the PRBS sequence

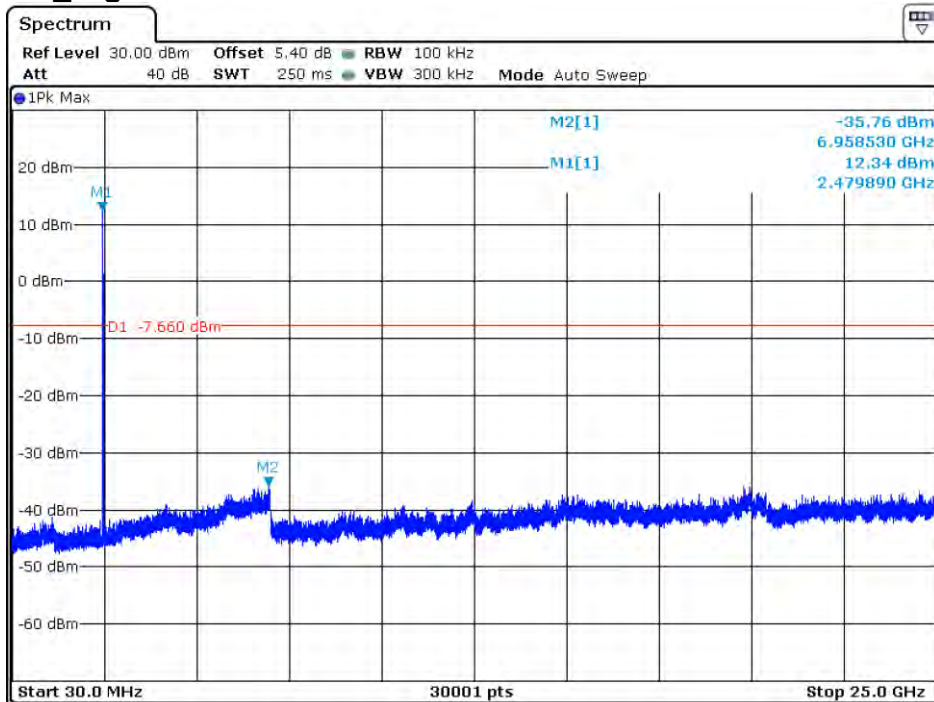


### 4.10.1.2 GFSK\_Middle Channel

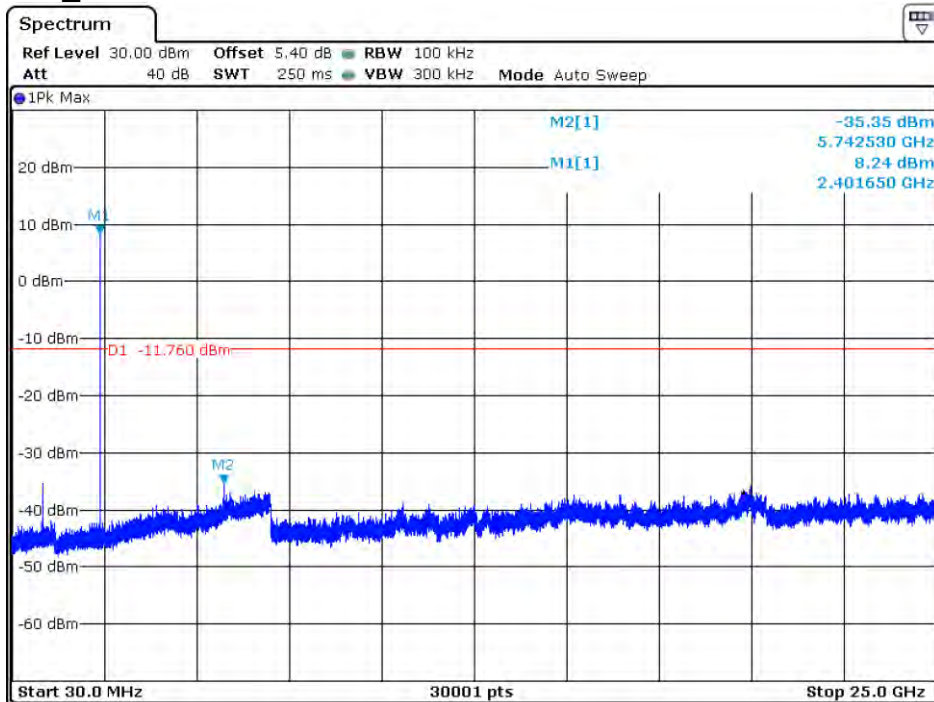


**4.10.1.6  $\pi/4$ DQPSK\_Highest Channel**

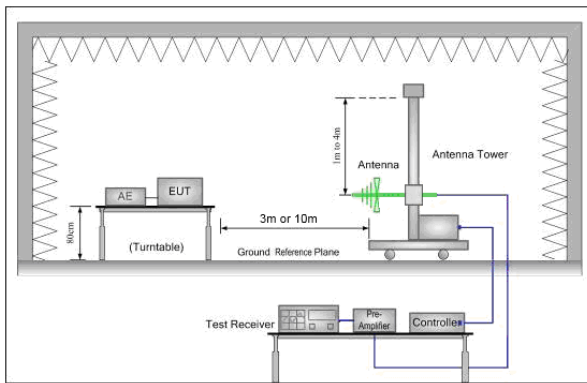


Figure 1. 30MHz to 1GHz

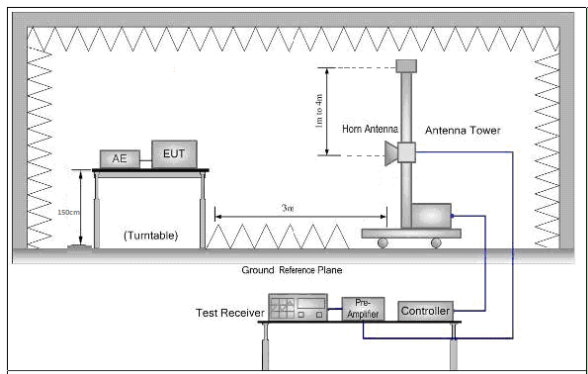


Figure 2. Above 1 GHz
