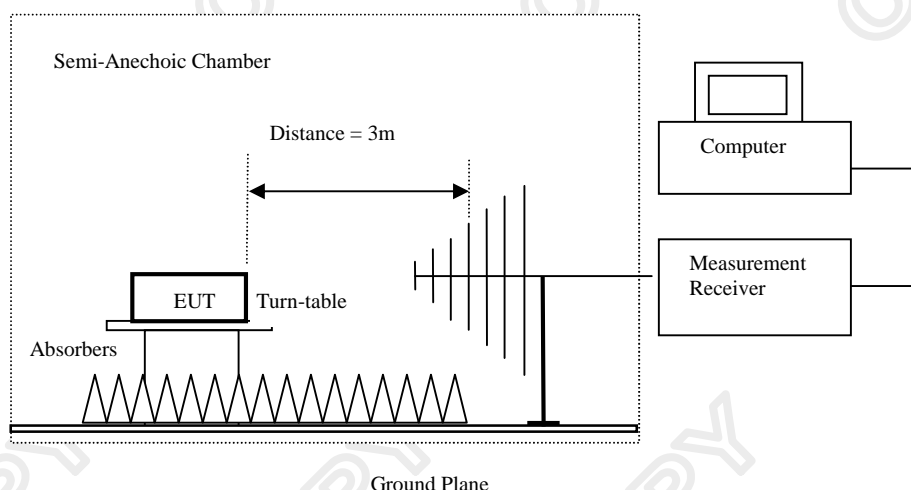

#### **Test Method:**

The sample was placed 0.8m above the ground plane on a standard radiated emission test site. Measurements in both horizontal and vertical polarities were performed. During the test, each emission was maximized by: having the EUT continuously working, investigated all operating modes, rotated about all 3 axis (X, Y & Z) and considered typical configuration to obtain worst position, manipulating interconnecting cables, rotating turntable, varying antenna height from 1m to 4m in both horizontal and vertical polarizations. In the frequency range of 9kHz to 30MHz, The center of the loop antenna shall be 1 meter above the ground and rotated loop axis for maximum reading. The emissions worst-case are shown in Test Results of the following pages.

\*: Semi-anechoic chamber located on the G/F of The Hong Kong Standards and Testing Centre Ltd. with a metal ground plane filed with the FCC pursuant to section 2.948 of the FCC rules, with Registration Number: 607756.

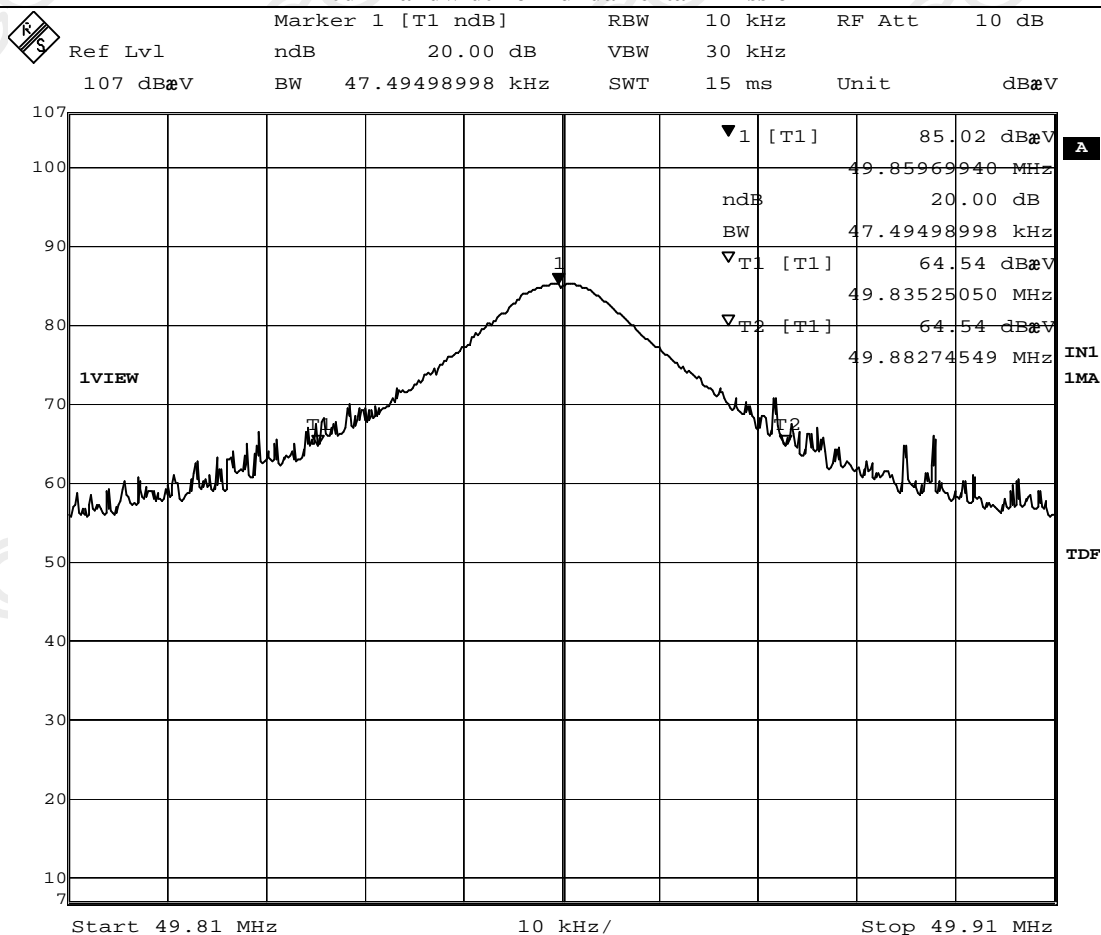

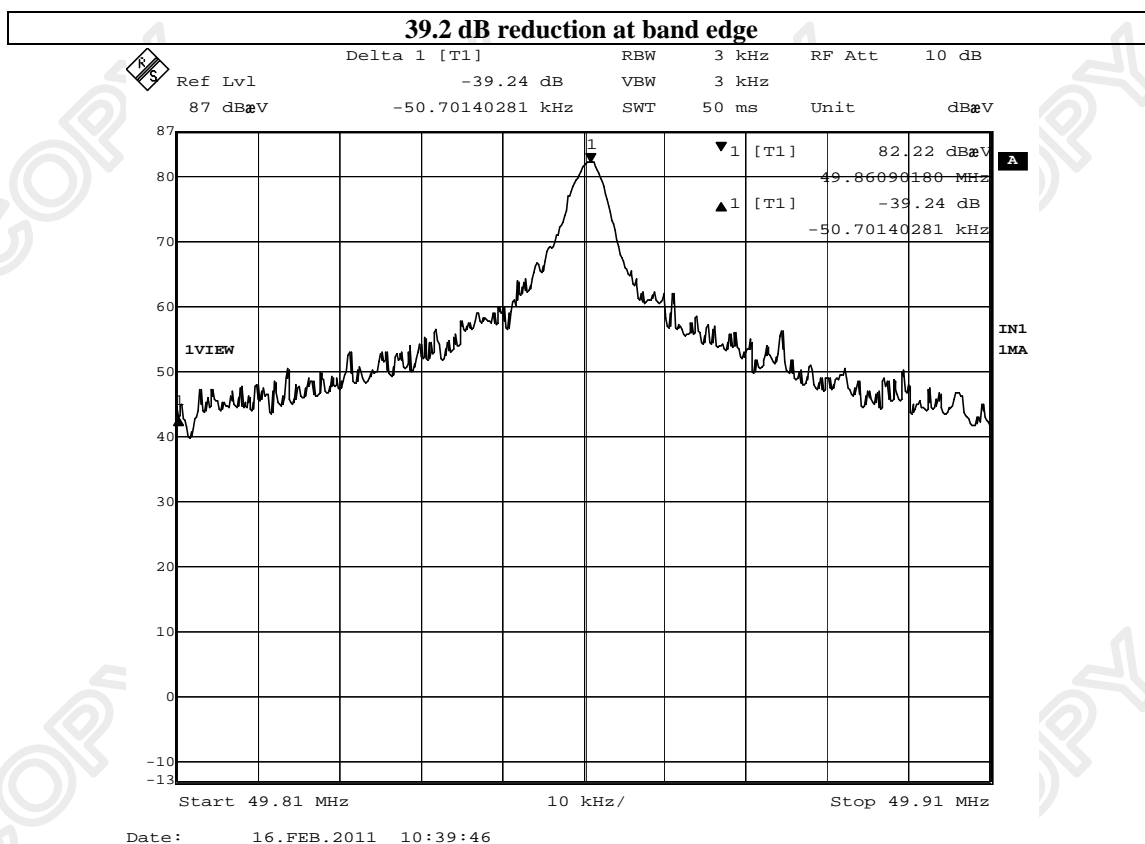

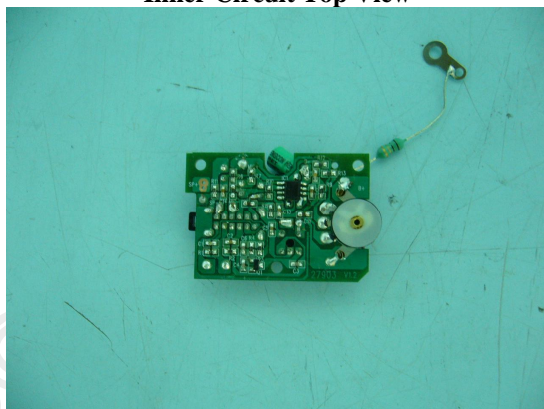
**Front View of the product**



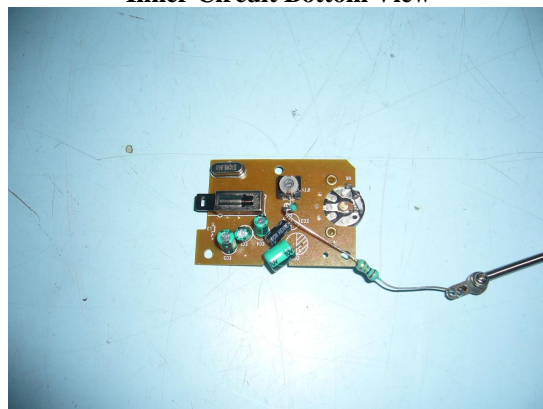
**Rear View of the product**
