EXHIBIT: COVER LETTER

WE WISH TO OBTAIN A GRANT OF CERTIFICATION FOR OUR MICROWAVE OVENS, 0.7 CU FT, 800W RATED OUTPUT. THESE OVENS ARE AN INCREASED POWER VERSION OF OUR 700W RATED UNITS UNDER FCC ID JHU7557, GRANTED MAY 7, 1998.

THE ONLY CHANGE WAS THE HIGH VOLTAGE TRANSFORMER AND CAPACITOR. THE MAGNETRON IS THE SAME, AS IS THE OTHER ELECTRICAL AND MECHANICAL CONSTRUCTION.

WE CONFIRM THAT THE TEST REPORT SUBMITTED WITH THIS APPLICATION IS APPLICABLE TO ANY MODEL NUMBER MICROWAVE OVEN BEARING THE SUBJECT FCC ID: JHU7558Z.

WHEN COMPLETING THE 731, I DID NOT INCLUDE THE TOSHIBA MAGNETRON EMISSION DESIGNATOR AS "2M231H(IF)-K". AND, I ENTERED THE FREQUENCY TOLERANCE AS "2.04%" AS THE COMPUTER WOULD NOT LET ME ENTER "+/- 50 MHZ" AS IN THE PAST. I TRIED TO CORRECT THE 731 AFTER ENTRY, BUT COULD NOT.

AS IN THE PAST WE ARE EXHIBITING THE OWNER'S MANUAL PAGES THAT WERE NOT REQUESTED FOR THIS ELECTRONIC APPLICATION.

PLEASE NOTE THAT THIS IS OUR FIRST ELECTRONIC FILING. WE HAVE BEEN SUBMITTING PAPER 731'S FOR MORE THAN 15 YEARS UNDER BOTH THE "JHU" AND "D3E" PREFIXES. THE UNDERSIGNED IS QUITE UNCOMFORTABLE WITH THIS NEW PROCEDURE DUE TO LACK OF COMPUTER SKILLS. SURELY THE NEXT 731 SUBMISSION WILL BE EASIER, AND WITH LESS HESITATION. WE ASK YOU PLEASE BEAR WITH US AND REQUEST ANY ADDITIONAL OR CORRECTED INFORMATION RATHER THAN DISMISS THE APPLICATION. WE WILL IMMEDIATELY REPLY TO YOUR REQUEST. AS WE ARE PLANNING PRODUCTION LATE MAY, 2000 YOU EFFORTS ARE GREATLY APPRECIATED. WE THANK YOU IN ADVANCE FOR YOUR COOPERATION.
