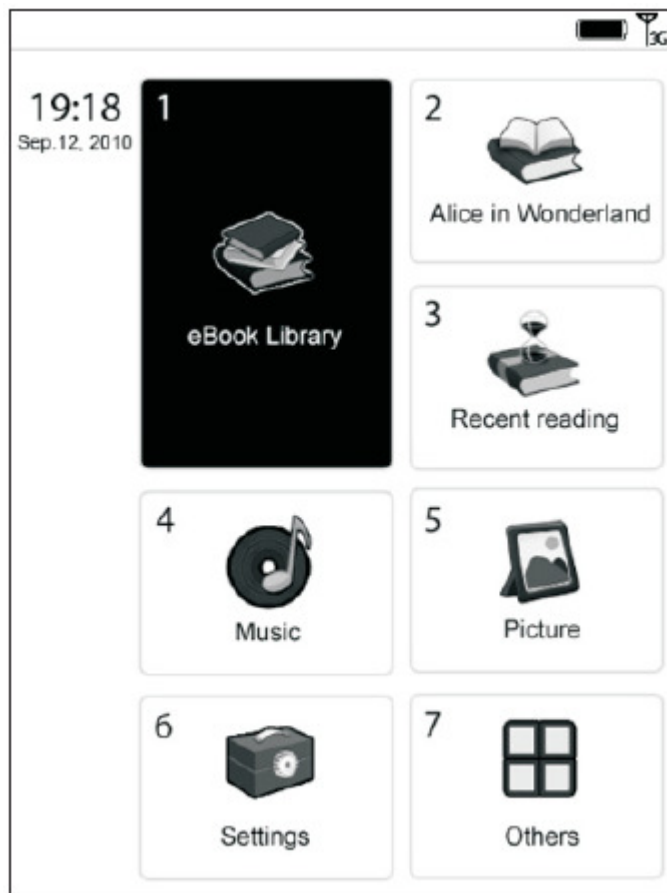
A. General

1. User interface (for WiFi version)



- Top side (from left to right): MicroSD socket (under cover), *Power* key
 - Front side: LCD; *Zoom* key (#11); *Page-up/Page-down* keys (#3); Dual-color LED (#13); *Number* keys (#4); *Directional* keys (#6); Optical finger navigation/OFN and *OK* key (#6); *Menu* key, *Home* key, *Return* key (#11)
 - Right side: *WiFi* key (#5)
 - Back side: *Reset* key
 - Bottom: Mini-B connector; Phone jack
 - Gravity sensor to change the display in Portrait and Landscape modes.
2. User interface of non-WiFi version is same as that of WiFi version except there is no *WiFi* key on the right side.

B. Basic Operation



1. Charging. With the USB cable included, connect the unit with AC/DC adaptor or computer's USB port. When charging, red LED will turn on. When the unit is full-charged, red LED will turn off. Typical charging time is 3 hours
2. Turn on the unit. Press the *Power* key under boot up screen is shown.
3. Turn off the unit. Press the *Power* key for around 4 seconds
4. Enter suspend mode. When the unit is on, press *Power* key once to enter suspend mode.
5. Key operation. To scroll, use OFN or *Directional* key. To select, press *OK* key once (i.e. press the OFN once). To escape, press *Return* key once.
6. Book reading. In Menu page, select "eBook Library". Scroll and select desired ebook you want to read.
7. Music playing. In Menu page, select "Music" and play the music. Scroll and select desired music you want to play.
8. Picture viewing. In Menu page, select "Picture" and select the picture shows in thumbnail. Scroll and select desired picture you want to watch
