This application for certification is being made under CFR47 2.933 (b). Except for the FCC ID and product labels, this device is unchanged from the Original Equipment Manufacturers device. As such, only the information prescribed in 2.933 is provided. Pursuant to 2.933 (b), the following information is given hrewith and constitutes a formal submittal and application for a Grant of Equipment Authorization pursuant to Part 15 Subpart C of FCC Rules (CFR 47) regarding intentional radiators.

2.933 (b) (1). The original identification used on the equipment prior to the change in identification is: ***Phillips Bluetooth Compact Flash Card, Model Bluetooth Wireless CF Card, FCC ID number PUBWCM0003. The New FCC ID number is to be K7SF8T020. See attached recognition and approval from Phillips – Exhibit 3.***

2.933 (b) (2). The date of the original grant of the equipment authorization was:

2.933 (b) (3). How the equipment bearing the modified identification differs from the original equipment. ***The equipment for which certification is being applied is identical to the original device except for the FCC ID and product label. The Belkin FCC ID label and the Belkin product label for the product are shown Exhibit 1.***

2.933 (b) (4). Whether the original test results continue to be representative of and applicable to the equipment bearing the changed identification. ***Since the device is identical to the original in every aspect excluding product and FCC ID labels, the original test report is representative of this application and need not be provided for this application.***

2.933 (b) (5). The photographs required by §2.1033(b)(7) or §2.1033(c)(12) showing the exterior appearance of the equipment, including the operating controls available to the user and the identification label. Photographs of the construction, the component placement on the chassis, and the chassis assembly are not required to be submitted unless specifically requested by the Commission. ***Since the device is identical in construction, component placement photographs are not needed with this application. The Belkin FCC ID label and the Belkin product label are shown Exhibit 2.***
