TEST PROCEDURE

GENERAL: This report shall NOT be reproduced except in full without the written approval of TIMCO ENGINEERING, INC.

RADIATION INTERFERENCE: The test procedure used was ANSI STANDARD C63.4-1992 using a HEWLETT PACKARD spectrum analyzer with a preselector. The bandwidth of the spectrum analyzer was 100 kHz with an appropriate sweep speed. The analyzer was calibrated in dB above a microvolt at the output of the antenna. The resolution bandwidth was $100 \, \text{KHz}$ and the video bandwidth was $300 \, \text{KHz}$. The ambient temperature of the UUT was $50 \, ^{\circ}\text{F}$ with a humidity of $23 \, ^{\circ}\text{C}$.

FORMULA OF CONVERSION FACTORS: The Field Strength at 3m was established by adding the meter reading of the spectrum analyzer (which is set to read in units of dBuV) to the antenna correction factor supplied by the antenna manufacturer. The antenna correction factors are stated in terms of dB. The gain of the Preselector was accounted for in the Spectrum Analyzer Meter Reading.

Example:

Freq (MHz) METER READING + ACF = FS 33 20 dBuV + 10.36 dB = 30.36 dBuV/m @ 3m

ANSI STANDARD C63.4-1992 10.1.7 MEASUREMENT PROCEDURES: The UUT was placed on a table 80 cm high and with dimensions of 1m by 1.5m. The UUT was placed in the center of the table. The table used for radiated measurements is capable of continuous rotation. The spectrum was scanned from 30 MHz to 10th harmonic of the fundamental.

Peak readings were taken in three (3) orthogonal planes and the highest readings were converted to average readings based on the duration of "ON" time.

When an emission was found, the table was rotated to produce the maximum signal strength. At this point, the antenna was raised and lowered from 1m to 4m. The antenna was placed in both the horizontal and vertical planes.

Measurements were made by TIMCO ENGINEERING INC. at the registered open field test site located at 849 N.W. State Road 45, Newberry, Fl 32669.

CALCULATION OF DUTY CYCLE:

The period of the pulse train is determined by observing it on an oscilloscope or a spectrum analyzer with zero(0) frequency span. A plot is then made of the pulse train with a sweep time of 100milliseconds. This sweep determines the duration of the pulse train, which in this case is milliseconds. This sweep allows the determination of the number of and type of pulses, i.e. long & short. Plots are then made showing the duration of each type of pulse and its duration. From the 100millisecond Plot the number of a given type of pulse is then multiplied by the duration of that type pulse. This allows the calculation of the amount of time the UUT is on within 100milliseconds. If the pulse train is longer than 100milliseconds then this number is multiplied by 100 to determine the percentage ON TIME. the pulse train is less than 100milliseconds the total on-time is divided by the length of the pulse train and then multiplied by 100 to determine the percentage ON TIME. In this case there were 32 short pulses .120 milliseconds long and 46 long pulses .280 milliseconds long for a total of 16.72 milliseconds within either the 100milliseconds or the pulse train. The duty cycle correction factor is determined by taking the on-time and dividing it by the pulse train duration. In this case the percentage ON time was 18.97 percent over an 88.1 millisecond time period.



DUTY CYCLE PLOT - PULSED EMISSIONS



DUTY CYCLE PLOT - COMPLETE PULSE TRAIN



DUTY CYCLE PLOT - LONG PULSES






