1. The modular transmitter must have its own RF shielding.	Not complied, but subject to limited modular approval. Transmitter see the test report STE120926331.
2. The modular transmitter must have buffered modulation/data inputs (if such inputs are provided) to ensure that the module will comply with Part 15 requirements under conditions of excessive data rates or over-modulation.	The modular have buffered modulation/data inputs.(BC6145)
3. The modular transmitter must have its own power supply regulation.	The modular transmitter have its own power supply regulation.(DC 3.7V, BC6145 internal LDO regulator)
4. The modular transmitter must comply with the antenna requirements of Section 15.203 and 15.204(c).
