


Picture showing the dimension of FCC ID and Giteki symbol (this is only an EXAMPLE)



### 2.4 US labelling requirements to prescription hearing aids 21 CFR 801.422

The following information will be applied as sticker to the packaging of prescription hearing aids entering the US market.

- Prescription hearing aid with integrated Lithium-ion battery

WARNING - Medical evaluation for people younger than 18: The use of a hearing aid in people younger than 18 years old without a medical evaluation may worsen impairment or disability. A prospective hearing aid user who is younger than 18 should have a recent medical evaluation from a doctor, prefe-

rably an ear-nose-throat doctor (an ENT). Prior to purchase, a doctor should determine that the person is a candidate for the use of a hearing aid.

Note: Ask about trial-rental or purchase-option programs. If you're unsure about your ability to get used to using a hearing aid, you should ask about a trial-rental or purchase-option program. Many hearing instruments specialists offer programs that allow you to wear a hearing aid for a short time, at a nominal fee, before you decide to buy a hearing aid.

Battery information: One hearing aid contains one rechargeable Lithium-lon battery.

#### WARNING: When to See a Doctor

If you have any of the problems listed below, please see a doctor, preferably an ear-nose-throat doctor (an ENT).


- Your ear has a birth defect or an unusual shape. Your ear was injured or deformed in an accident.
- You saw blood, pus, or fluid coming out of your ear in the past 6 months.
- · Your ear feels painful or uncomfortable.
- You have a lot of ear wax, or you think something could be in your ear.
- You get really dizzy or have a feeling of spinning or swaying (called vertigo).
- . Your hearing changed suddenly in the past 6 months.
- Your hearing changes: it gets worse then gets better again.
- You have worse hearing in one ear.
- · You hear ringing or buzzing in only one ear.
