The Spectrum was searched up to 2GHz.

The EUT was measured on three orthogonal axis. Fresh new batteries were used during this assessment.

All measurements were performed using a Quasi-Peak Detector with 120kHz RBW below 1GHz and a 1MHz RBW above 1GHz at a distance of 3 meters.
