ER3DV6 E-Field probe: The distances from the probe tip to the closest points on the dipole sensors are 1.45mm for X and Y and 1.25mm for Z. From the probe tip to the center of the sensors is 2.5mm.

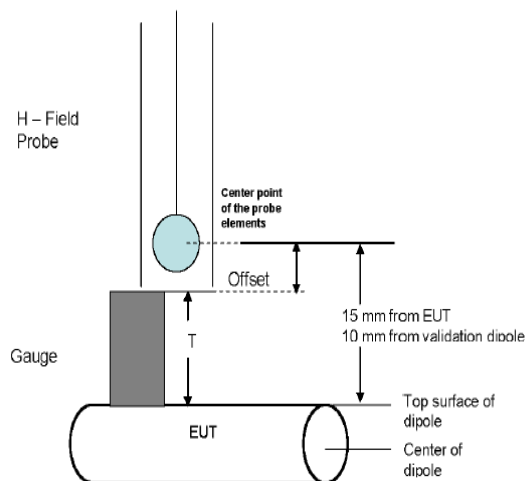

The following information is from the system manufacturer user manual describing the process chain:

The first step of the evaluation is a linearization of the filtered input signal to account for the compression characteristics of the detector diode. The compensation depends on the input signal, the diode type and the DC-transmission factor from the diode to the evaluation electronics. The measurement / integration time per point is > 500 ms, as per the system manufacturer:

The time response of the field probes has been assessed by exposing the probe to a well-controlled field producing signals larger than HAC E- and H-fields of class M4. The signal response time is evaluated as the time required by the system to reach 90% of the expected final value after an on/off switch of the power source with an integration time of 500 ms and a probe response time of <5 ms. In the current implementation, DASY4 waits longer than 100ms after having reached the grid point before starting a measurement, i.e., the response time uncertainty is negligible.

If the device under test does not emit a CW signal, the integration time applied to measure the electric field at a specific point may introduce additional uncertainties due to the discretization. The tolerances for the different systems had the worst-case of 2.6%.

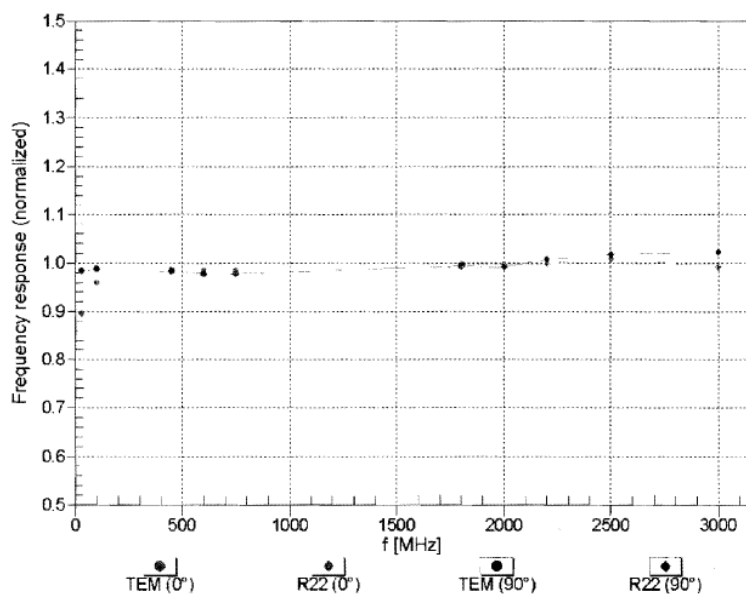

(TEM-Cell:ifi110 EXX, Waveguide: R22)



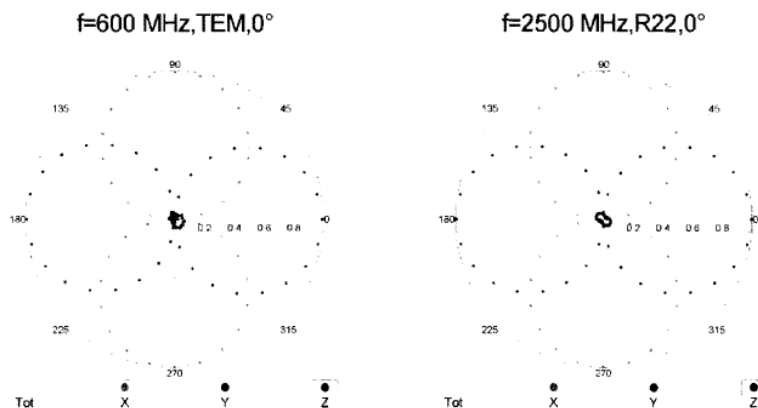

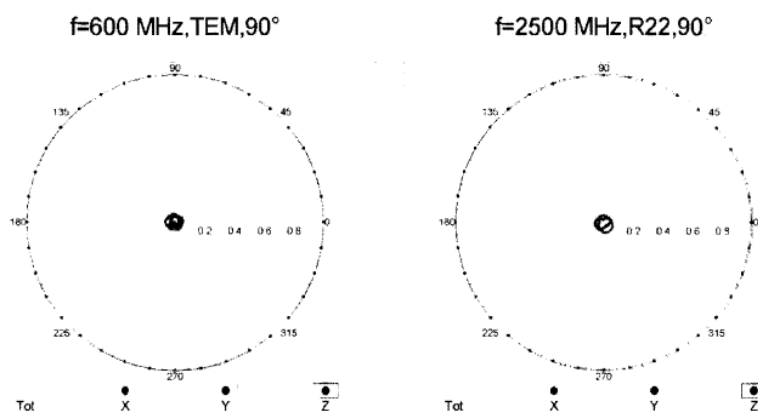

Receiving Pattern (ϕ), $\theta = 90^\circ$

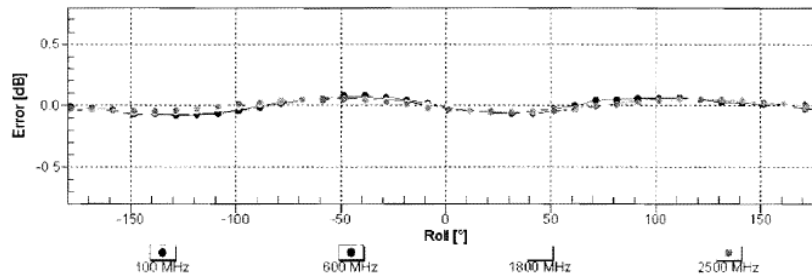

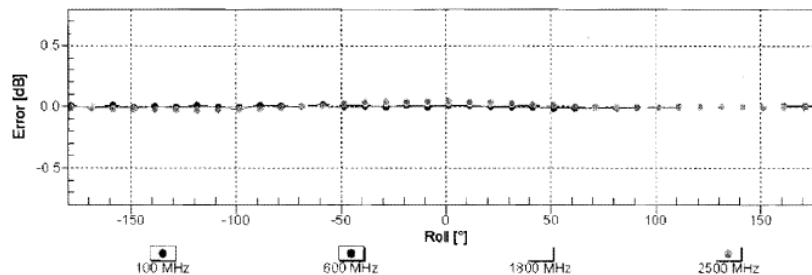

Receiving Pattern (ϕ), $\theta = 90^\circ$



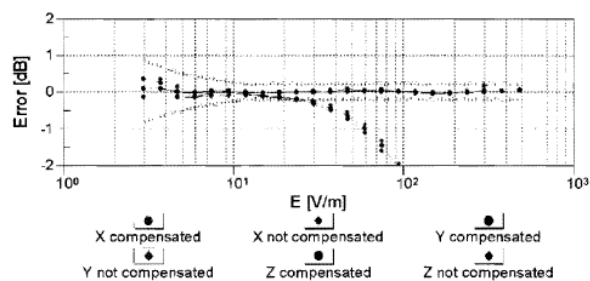
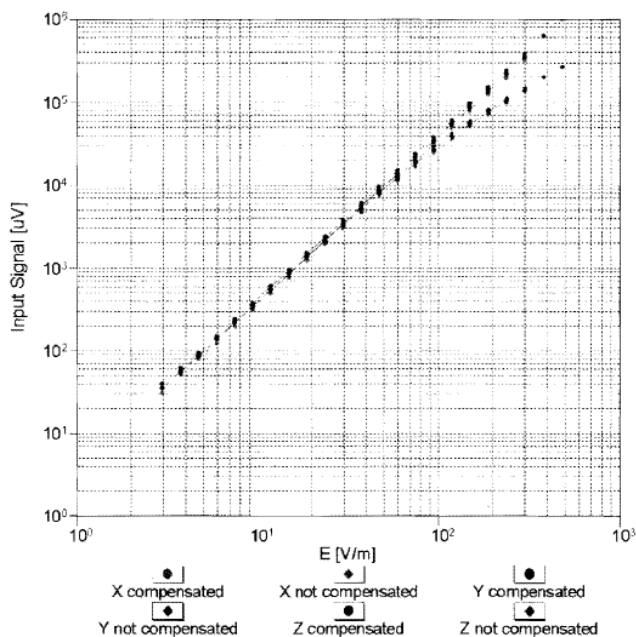

Dynamic Range f(E-field) (TEM cell , f = 900 MHz)



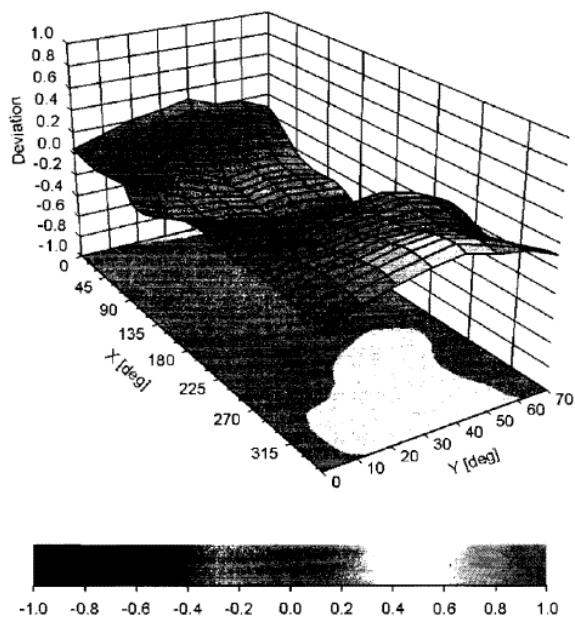



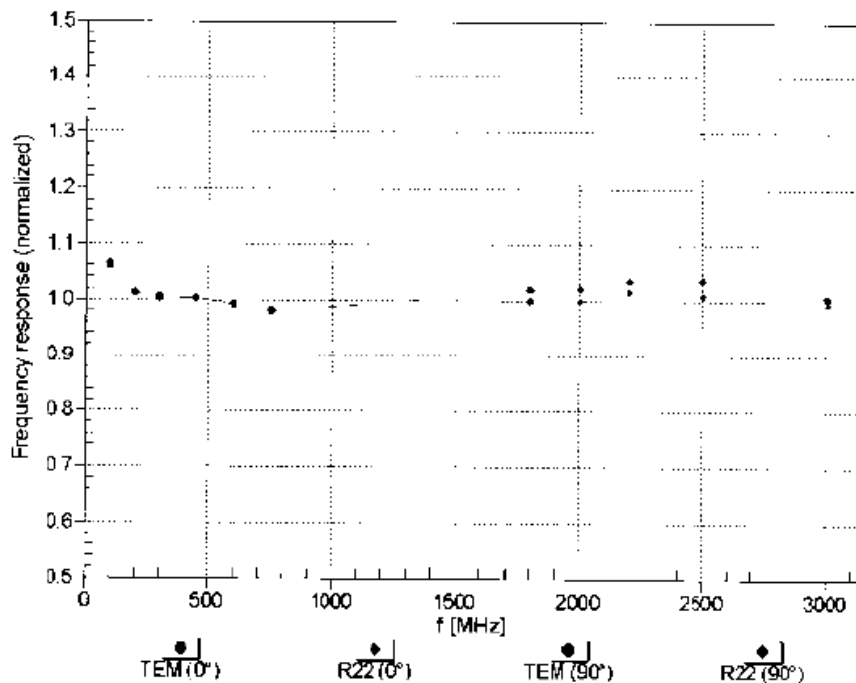

Frequency Response of H-Field (TEM-Cell:ifi110 EXX, Waveguide: R22)



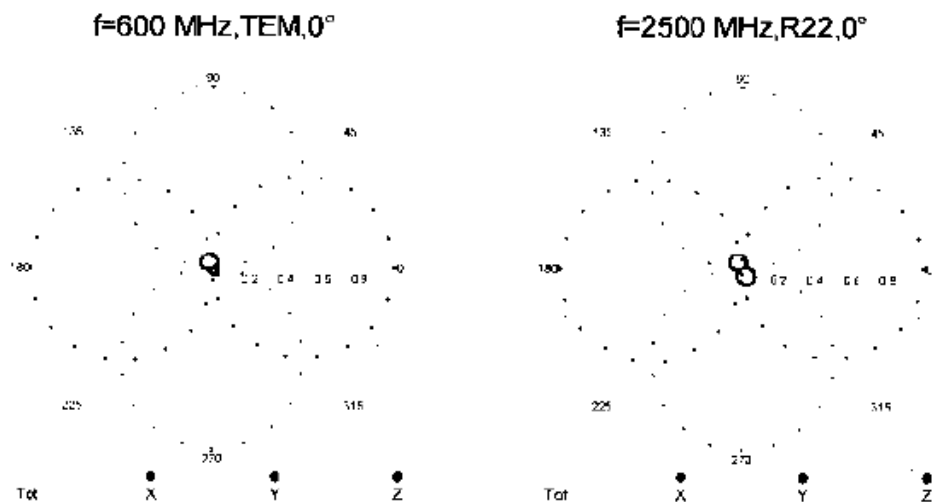

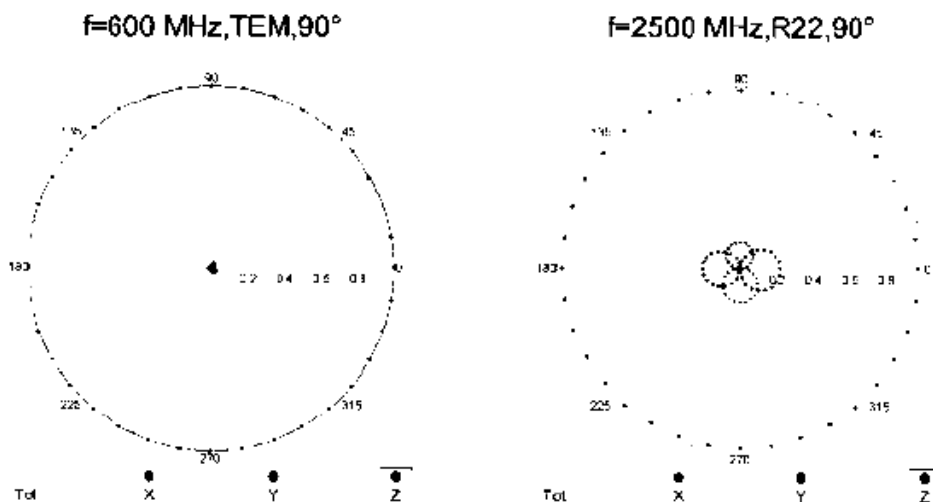

Receiving Pattern (ϕ), $\theta = 90^\circ$

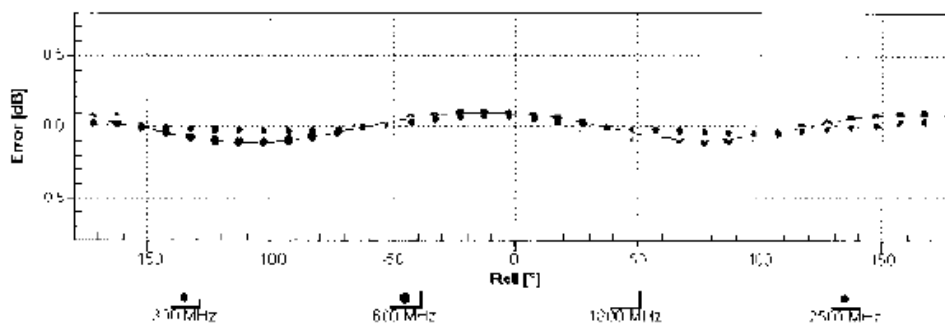

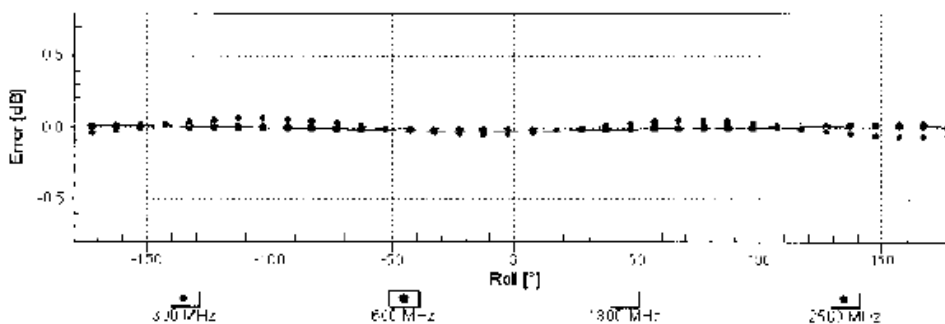

Receiving Pattern (ϕ), $\theta = 90^\circ$



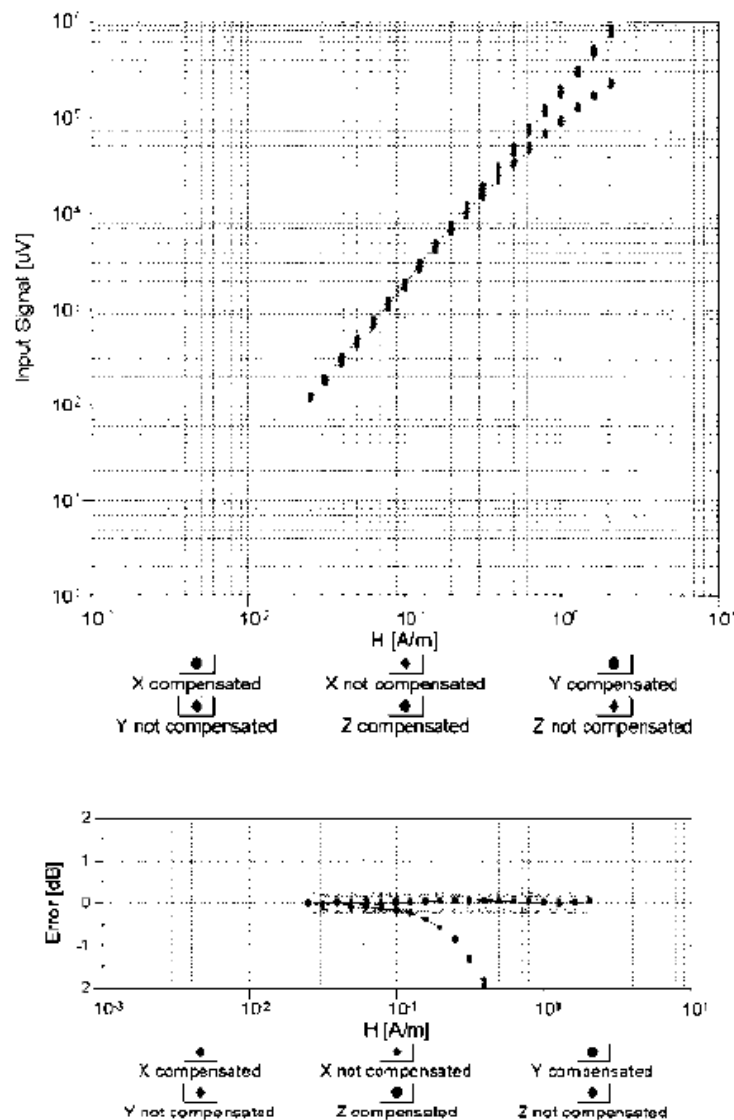

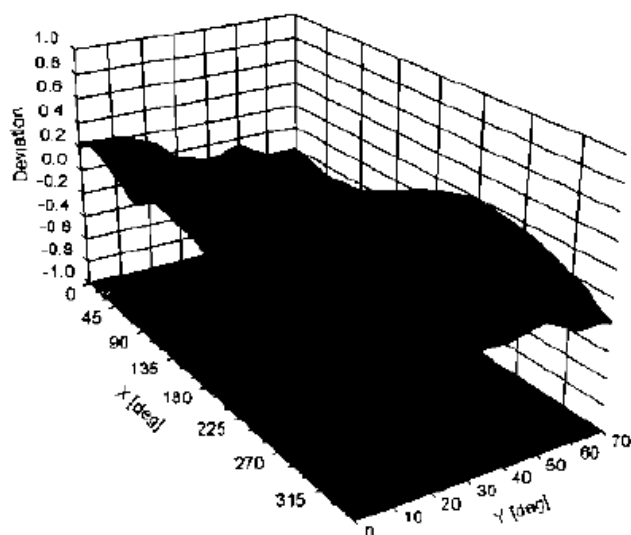
