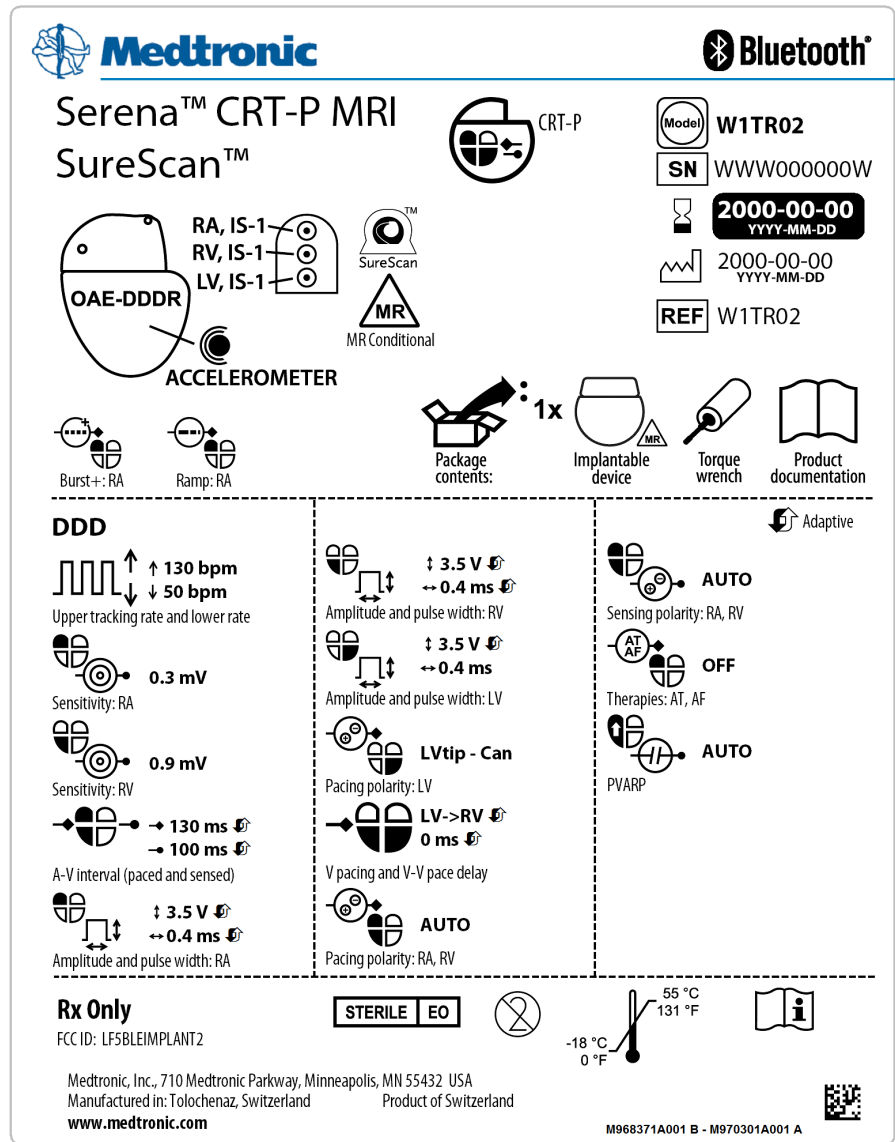

2. THESE LABEL IMAGES ARE THE COMBINATION OF THE TEMPLATE FILE, MODEL DATA RECORD, SAMPLE TRIGGER DATA AND REPRESENTATIVE VIEWS OF THE LABEL DIE LINES.
3. PRINTING REQUIREMENTS - THE LABELS ARE TO BE PRINTED USING A 300 DPI ZEBRA THERMAL TRANSFER PRINTER.
4. THE LOT OR SERIAL NUMBER, USE BY DATE, DATE OF MANUFACTURE, PIN NUMBER, ADDRESS CODE, GTIN, PRODUCT NUMBER (REF) AND BAR CODES ARE SHOWN FOR EXAMPLE ONLY. THESE FIELDS ARE VARIABLE AND ARE TO BE SUPPLIED BY MANUFACTURING AT THE TIME OF PRINTING.
5. SPACING AND TEXT WRAPPING SHOWN IN THE IMAGES MAY DIFFER SLIGHTLY FROM ACTUAL PRINTED LABEL, AS LONG AS CONTENT OF PRINTED VERSION IS ACCURATE.
