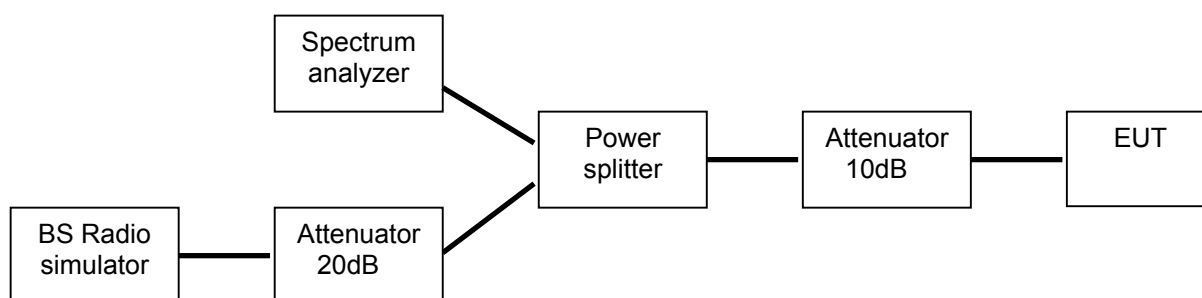

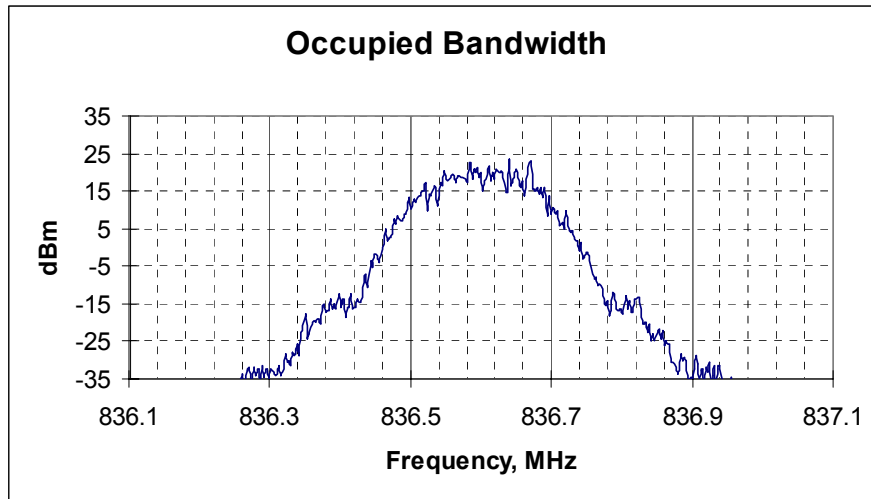

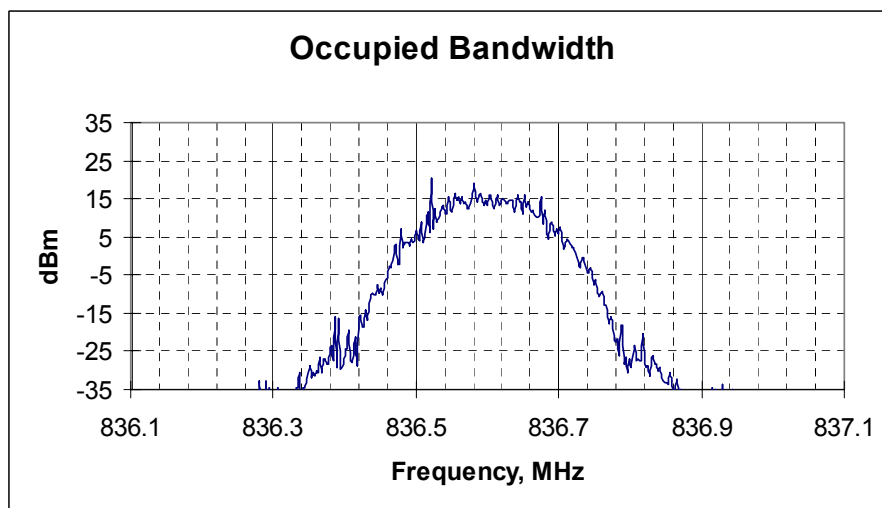
The 99% occupied bandwidth was measured using the in-built function of the spectrum analyzer.

RBw = VBw = 3KHz, Channel spacing = 200KHz



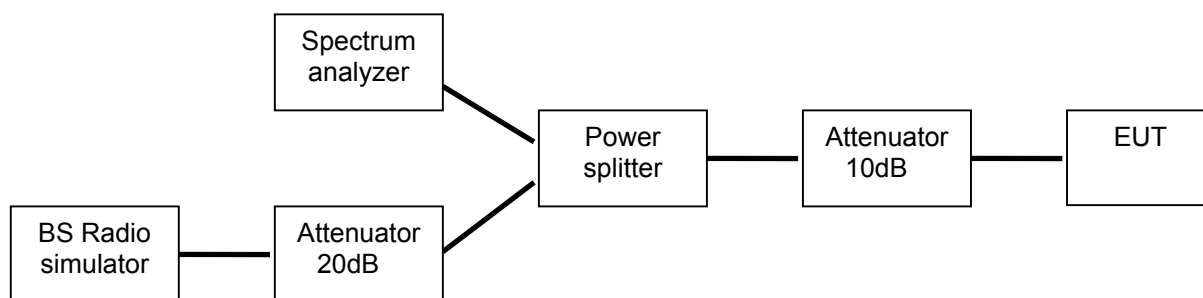
Picture 5. 99% occupied bandwidth, EGPRS channel 190

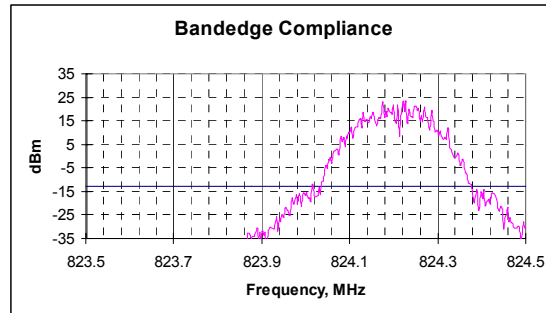

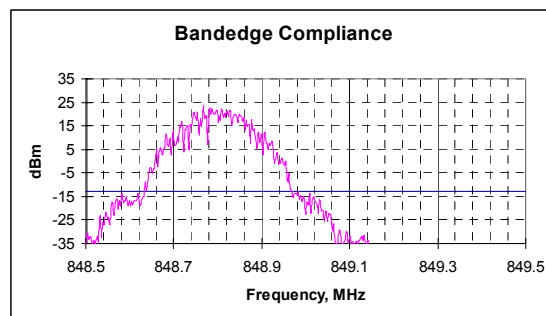
The line in the screen shots is the -13dBm limit line. The results were corrected with measurement path loss set as "offset" in the spectrum analyzer.

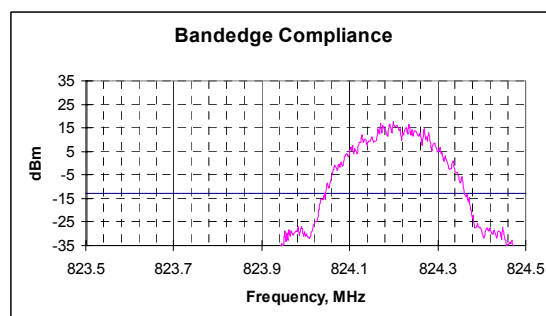

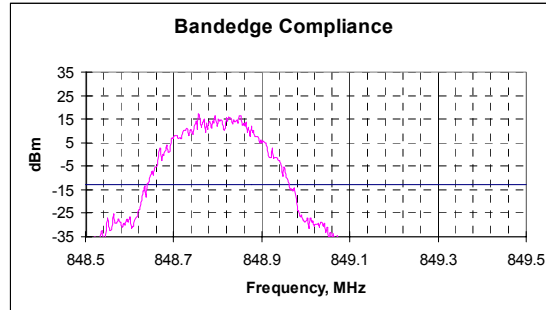
Picture 6. Lower bandedge, channel 128 GSM

RBw 3KHz VBw 3KHz



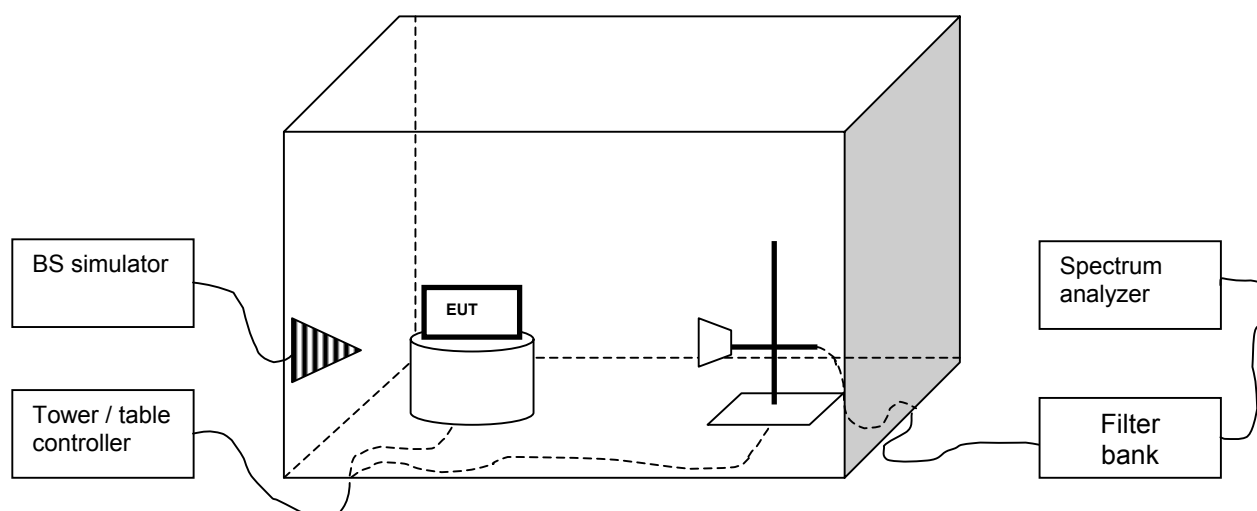
Picture 9. Upper bandedge, channel 251 EGPRS

7.1. Test setup

A set of LP/HP/BS filters was used to prevent overloading the spectrum analyzer. The BS simulator was used to set the TX channel and power level and modulate the TX signal with different bit patterns. The test was done manually.



7.2. Test method

- The emissions were searched and maximized by moving the turn table and measuring antenna and manipulating the EUT.
- All suspicious frequencies with emission levels were recorded.
- The EUT was replaced with a substituting antenna.
- For each frequency recorded, the substituting antenna was fed with the power (from signal generator) giving the same reading as in (b). These power levels were reported.

7.5. Results

The formula below was used to calculate the ERP of the spurious emissions. If there were no emissions closer than 20dB below the limit line, then the emission levels were documented only at the transmitter's mid-channel harmonics.

$$P_{\text{Emission[dBm]}} = P_{\text{SubstTX[dBm]}} - L_{\text{Cable[dB]}} + G_{\text{Antenna[dBi]}}$$

where the variables are as follows:

$P_{\text{Measured [dBm]}}$	Measured emission level (from step b in 7.2)
$P_{\text{Subst_TX [dBm]}}$	Signal generator power (from step d in 7.2) fed to the substituting antenna
$L_{\text{Cable [dB]}}$	Loss of the cable between antenna and signal generator (from step d in 7.2)
$G_{\text{Antenna [dBi]}}$	Gain of the substitutive antenna over isotropic radiator

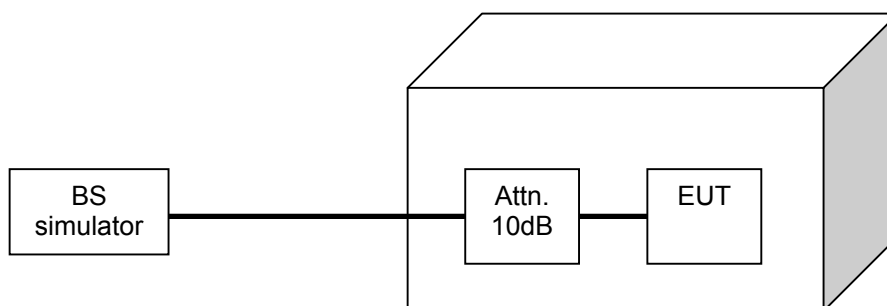

8.4. Test method

- The EUT was placed in the chamber
- The climate chamber temperature was set to the maximum value (50°C) and the temperature was allowed to stabilize for 45 minutes
- The EUT was set to transmit.
- The transmit frequency error was measured after 1 minute

- e) The call was released
- f) Temperature decreased 10 °C and allowed to stabilize for 45 minutes after set temperature was reached
- g) The steps c - f were repeated for each temperature

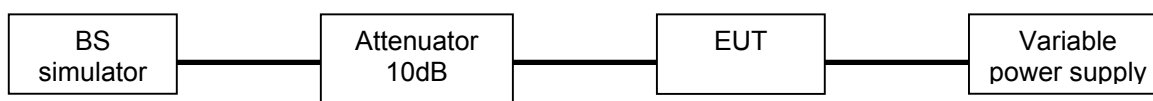
