Cubic has recently made a decision to rename the 13.56 MHz smart card read/write transceiver heretofore known as the MiniRTD to a new name, Tri-Reader[®] 2. We are preparing a new User Manual that reflects this name change, but the remaining internal documentation will still carry the name "MiniRTD" in the document title blocks until we can revise each of them.

Recognizing the importance of branding in the marketplace, as determined by our Marketing Department, our priority is to ensure that the regulatory approvals and any documentation released to the public reflects the new name. Considering that production bases the identification of assemblies and all build schedules on of part numbers and revision levels, and that drawing title blocks are merely a convenience for Cubic personnel rather than a determinant of any aspect of production, our other internal documents that show the obsolete naming will also be changed, but the priority for this continuing work will be lower than for updating user manuals and approvals application forms.

For anyone with an interest in verifying that all internal design documents carry updated title blocks, I ask your patience while we work through the many drawings involved. Please contact me directly if you have any questions.
