GENERAL DESCRIPTION

1.0 **General Description**

1.1 Product Description

The Equipment Under Test (EUT) is a Wireless Water Alarm Transmitter operating at 312 MHz. The EUT is powered by 9V battery (1 x "9V" Alkaline Battery). The EUT consists of a switch (Test Mode and Standby Mode) and a remote sensor with suction cup. Test Mode will transmit the signal and will be stopped automatically within 3 seconds. Standby Mode will transmit the signal and stopped automatically within 3 seconds when the two metal contacts on the sensor reached by the water level.

1.2 Original Identification Information

The original identification (FCC ID) of the equipment is JYTHONIN03300T and granted on Jun 25, 1999. The name of grantee is Sun Fu Cheong Electronics Co. Ltd. The copy of certificate is saved with filename: cert.pdf
