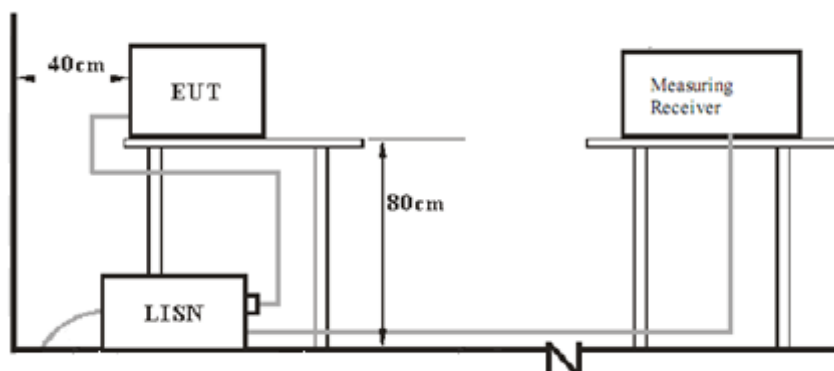
7.1 Radiated test setups Below 1GHz



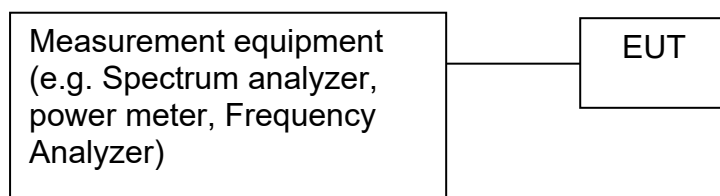
7.2 Radiated test setups Above 1GHz

Limit

For intentional device, according to FCC Title 47 Part 15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. And according to FCC Title 47 Part 15.247(b), if transmitting antennas of directional gain greater than 6 dBi are used, the power shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6 dBi.

Antenna Connector Construction

The antenna used in this product is an integrated antenna on PCB, and the maximum gain of this antenna is 0.0 dBi.

9 Test setup procedure

9.1 Spurious Radiated Emission

Test Method

- 1: The EUT was placed on a turn table which is 1.5m above ground plane for above 1GHz and 0.8m above ground for below 1GHz at 3 meter chamber room for test. The table was rotated 360 degrees to determine the position of the highest radiation.
- 2: The EUT was set 3 meters away from the interference – receiving antenna, which was mounted on the top of a variable – height antenna tower.
- 3: The height of antenna is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are set to make the measurement.
- 4: For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights from 1 meter to 4 meters and the rotatable table was turned from 0 degrees to 360 degrees to find the maximum reading.
- 5: Use the following spectrum analyzer settings According to C63.10:

For Below 1GHz

Use the following spectrum analyzer settings:

Span = wide enough to capture the peak level of the in-band emission and all spurious
 RBW = 100 KHz to 120KHz, VBW ≥ RBW for peak measurement, Sweep = auto, Detector function = peak, Trace = max hold.

For Peak unwanted emissions Above 1GHz:

Span = wide enough to capture the peak level of the in-band emission and all spurious
 RBW = 1MHz, VBW ≥ RBW for peak measurement, Sweep = auto, Detector function = peak, Trace = max hold.

Procedures for average unwanted emissions measurements above 1000 MHz

a) RBW = 1MHz.

b) VBW \ [3 × RBW].

c) Detector = RMS (power averaging), if [span / (# of points in sweep)] \ RBW / 2.

Satisfying this condition can require increasing the number of points in the sweep or reducing the span. If the condition is not satisfied, then the detector mode shall be set to peak.

d) Averaging type = power (i.e., rms) (As an alternative, the detector and averaging type may be set for linear voltage averaging. Some instruments require linear display mode to use linear voltage averaging. Log or dB averaging shall not be used.)

e) Sweep time = auto.

f) Perform a trace average of at least 100 traces if the transmission is continuous. If the transmission is not continuous, then the number of traces shall be increased by a factor of 1 / D, where D is the duty cycle. For example, with 50% duty cycle, at least 200 traces shall be averaged. (If a specific emission is demonstrated to be continuous—i.e., 100% duty cycle—then rather than turning ON and OFF with the transmit cycle, at least 100 traces shall be averaged.)

g) If tests are performed with the EUT transmitting at a duty cycle less than 98%, then a correction factor shall be added to the measurement results prior to comparing with the

emission limit, to compute the emission level that would have been measured had the test been performed at 100% duty cycle. The correction factor is computed as follows:

1) If power averaging (rms) mode was used in the preceding step e), then the correction factor is $[10 \log (1 / D)]$, where D is the duty cycle. For example, if the transmit duty cycle was 50%, then 3 dB shall be added to the measured emission levels.

2) If linear voltage averaging mode was used in the preceding step e), then the correction factor is $[20 \log (1 / D)]$, where D is the duty cycle. For example, if the transmit duty cycle was 50%, then 6 dB shall be added to the measured emission levels.

3) If a specific emission is demonstrated to be continuous (100% duty cycle) rather than turning ON and OFF with the transmit cycle, then no duty cycle correction is required for that emission.

Limit

The radio emission outside the operating frequency band shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power.

Radiated emissions which fall in the restricted bands, as defined in section RSS-GEN 8.10, must comply with the radiated emission limits specified in section 15.209.

According to C63.10, if the peak (or quasi-peak) measured value complies with the average limit, it is unnecessary to perform an average measurement, so AV emission value did not show in below table if the peak value complies with average limit.

9.2 Conducted Emission at AC Power line

Test Method

1. The EUT was placed on a table, which is 0.8m above ground plane
2. The power line of the EUT is connected to the AC mains through a Artificial Mains Network (A.M.N.).
3. Maximum procedure was performed to ensure EUT compliance
4. A EMI test receiver is used to test the emissions from both sides of AC line

According to §15.207 & RSS-GEN 8.8, conducted emissions limit as below:

9.3 6dB & 99% Bandwidth

1. Use the following spectrum analyzer settings:
RBW=100K, VBW \geq 3RBW, Sweep = auto, Detector function = peak, Trace = max hold
2. Use the automatic bandwidth measurement capability of an instrument, may be employed using the X dB bandwidth mode with X set to 6 dB, care shall be taken so that the bandwidth measurement is not influenced by any intermediate power nulls in the fundamental emission that might be \geq 6 dB.
3. Allow the trace to stabilize, record the X dB Bandwidth value.

9.4 Peak Output Power

Test Method

1. Connect the spectrum analyzer to the EUT
 - a) The EUT is configured to transmit continuously, or to transmit with a constant duty factor.
 - b) At all times the EUT is transmitting at its maximum power control level.
 - c) The integration period of the power meter exceeds the repetition period of the transmitted signal by at least a factor of five.
2. Measure the average power of the transmitter. This measurement is an average over both the on and off periods of the transmitter.
3. Adjust the measurement in dBm by adding $10\log(1/x)$, where x is the duty cycle to the measurement result.

 - b. Allow trace to fully stabilize, use the peak marker function to determine the maximum PSD level.
2. Use the maximum PSD level to establish the reference level.
 - a. Set the center frequency and span to encompass frequency range to be measured.
 - b. Use the peak marker function to determine the maximum amplitude level. Ensure that the amplitude of all unwanted emissions outside of the authorized frequency band (excluding restricted frequency bands) are attenuated by at least the minimum requirements, report the three highest emissions relative to the limit.
3. Repeat above procedures until other frequencies measured were completed.


