5-Button Remote Functions:

BANK #1 (Directly Press Buttons)

Button 1: Arm **Button 2: Disarm**

Button 3: Aux #1 (Trunk)

Button 4: Keep press for Panic

When Ignition ON short press for Carjacking by

"Programing options 13 with [Active] and 14 with [Enabled]"

Button 5: (Change to Bank #2)

BANK #2 (Press Button 5 First, then within 3 seconds Buttons 1-4)

Button 1: Silent Arm (No Chirp) Button 2: Silent Disarm (No Chirp)

Button 3: Car Locator (Successive Chirp)

Button 4: Aux #2

Remote Transmitter Programming

Turn Ignition ON.

1. Press the Program/Override Button 4 times and you should see 4 light flashes.

Press #1 (LOCK) Button on the new transmitter. LAMP flash one time for Code-learn confirmation. Press

#1 Button on a second, third or fourth remote at this time (If needed).

Turn OFF Ignition to stop Code-learn.

Note 1: This system will lean a total of 4 transmitters max.

Option Programming

Turn the Ignition ON and press the Override/program button 5 times. Parking Light flash 5 times for 1.

"Programming" confirmation.
Within the next few seconds, press the Override/Program button [again] the number of times that corresponds to the feature list below. The siren will chirp for each button press. DO NOT LOSE COUNT!!

When you get to the desired option number, press the appropriate button on the transmitter according the chart below. Turn Ignition OFF. See below for Option numbers, description, and values. (Button 1 give a single light flash/chirp, Button 2 give two light flashes/chirps, and Button 3 gives three light flashes/chirps.)


Change One option at a time repeating steps 1-3 as needed. When you are finished customizing options,

check operation to see if the option(s) have changed.
