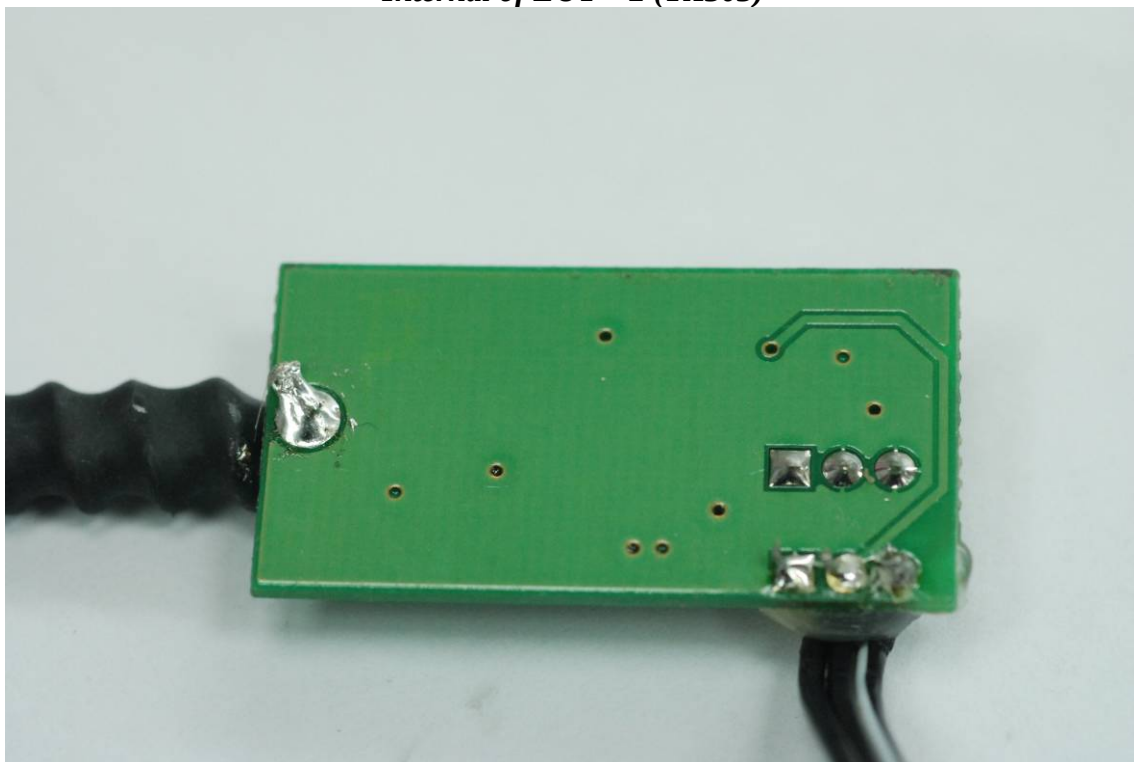

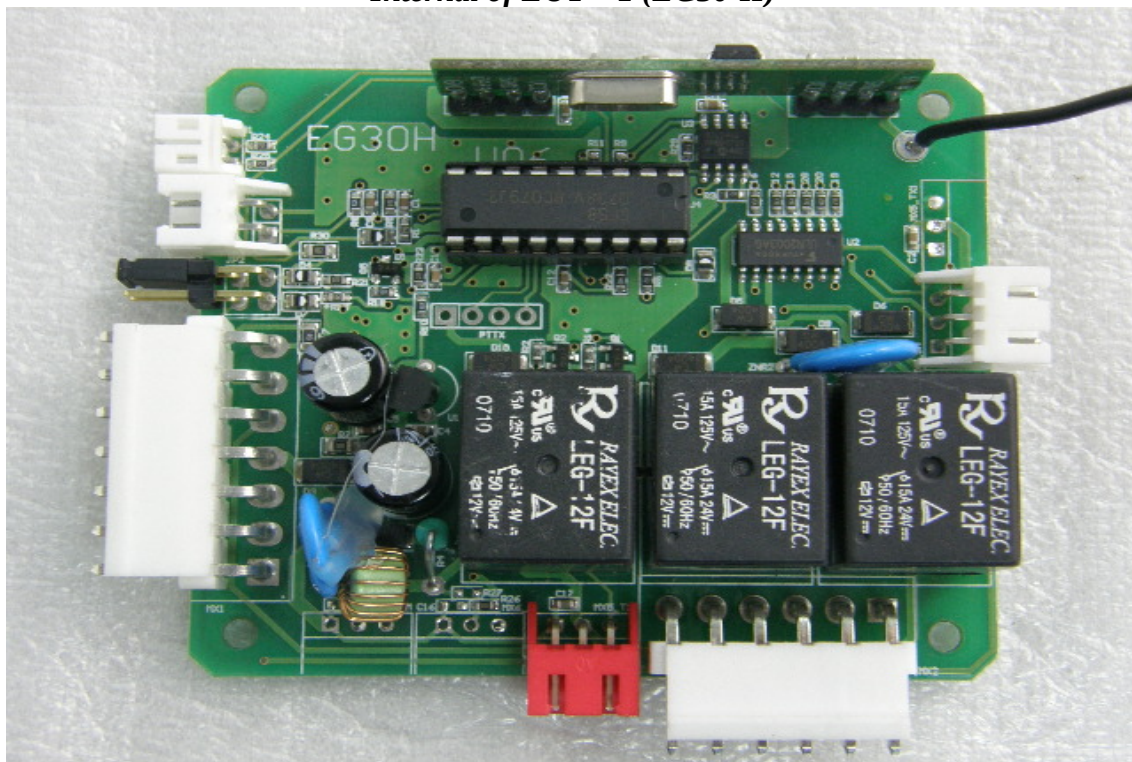


Open View of EUT (EG30-H)

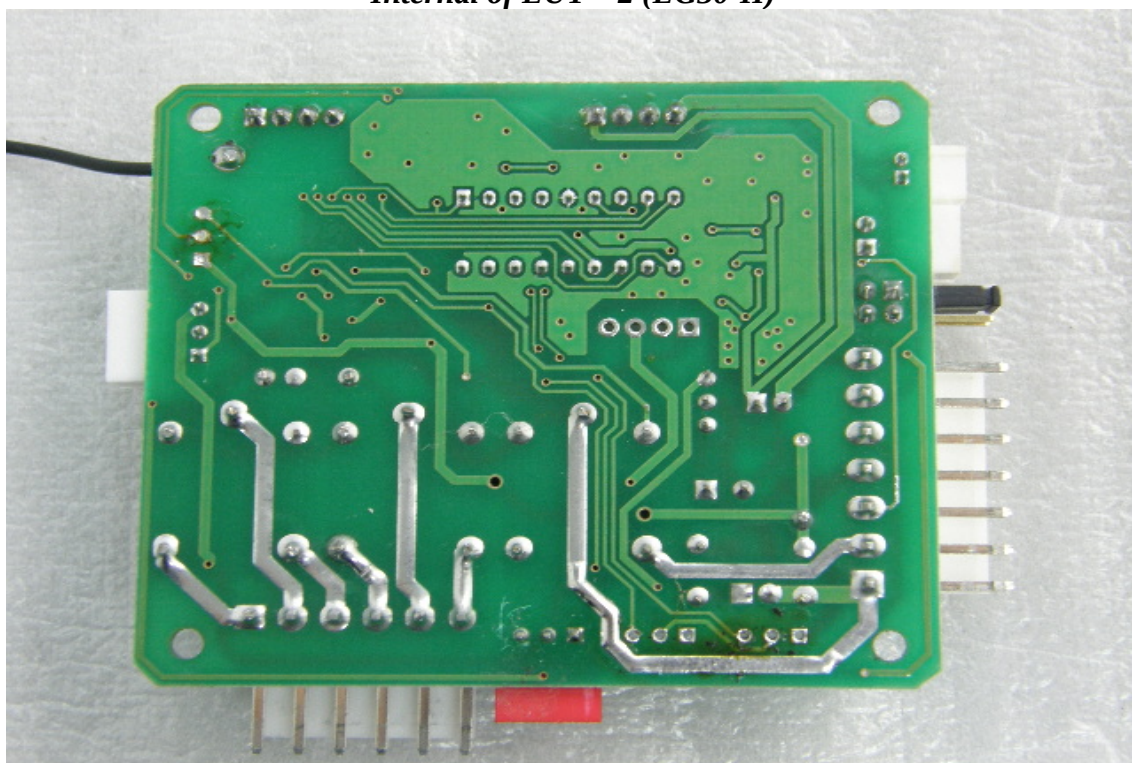

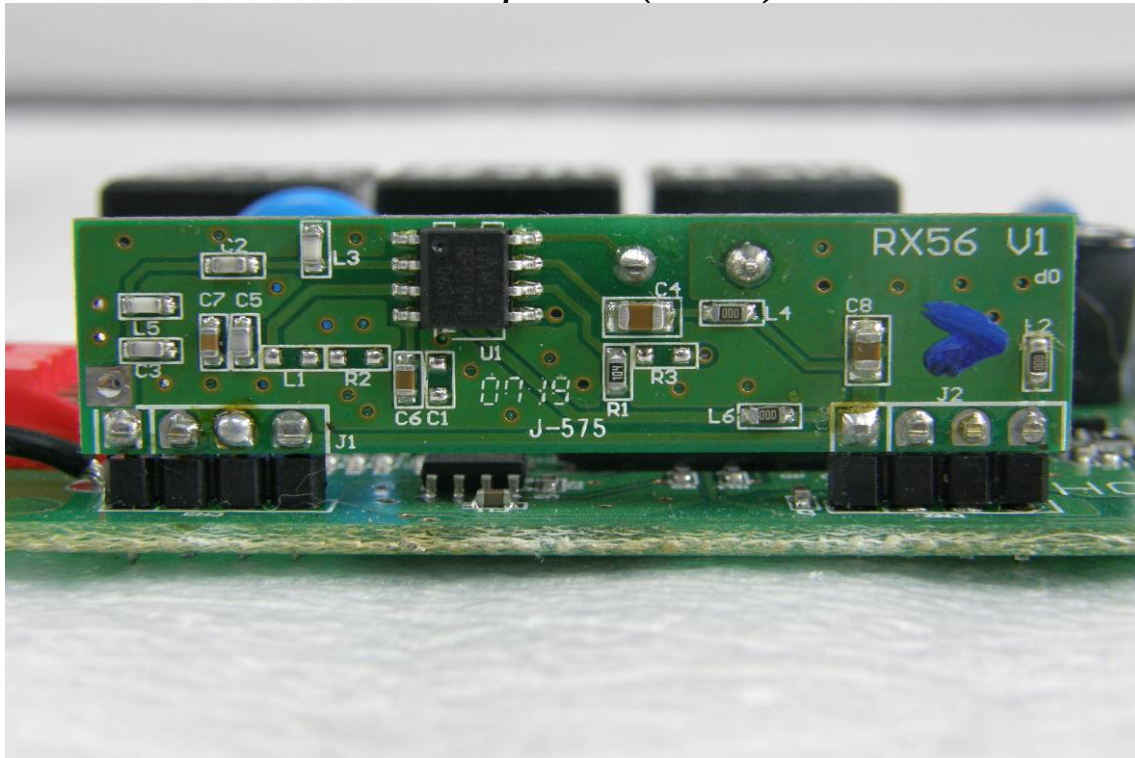

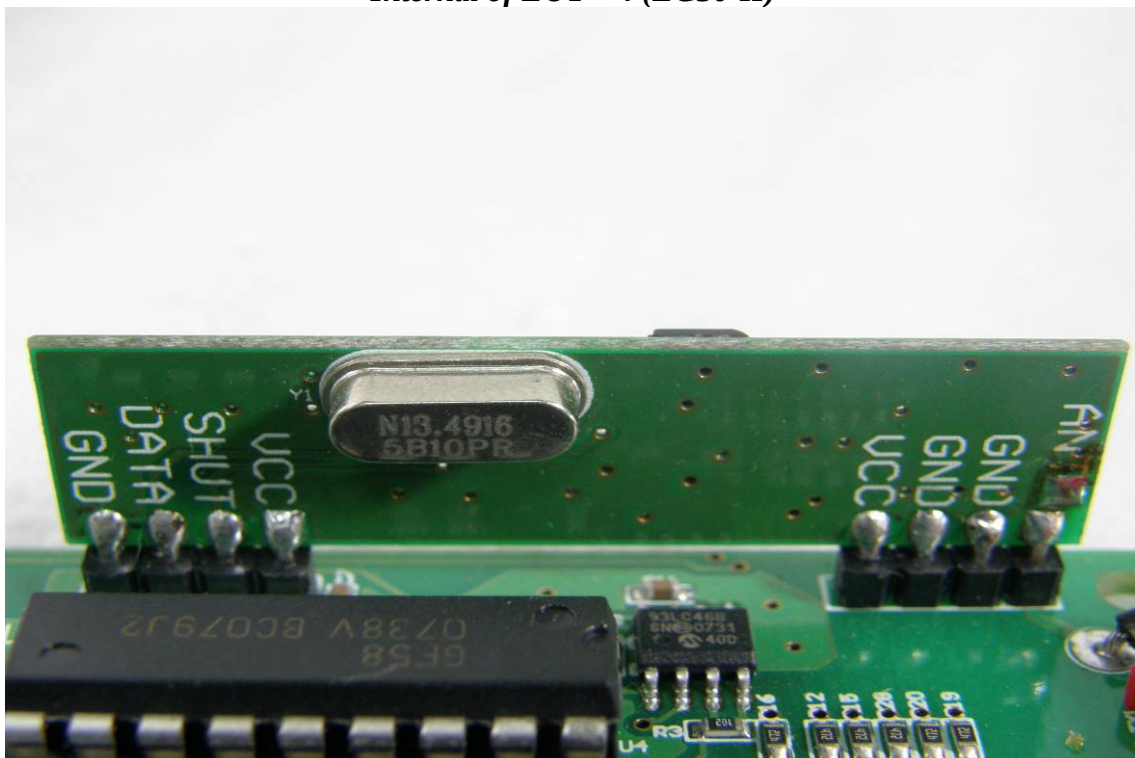
