2.2 MPE Calculation Formula

$$Pd = (Pout*G) / (4*pi*r^2)$$

where

Pd = power density in mW/cm²

Pout = output power to antenna in mW

G = gain of antenna in linear scale

pi = 3.1416

r = distance between observation point and center of the radiator in cm

2.3 Classification

The antenna of this product, under normal use condition, is at least 443cm away from the body of the user. So, this device is classified as fixed station and installations by professional service personnel device.

3 General Description of Antenna Gain

The antennas provided to the EUT, please refer to the following table:

Note:

1. EIRP Power = Conducted Power + Antenna gain
2. Determining compliance based on the results of the compliance measurement, not taking into account measurement instrumentation uncertainty.

Conclusion:

The formula of calculated the MPE is:

$$CPD1 / LPD1 + CPD2 / LPD2 + \dots \text{etc.} < 1$$

CPD = Calculation power density

LPD = Limit of power density

$$\text{Band n66} + \text{Band n70} = 0.387/1 + 0.610/1 = 0.997$$

Therefore the maximum calculations of above situations are less than the “1” limit.
