## SINGLE MODULAR APPROVAL LETTER

June 9, 2015

Dear Application Examiner:

Remote Technologies Inc. is seeking a Single Modular Approval for the APM 6998 WiFi Module with FCC ID MMURTI2100. The radio meets the requirements for modular approval as detailed in FCC 15.212. Compliance to each of the requirements is described below:

1. **"The modular transmitter must have its own RF shielding."** The radio portion of the module is contained in its own RF shielding. The shielding is installed at the factory. Please see the Internal Photos exhibit uploaded with the original filing.
2. **"The modular transmitter must have buffered modulation/data inputs."** The EUT has buffered data inputs to insure compliance with Part 15 requirements under conditions of excessive data rates or over-modulation. Please see the Schematics exhibit uploaded with the original filing.
3. **"The modular transmitter must have its own power supply regulation."** The EUT has its own power supply regulation to insure compliance with Part 15 requirements regardless of the quality or level of external DC supplying the module from the host unit. Please see Schematics exhibit uploaded with the original filing. Also, the technical report exhibit uploaded with the original filing contains AC power line conducted emissions data taken with the EUT powered from a linear power supply that contains no EMC suppression components.
4. **"The modular transmitter must comply with the antenna requirements of Section 15.203 and 15.204(c)."** The EUT meets the FCC antenna requirements. Please see OEM Integration Instructions.
5. **"The modular transmitter must be tested in a stand-alone configuration."** The EUT was tested in a stand-alone configuration. The module was greater than 10 cm from the host device. Please see Test Setup Photos exhibit and Technical Report exhibit uploaded with the original filing.
6. **"The modular transmitter must be labeled with its own FCC ID number."** The EUT is labeled with its own FCC ID number. Please see FCC ID label & location exhibit uploaded with the original filing. If the FCC ID number will not be visible when the module is installed inside a host device, another label with the FCC ID will be applied to the exterior of the host device.
7. **"The modular transmitter must comply with any specific rule or operating requirements applicable to the transmitter and the manufacturer must provide adequate instructions along with the module to explain any such requirements."** The EUT is compliant with all applicable FCC rules. Please see OEM Integration Instructions.
8. **"The modular transmitter must comply with any applicable RF exposure requirements."** The EUT is compliant with all applicable RF exposure requirements. Please see RF Exposure Exhibit uploaded with the original filing.
