2 EVALUATION RESULT

Following FCC KDB 447498 D01 “General SAR test exclusion guidance”

The corresponding SAR Exclusion Threshold condition, listed below:

- 1) The 1-g and 10-g SAR test exclusion thresholds for 100 MHz to 6 GHz at test separation distances ≤ 50 mm are determined by:

$[(\text{max. power of channel, including tune-up tolerance, mW}) / (\text{min. test separation distance, mm})] \cdot [\sqrt{f(\text{GHz})}] \leq 3.0$ for 1-g SAR and ≤ 7.5 for 10-g extremity SAR where

- $f(\text{GHz})$ is the RF channel transmit frequency in GHz
- Power and distance are rounded to the nearest mW and mm before calculation
- The result is rounded to one decimal place for comparison

The test exclusions are applicable only when the minimum test separation distance is ≤ 50 mm and for transmission frequencies between 100 MHz and 6 GHz. When the minimum test separation distance is < 5 mm, a distance of 5 mm is applied to determine SAR test exclusion.

- 2) At 100 MHz to 6 GHz and for test separation distances > 50 mm, the SAR test exclusion threshold is determined according to the following:

- a) $[\text{Threshold at 50 mm in step 1}) + (\text{test separation distance} - 50 \text{ mm}) \cdot (f(\text{MHz})/150)]$ mW, at 100MHz to 1500 MHz
- b) $[\text{Threshold at 50 mm in step 1}) + (\text{test separation distance} - 50 \text{ mm}) \cdot 10]$ mW at > 1500 MHz and ≤ 6 GHz

- 3) At frequencies below 100 MHz, the following may be considered for SAR test exclusion.

- a) The threshold at the corresponding test separation distance at 100 MHz in step 2) is multiplied by $[1 + \log(100/f(\text{MHz}))]$ for test separation distances > 50 mm and < 200 mm.
- b) The threshold determined by the equation in a) for 50 mm and 100 MHz is multiplied by $\frac{1}{2}$ for test separation distances ≤ 50 mm.
- c) SAR measurement procedures are not established below 100 MHz. When SAR test exclusion cannot be applied, a KDB inquiry is required to determine SAR evaluation requirements for any test results to be acceptable.

3 SAR TEST EXCLUSION THRESHOLDS

3.1 SAR TEST EXCLUSION THRESHOLDS - GSM AND WCDMA

Smallest distance from the antenna and radiating structures or outer surface of the device

The minimum test separation distance is determined by the smallest distance from the antenna and radiating structures or outer surface of the device, according to the host form factor, exposure conditions and platform requirements, to any part of the body or extremity of a user or bystander. Note: Calculations for RF Exposure compliance in the cellular and PCS bands are base on the maximum source based time-average power obtained from 2-Slot GPRS operation. The resulting duty cycle factor is 2/8, or 6.02dB.

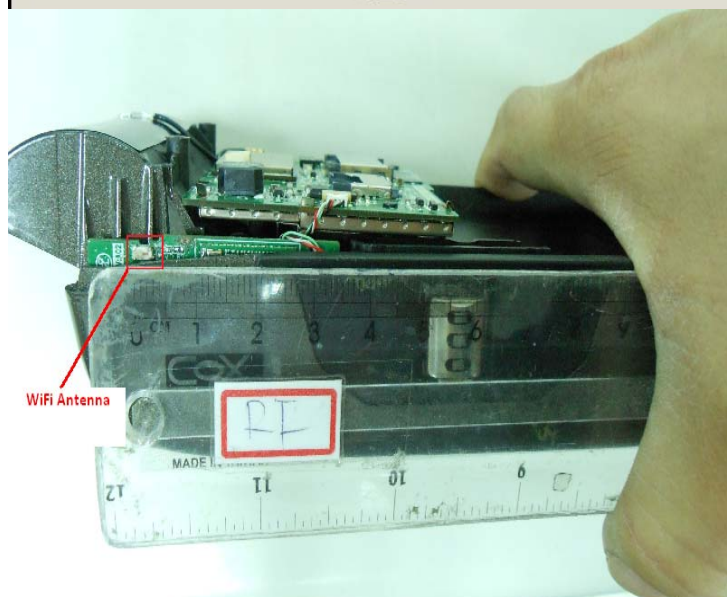

3.2 SAR TEST EXCLUSION THRESHOLDS - WLAN

Smallest distance from the antenna and radiating structures or outer surface of the device

The minimum test separation distance is determined by the smallest distance from the antenna and radiating structures or outer surface of the device, according to the host form factor, exposure conditions and platform requirements, to any part of the body or extremity of a user or bystander. 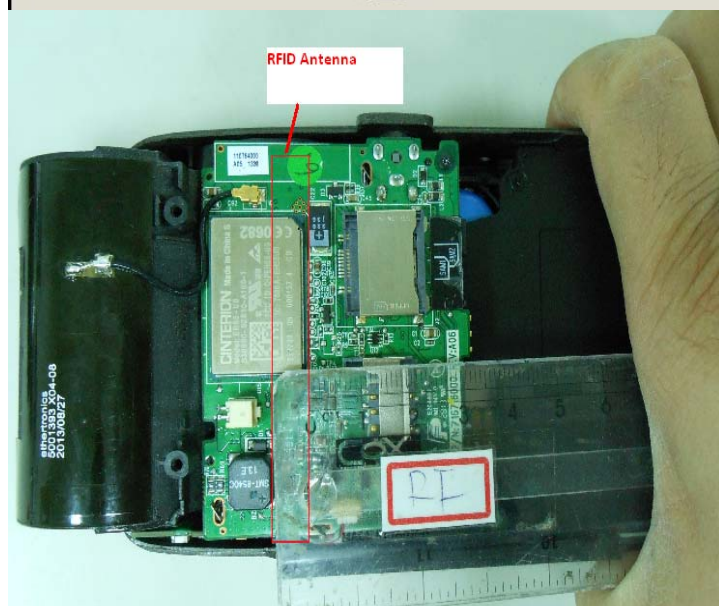

3.3 SAR TEST EXCLUSION THRESHOLDS - RFID

Smallest distance from the antenna and radiating structures or outer surface of the device

The minimum test separation distance is determined by the smallest distance from the antenna and radiating structures or outer surface of the device, according to the host form factor, exposure conditions and platform requirements, to any part of the body or extremity of a user or bystander. (See below figure)

Mode	Frequency (MHz)	Electric field (dBuV/m) @10m	EIRP (dBm)
RFID	13.56	69.9	-25.3

Field strength is then converted to EIRP as follows:

(i) $EIRP = ((E \cdot d)^2) / 30$

where:

E is the field strength in V/m;

d is the measurement distance in meters;

EIRP is the equivalent isotropically radiated power in watts.

(ii) Working in dB units, the above equation is equivalent to: $EIRP[dBm] = E[dB\mu V/m] + 20 \log(d[meters]) - 104.77$

(iii) Or, if d is 3 meters: $EIRP[dBm] = E[dB\mu V/m] - 95.2$
