


Fig.2 Photograph of the mmW measurement system






Fig.3 Photograph of the tissue simulant fluid liquid depth




Photograph 3. Head, Right Tilt, 0mm




Photograph 5. Head, Left Touch, 0mm







#### PD - distance between probe sensor and EUT is 15 mm




Photograph 35. PD, Front Surface, 15mm




Photograph 36. PD, Front Surface, 15mm


