#### **Caring for your Chromebook**



Disconnect the AC power and remove the battery pack (if applicable) before cleaning your Chromebook. Use a clean cellulose sponge or chamois cloth dampened with warm water or a solution with low concentration of nonabrasive detergent. Remove any extra moisture from your Chromebook using a dry cloth. Keep any liquids from entering the chassis or keyboard gap to prevent short circuit or corrosion.



Do not use strong solvents such as alcohol, thinners, benzene, or other chemicals on or near your Chromebook.



Do not place objects on top of your Chromebook.



Do not expose your Chromebook to strong magnetic or electrical fields.



Do not use or expose your Chromebook near liquids, rain, or moisture.



Do not expose your Chromebook to dusty environments.



Do not use your Chromebook near gas leaks.



Do not place active electronic devices close to your Chromebook to avoid electromagnetic wave interference to the display panel.

#### **Battery safety information**

#### **Battery protection**

 Frequently charging a battery under high voltage may shorten the battery life. To protect the battery, once the battery is fully charged, the system may stop charging when the battery power is between 90% and 100%.

**NOTE:** The initiate battery power charging capacity is usually set between 90% and 99%. Actual value may vary by models.

- Charging or storing a battery in high ambient temperatures may result in permanent damage to the battery power capacity and rapidly shorten battery life. If the battery temperature is too high, the system may reduce the battery power charging capacity or even stop charging to protect the battery.
- Battery power capacity may drop even when your device is powered off and disconnected from the AC power. This is normal as the system still draws a small amount of power from the battery.

#### **Standard battery care**

- If you are not using your device for a long period of time, ensure
  to charge the battery power to 50% then power off your device
  and disconnect the AC power adapter. Recharge the battery
  power to 50% every three months to avoid over-discharging and
  prevent damage to the battery. Or you may enable the long-term
  storage mode for your Chromebook in a few steps:

- Do not leave your battery in damp environments. Exposure to damp environments may increase the battery over-discharging rate. Low temperature environment may damage the chemicals inside the battery while high temperature or overheating may result in a risk of explosion.
- Do not place your device or battery pack near radiators, fireplaces, furnaces, heaters, or any sources of heat with temperature exceeding 60°C (140°F). High temperature surrounding environment may result in an explosion or leakage that may cause fire.




### Chapter 1: Hardware Setup

#### **Getting to know your Chromebook**

#### **Top View**

**NOTE:** The keyboard's layout may vary per region or country. The top view may also vary in appearance depending on the Chromebook model.



Array microphones

The array microphones feature echo canceling, noise suppression, and beam forming functions for better voice recognition and audio recording.

Camera indicator

The camera indicator lights up when the built-in camera is in use.

Camera

The built-in camera allows you to take pictures or record videos using your Chromebook.

Display panel

This high-definition display panel provides excellent viewing features for photos, videos, and other multimedia files on your Chromebook.

#### **6** Keyboard

The keyboard provides full-sized QWERTY keys with a comfortable travel depth for typing. It also enables you to use the function keys and controls other multimedia functions.

**NOTE:** The keyboard layout differs by model or territory.

#### Touchpad

The touchpad allows the use of multi-gestures to navigate onscreen, providing an intuitive user experience. It also simulates the functions of a regular mouse.

**NOTE:** For more details, refer to the *Using the touchpad* section in this manual.


#### **Bottom View**

Use a USB Type-C® adapter to connect your Chromebook to an external display. Insert the bundled power adapter into this port to charge the battery pack and supply power to your Chromebook.



The Kensington® security slot allows you to secure your Chromebook using Kensington® compatible Chromebook security products.

#### **Left View**



#### USB 3.2 Gen 1 Type-C<sup>®</sup>/DisplayPort/ Power (DC) input combo port

The USB 3.2 (Universal Serial Bus 3.2) Gen 1 Type-C® port provides a transfer rate of up to 5 Gbit/s and is backward compatible to USB 2.0. Use a USB Type-C® adapter to connect your Chromebook to an external display. Insert the bundled power adapter into this port to charge the battery pack and supply power to your Chromebook.

**NOTE:** Transfer rate of this port may vary per model.

**WARNING!** The adapter may become warm to hot while in use. Do not cover the adapter and keep it away from your body while it is connected to a power source.

**IMPORTANT!** It may take longer to fully charge your Chromebook through a low-voltage power source. Use only the bundled power adapter to charge the battery pack and supply power to your Chromebook.

#### 2 Two-color battery charge indicator

The two-color LED provides a visual indication of the battery's charge status. Refer to the following table for details:

| Color        | Status   |
|--------------|--|
| Solid White  | The Chromebook is plugged to a power source and the battery power is between 95% and 100%.                 |
| Solid Orange | The Chromebook is plugged to a power source, charging its battery, and the battery power is less than 95%. |
| Solid White  | The Chromebook is running on battery mode.   |

#### MicroSD card slot (on selected models)

This built-in memory card reader slot supports microSD card formats.

Headphone/Headset jack

This port allows you to connect amplified speakers or headphones. You can also use this port to connect your headset.

**NOTE:** This port does not support three-conductor 3.5 mm microphones.

USB 3.2 Gen 1 port

The USB 3.2 (Universal Serial Bus 3.2) Gen 1 port provides a transfer rate of up to 5 Gbit/s and is backward compatible to USB 2.0.

## Chapter 2: Using your Chromebook

#### **Getting started**

#### **Charge your Chromebook**


- Connect the DC power connector into your Chromebook's power (DC) input port.
- B. Plug the AC power adapter into a 100V~240V power source.



Charge the Chromebook for **3 hours** before using it in battery mode for the first time.

**IMPORTANT!** Carefully plug in and pull out the USB connector horizontally to avoid damage to the USB port. Using excessive force or not inserting the USB connector horizontally may cause damage and affect your warranty.

**NOTE:** The power adapter may vary in appearance, depending on models and your region.



#### IMPORTANT!

#### Power adapter information:

Input voltage: 100-240Vac

Input frequency: 50-60Hz

Rating output current: 3A (45W)

• Rating output voltage: 15V

#### IMPORTANT!


- Locate the input/output rating label on your Chromebook and ensure that it matches the input/output rating information on your power adapter. Some Chromebook models may have multiple rating output currents based on the available SKU.
- Ensure that your Chromebook is connected to the power adapter before turning it on for the first time. Always plug the power cord into a wall socket without using any extension cords. For your safety, connect this device to a properly grounded electrical outlet only.
- The socket outlet must be easily accessible and near your Chromebook
- To disconnect your Chromebook from its main power supply, unplug your Chromebook from the power socket.

#### WARNING!

Read the following precautions for your Chromebook's battery:

- Only ASUS-authorized technicians should remove the battery inside the device (for non-removable battery only).
- The battery used in this device may present a risk of fire or chemical burn if removed or disassembled.
- · Follow the warning labels for your personal safety.
- · Risk of explosion if battery is replaced by an incorrect type.
- Do not dispose of in fire.
- Never attempt to short-circuit your Chromebook's battery.
- Never attempt to disassemble and reassemble the battery (for non-removable battery only).

### Lift to open the display panel or press the power button to turn on your Chromebook



**NOTE:** Before turning on your Chromebook for the first time, ensure the DC power adapter is connected and the Two-color battery charge indicator lights up.

#### Using the touchpad

#### Moving the pointer

You can tap anywhere on the touchpad to activate its pointer, then slide your finger on the touchpad to move the pointer onscreen.


#### Slide horizontally



#### Slide vertically




#### Slide diagonally



#### **One-finger gestures**

#### Tap/Double-tap



- Tap an app to select it.
- Double-tap an app to launch it.
- Double-tap on an active screen to minimize or maximize it on your display panel.


#### Drag and drop



Tap on an active screen then slide the same finger without lifting it off the touchpad. To drop the screen to its new location, lift your finger from the touchpad.

#### **Two-finger gestures**

#### Тар



Tap two fingers on the touchpad to simulate the right-click function.

Two-finger scroll (up/down)



Slide two fingers to scroll up or down.

Two-finger scroll (left/right)



Slide two fingers to scroll left or right.

#### Drag and drop



Select an item then press and hold the touchpad. Using your other finger, slide on the touchpad to drag the item, lift your finger off the button to drop the item.

#### **Three-finger gestures**

#### Swipe left/Swipe right



If you opened multiple tabs on your web browser, swipe three fingers left or right to switch between these tabs.

#### Swipe up



Swipe up to see an overview of all the screens currently opened on Chromebook.

# Using the keyboard

The following shortcut keys on your Chromebook's keyboard can be used to launch programs and functions while using your Chromebook.

# **Turning your Chromebook off**

You can turn off your Chromebook by doing either of the following procedures:

### **Using Chromebook**

- 1. Launch the status area.
- 2. Click/Tap 😃 .

## Using the power button on your Chromebook

You can also use this option to turn off your Chromebook in case it becomes unresponsive.

**IMPORTANT!** Save your files before performing this option to prevent loss of important data.

To do this, press the power button on your Chromebook for at least four (4) seconds until your Chromebook turns off.

# Tips and FAQs

## **Useful tips for your Chromebook**

To help you maximize the use of your Chromebook, maintain its system performance, and ensure all your data are kept secured, here are some useful tips that you can follow:

- Use an anti-virus software to protect your data and keep this updated too.
- Unless absolutely necessary, refrain from using force shutdown to turn off your Chromebook.
- Always backup your data and make it a point to create a backup data in an external storage drive.
- If you are not using your Chromebook for a long period of time, ensure to charge the battery power to 50% then power off your Chromebook and disconnect the AC power adapter.
- Refrain from using the Chromebook at extremely high temperatures. If you are not going to use your Chromebook for a long period of time (at least a month), we recommend that you take out the battery if the battery is removable.
- Disconnect all external devices and ensure you have the following items prior to resetting your Chromebook:
  - Backup data
  - Log in ID and password
  - Internet connection information

# **Hardware FAQs**

 A black dot, or sometimes a colored dot, appears onscreen when I turn on the Chromebook. What should I do?

Although these dots normally appear onscreen, they will not affect your system. If the incident continues and subsequently affects system performance, consult an authorized ASUS service center.

2. My display panel has an uneven color and brightness. How can I fix this?

The color and brightness of your display panel may be affected by the angle and current position of your Chromebook. The brightness and color tone of your Chromebook may also vary per model. You may use the function keys or the display settings in your operating system to adjust the appearance of your display panel.

3. How can I maximize my Chromebook's battery life?

You can try doing any of the following suggestions:

- Use the function keys to adjust the display brightness.
- Disconnect unused USB devices.
- Close unused applications, especially those that take up too much system memory.

#### 4. My battery charge indicator does not light up. What's wrong?

- Check whether the power adapter or battery pack is attached correctly. You may also disconnect the power adapter or battery pack, wait for a minute, then reconnect them again to the power outlet and Chromebook.
- If the problem still exists, contact your local ASUS service center for assistance.

# 5. When I play audio and video files, why can't I hear any sound from my Chromebook's audio speakers?

You can try doing any of the following suggestions:

- Press to turn up the speaker volume.
- Check if your speakers were set to mute.
- Check if a headphone jack is connected to your Chromebook and remove it.

#### 6. What should I do if my Chromebook's power adapter gets lost or my battery stops working?

Contact your local ASUS service center for assistance.

# 7. My Chromebook cannot do keystrokes correctly because my cursor keeps on moving. What should I do?

Make sure that nothing accidentally touches or presses on your touchpad while you type on the keyboard.

Chromebooks use apps from the Google Play Store and on the web. There are apps to be productive, get creative, enjoy movies and shows, play games and more.

#### 2. How do I get more apps?

You can get more apps from the Google Play Store or the web.

#### 3. Can Luse Microsoft Office software?

Chromebooks work with Microsoft® Office. Whether it's Word, Excel® or PowerPoint®, you can easily find the apps on the web.

#### 4. Where can I find my files?

All your files are stored in the Files app . Find the app by clicking the Launcher icon and searching "Files".

#### 5. How do I transfer my local files?

Transfer your local files using a compatible storage device. Your Chromebook works with most external storage devices (e.g.: USB thumb drives, removable hard drives).

You can also upload your files, photos, and videos to Google Drive. After setting up your Chromebook with your Google Account, you'll be able to access your files on Drive.

# 6. Why does my Chromebook need my Google Account information?

You'll use your Google Account to sign in to your Chromebook. It is the same account you use for Google services such as Gmail and Drive. Your Chromebook uses your account information to automatically sign you into apps and services.

#### 7. How do I set this up for my child?

If you want to set up parental controls for your child, it's important that you sign in using your child's personal Google Account. If they don't already have one, you can create one during the signin process on your Chromebook. You will be able to add your child's school account after you complete device onboarding.

# **Appendices**

### **Internal Modem Compliancy**

The Chromebook with internal modem model complies with JATE (Japan), FCC (US, Canada, Korea, Taiwan), and CTR21. The internal modem has been approved in accordance with Council Decision 98/482/EC for pan-European single terminal connection to the public switched telephone network (PSTN). However due to differences between the individual PSTNs provided in different countries, the approval does not, of itself, give an unconditional assurance of successful operation on every PSTN network termination point. In the event of problems you should contact your equipment supplier in the first instance.

#### **Overview**

On 4th August 1998 the European Council Decision regarding the CTR 21 has been published in the Official Journal of the EC. The CTR 21 applies to all non voice terminal equipment with DTMF-dialling which is intended to be connected to the analogue PSTN (Public Switched Telephone Network).

CTR 21 (Common Technical Regulation) for the attachment requirements for connection to the analogue public switched telephone networks of terminal equipment (excluding terminal equipment supporting the voice telephony justified case service) in which network addressing, if provided, is by means of dual tone multi-frequency signalling.
