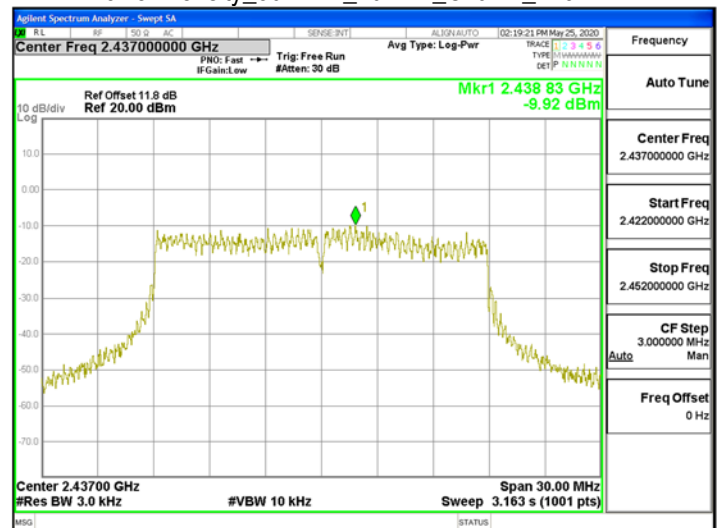
Power Density 802.11n 20MHz Chain1 2412MHz



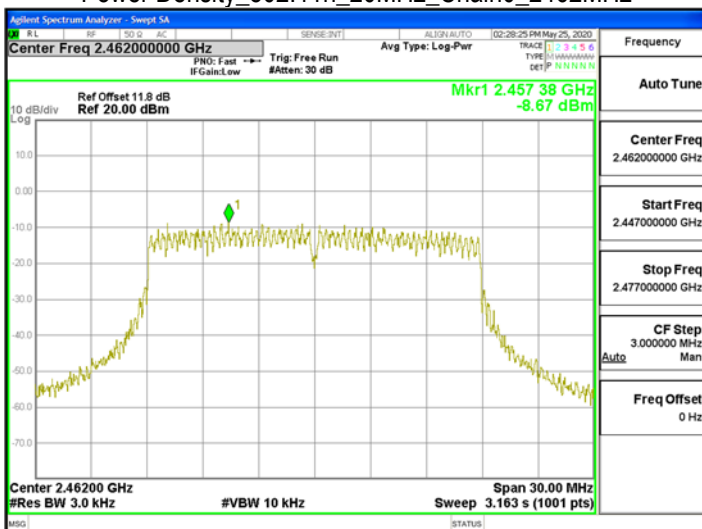

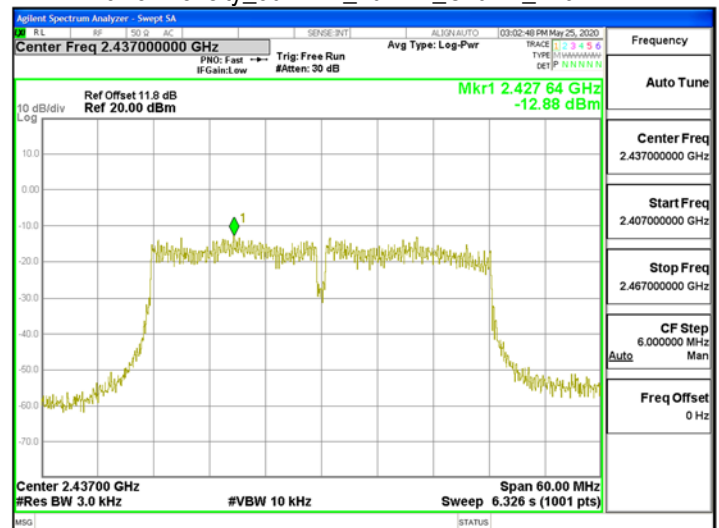
Power Density 802.11n 40MHz Chain1 2422MHz



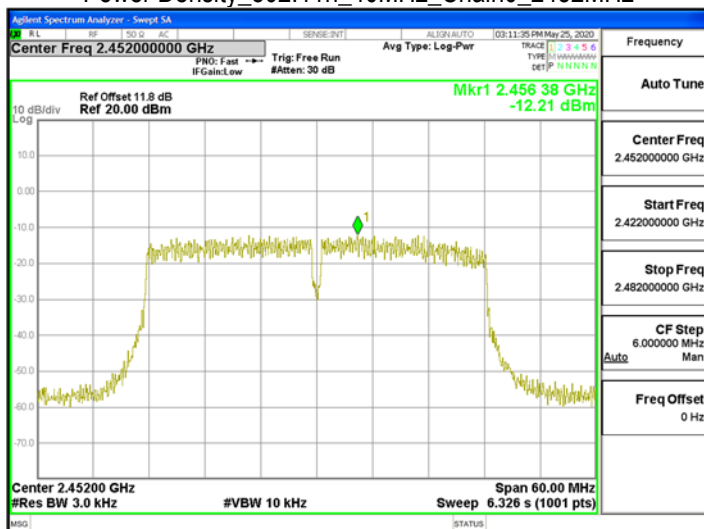

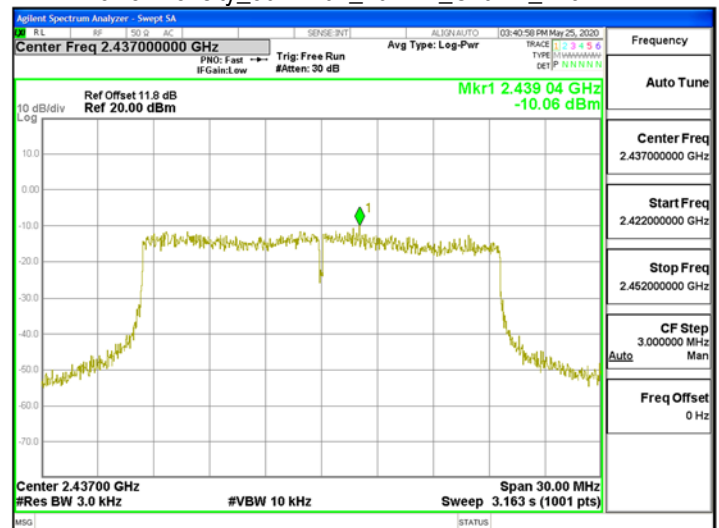
Power Density 802.11ax 20MHz Chain1 2412MHz



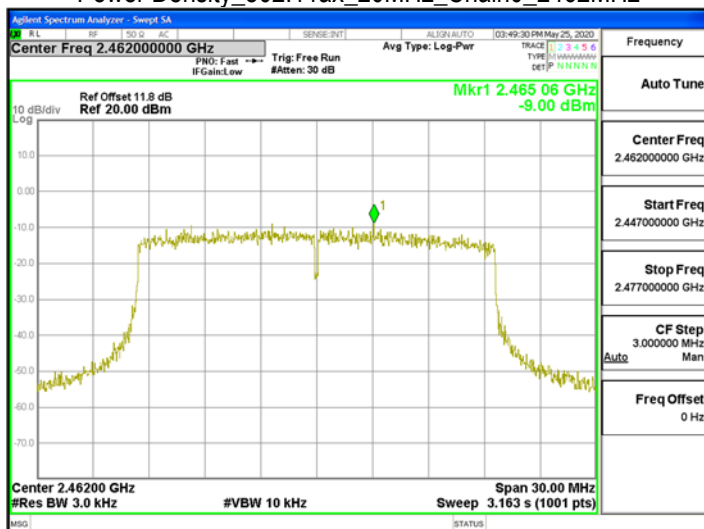

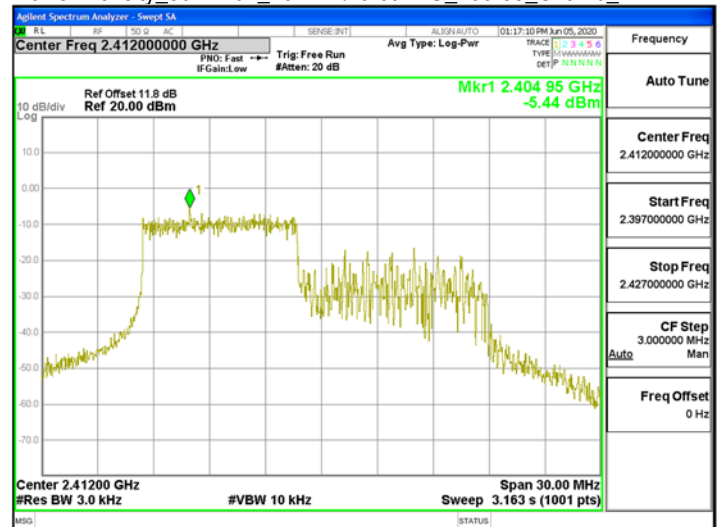
Power Density 802.11ax 20MHz\Partial RU 52-37 Chain1 2412MHz



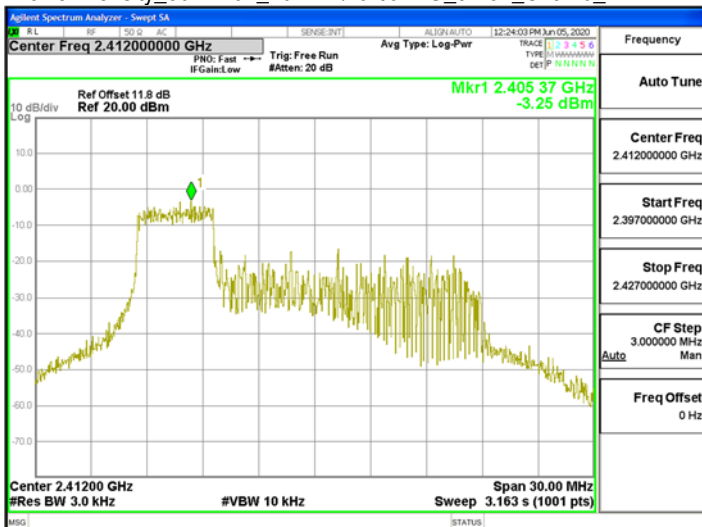

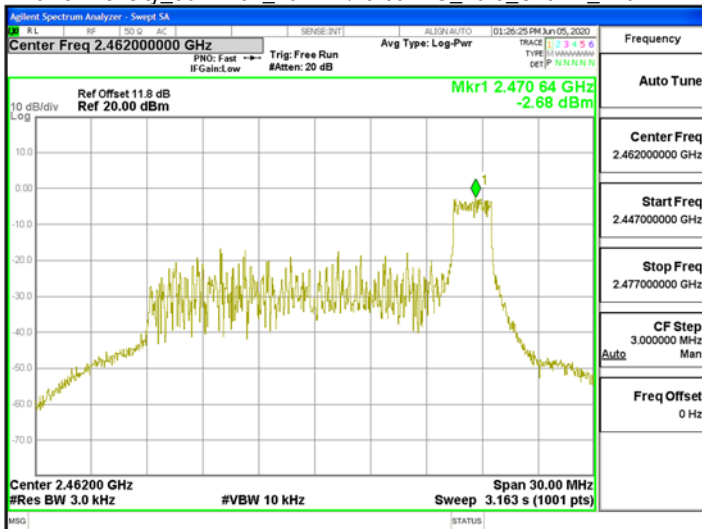
Power Density 802.11ax 20MHz\Partial RU 26-8 Chain0 2462MHz



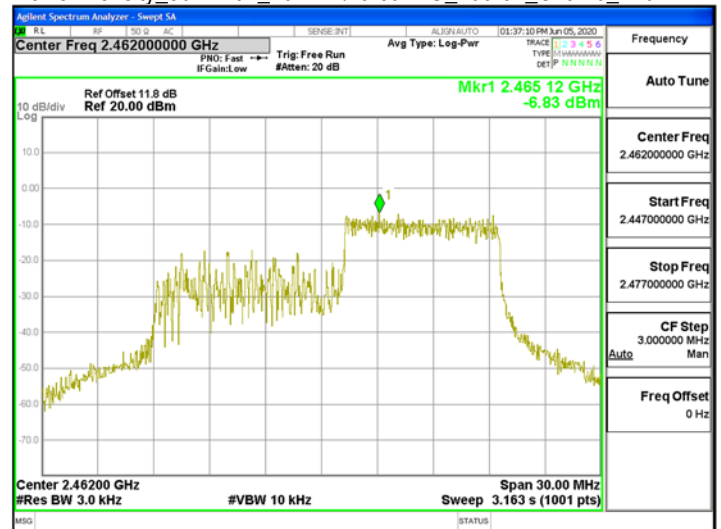
Power Density 802.11ax 20MHz\Partial RU 52-40 Chain1 2462MHz



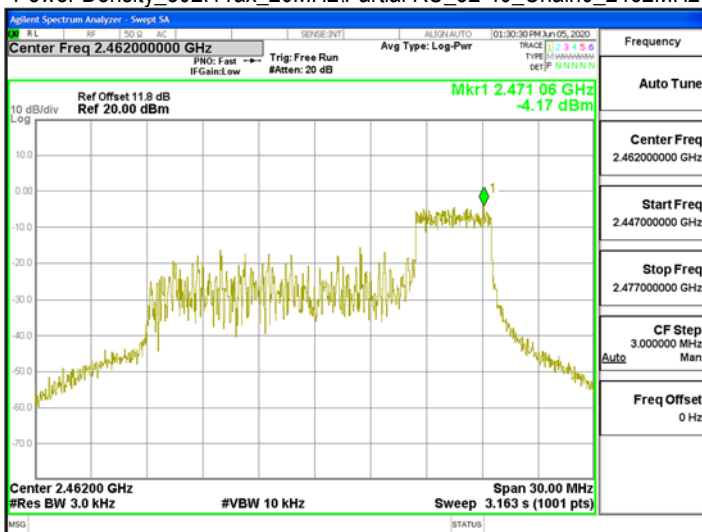

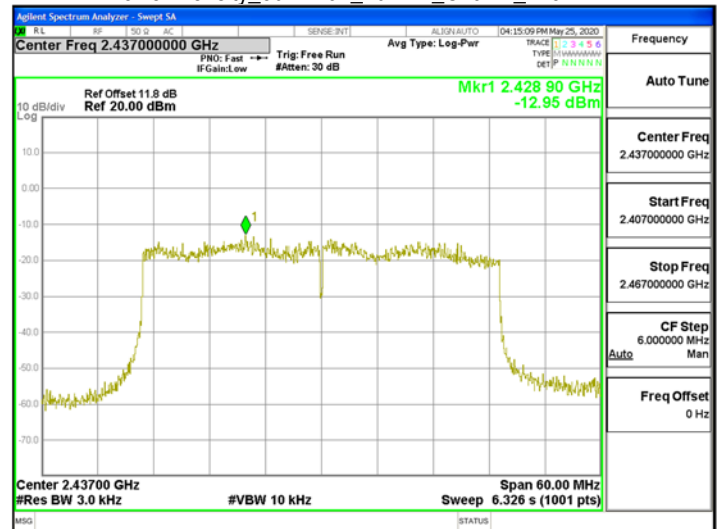
Power Density 802.11ax 40MHz Chain1 2422MHz



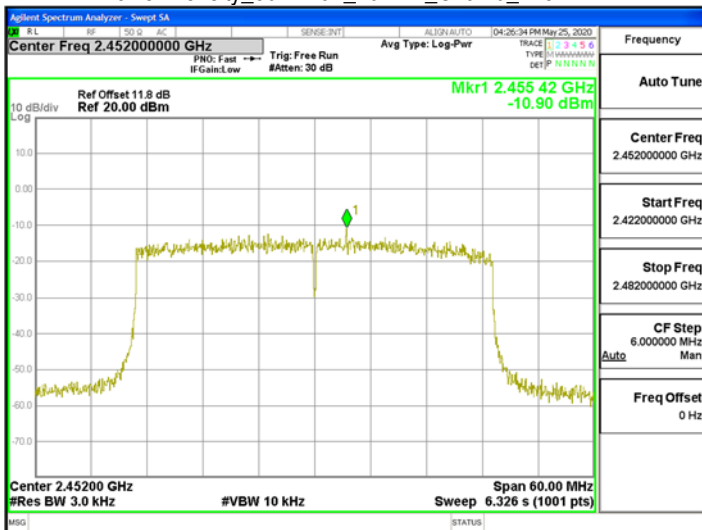
