Fig.1 Photograph of the SAR measurement system








Photograph 3. Head, Right Tilt, 0mm














Photograph 29. Product specific 10-g SAR, Top Edge, 0mm


Photograph 31. Product specific 10-g SAR, Bottom Edge, 0mm






Photograph 35. Product specific 10-g SAR, Left Edge, 0mm






