


**Exhibit 1: FCC ID Label**Equipment Identification Label

In accordance with the requirements of Sections 15.19 (a)(3), 15.311, 2.925 and 2.926 of the FCC Rules, the following information will be permanently affixed to the CTP Systems Ltd. Model Mini Base. There are three different part numbers for the Mini Base, one for the four antenna unit(PN: BSN00200) one for the five antenna unit(PN: BSN00202) and one for the outdoor unit (PN: BSN00240), all three units are covered under the same FCC ID number.
