SEAI/O W-SERIES

SealO WiFi Bridge adds 802.11b/g/n communication interface to Seal/O™ product family. It is an add-on daughter card that can be factory-installed in any Seal/O™ module. It utilizes a single proprietary header for power and data transfer. WiFi option is indicated by “W” suffix in the Seal/O™ module model name.

200W –WIRELESS GATEWAY

The 200W Wireless Gateway is a standalone Wi-Fi to RS-485 Modbus RTU converter. It contains SealO WiFi Bridge installed on a custom carrier in a metal enclosure. After configuration on a local network, the gateway enables the functionality of wireless modules to the serial or USB modules when the gateway is connected to the expansion port of Seal/O™ module.

SEAI/O WIRELESS SPECIFICATIONS

406 WiFi Bridge features networking engine based on TI’s popular CC3200MODB module. This subsystem integrates an ARM Cortex-M4 MCU with an 802.11 b/g/n radio, baseband, MAC, and a powerful crypto engine for fast, secure Internet connections with 256-bit encryption. It supports Infrastructure and access point modes and supports WPA2 personal and enterprise security and WPS 2.0. The engine includes embedded TCP/IP and TLS/SSL stacks, HTTP server, and multiple Internet protocols.

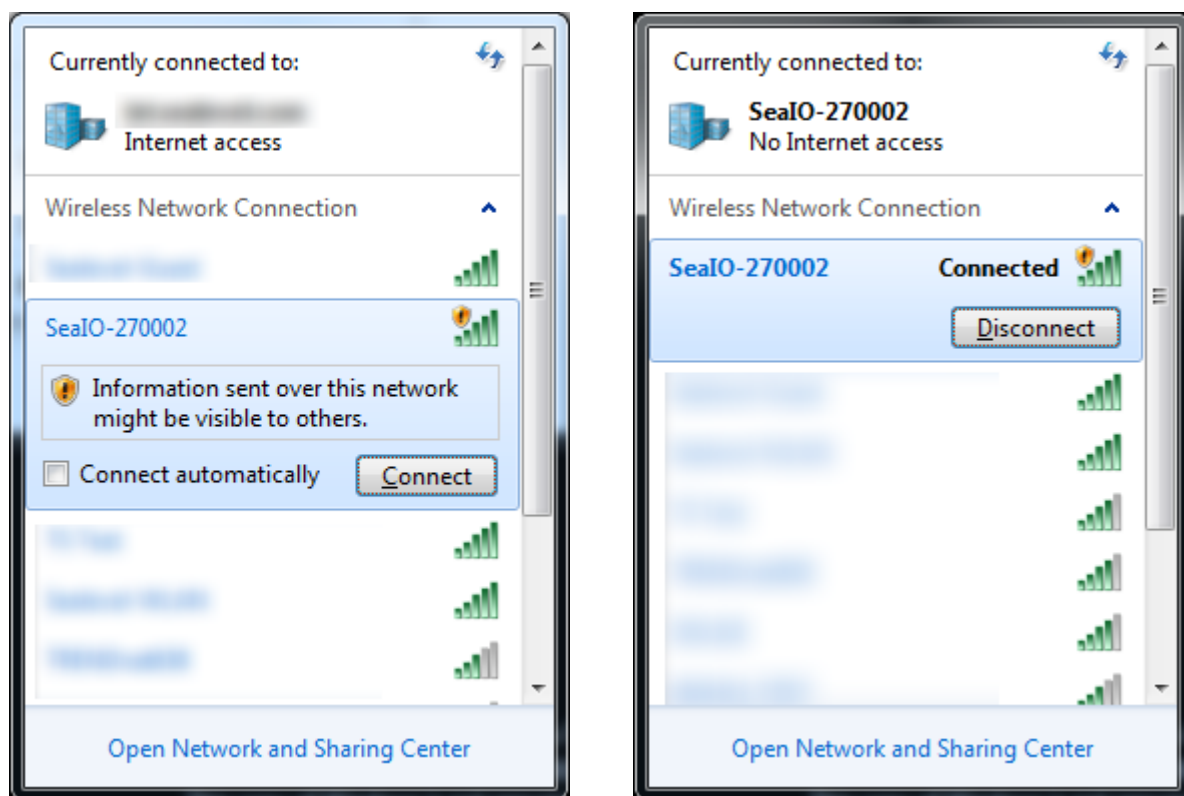
ANTENNA CONSIDERATIONS

The wireless device ships with an approved external hinged Wi-Fi antenna. Using a different antenna is not supported and it may invalidate regulatory certification and the user's authority to operate the equipment.

DEVICE SETUP (WINDOWS 7/8.1/10™)

AP MODE

Each WiFi enabled Seal/O™ device leaves the factory configured for connection in AP (Access Point) Mode. By default SSID is set to match the device name (SealO-270002 in the picture below) with no security. Select the device from available "Wireless Networks Connection" list and click "Connect" button.



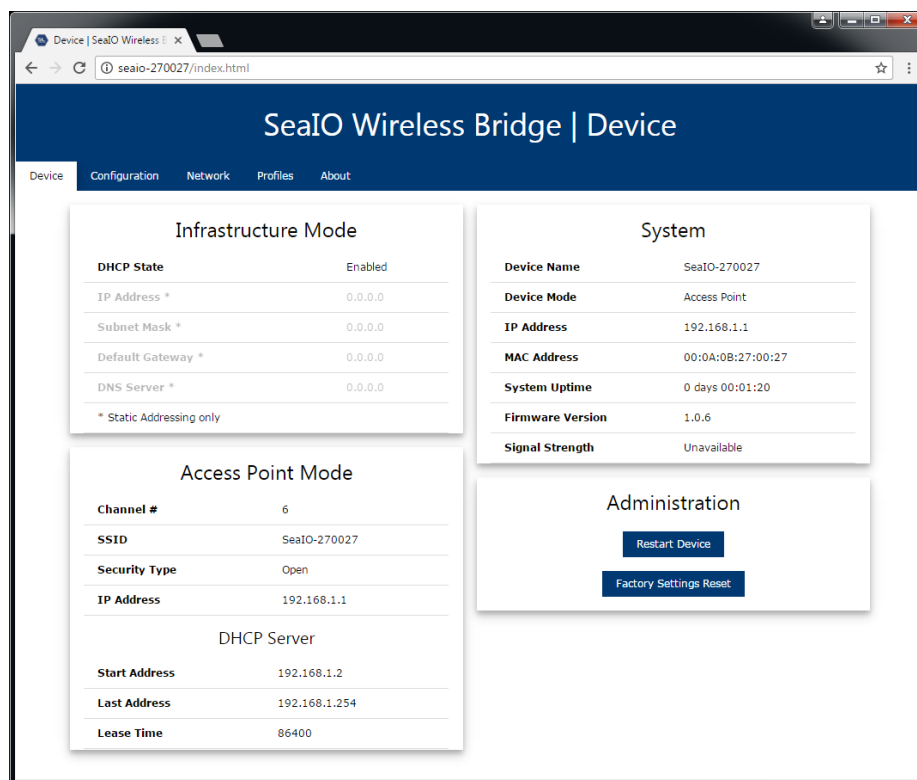
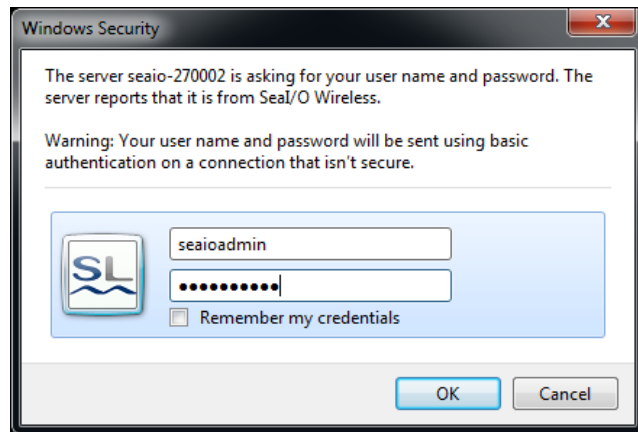
Once connected open web browser and enter <http://SeaIO-27xxxx> (replace xxxx with corresponding portion of your actual device name) in the address field to access the device status/configuration page. Enter administrator login credentials when prompted.

Default User Name: seaioadmin
Default Password: seaioadmin

It is strongly recommended to change the login credentials to prevent unauthorized access.

DEVICE TAB

The Device tab displays current configuration, as well as offers a path to firmware update over the WiFi connection. User can restart the device or reload factory defaults via buttons in Administration pane.



CONFIGURATION TAB

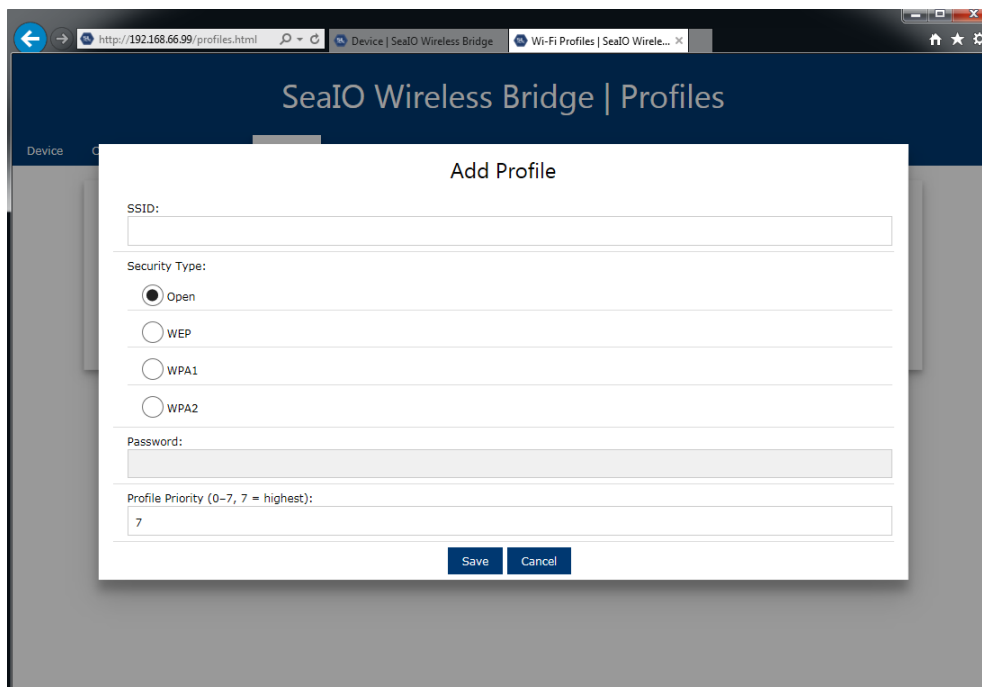
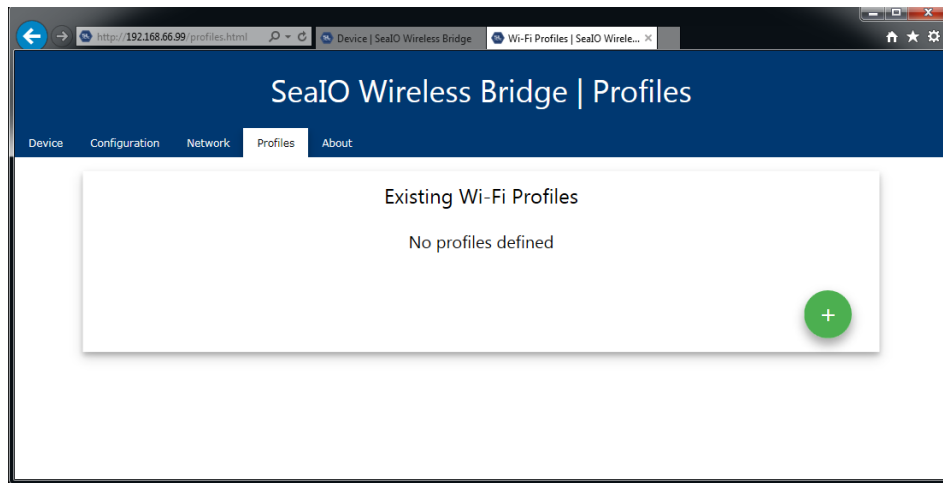
In the Configuration tab you can customize the device name if desired. If changed the new device name must be used to access the configuration pages. Administrator credentials can be modified in HTTP Authentication pane. Reset or power cycle is necessary for any changes to take effect.

NETWORK TAB

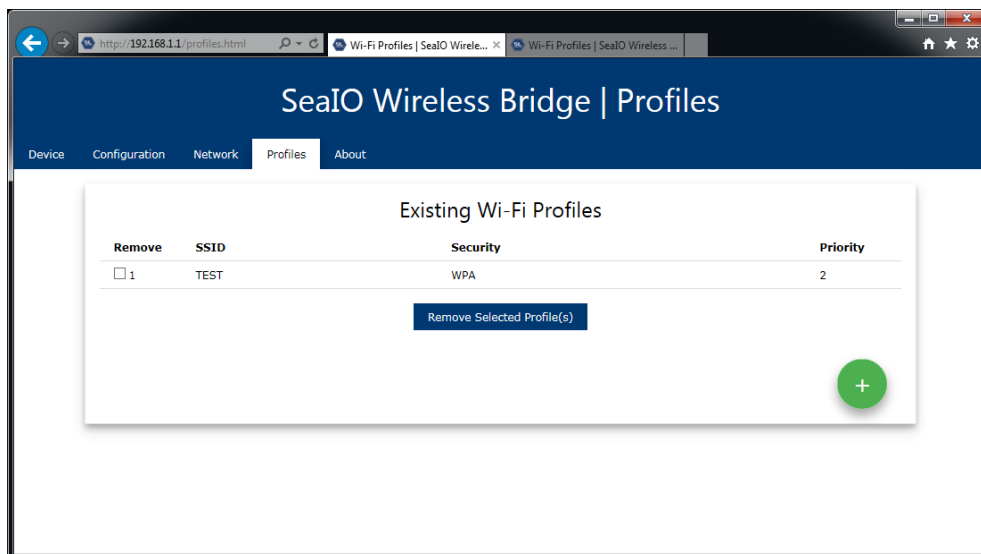
The Network tab is used to customize connection parameters for Infrastructure Mode and AP Mode. Reset or power cycle is necessary for any changes to take effect.

PROFILES TAB

In the Profiles you can configure typical connection parameters specific to your wireless network (SSID, security type, password). Multiple profiles are available. They can be prioritized via Profile Priority setting. Reset or power cycle is necessary for any changes to take effect.



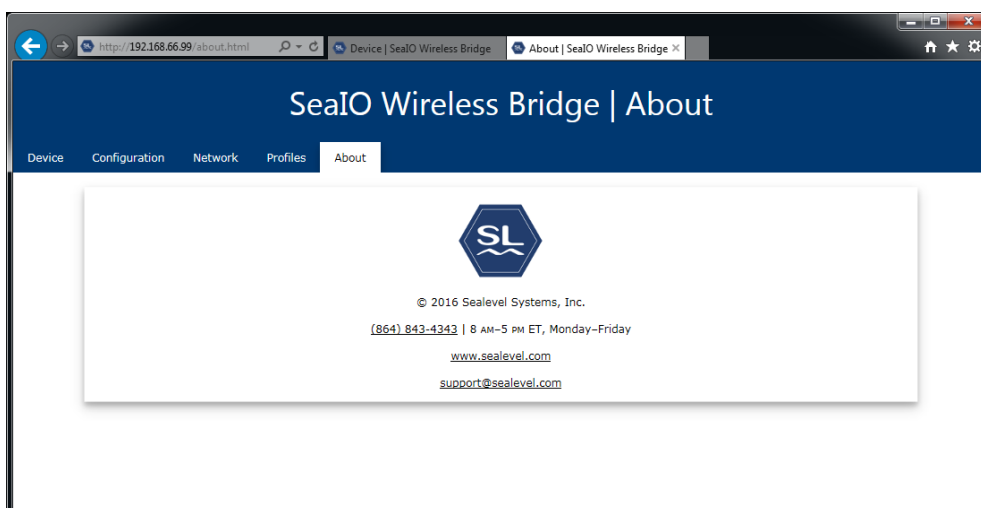
Existing profiles cannot be edited. They can only be deleted. If changes are required a new profile has to be created and configured.



Once the connection profile is defined the device will make an attempt to establish infrastructure type connection based on priority level. If there are no profiles that match the actual infrastructure settings the device will no longer be accessible. See Forced AP mode to regain access to the device.

ABOUT TAB

The About tab shows “Sealevel Systems” contact and support information.



FORCE AP MODE

The device can be forced to reconnect in AP mode in case communication cannot be established in Infrastructure mode. Power down the device. Locate the Reset/Configure button on the front of the module just above the antenna. Using a paperclip or similar sized blunt object, depress and hold the button then power on the device. Wait about 3 seconds and release the button. The device is now in AP mode with settings as previously configured.

RESTORE FACTORY DEFAULTS

To reset the device to factory defaults locate the Reset/Configure button on the front of the module just above the antenna. Using a paperclip or similar sized blunt object, depress and hold the button for at least 10 seconds. The device has been reset. All the configuration settings have been reverted to their default values. The device is in AP mode ready to be configured.
