


#### 4.5.3 TEST PROCEDURE

The transmitter output was connected to the spectrum analyzer through an attenuator, the bandwidth of the fundamental frequency was measured with the spectrum analyzer using 3 kHz RBW and 30 kHz VBW, set sweep time=span/3kHz. The power spectral density was measured and recorded.

The sweep time is allowed to be longer than span/3KHz for a full response of the mixer in the spectrum analyzer.

The software provided by client enabled the EUT to transmit and receive data at lowest, middle and highest channel frequencies individually.









#### 4.6.3 TEST PROCEDURE

The transmitter output was connected to the spectrum analyzer via a low lose cable. Set both RBW and VBW of spectrum analyzer to 100 kHz with suitable frequency span including 100 kHz bandwidth from band edge. The band edges was measured and recorded.



#### 4.6.4 EUT OPERATING CONDITION

The software provided by client enabled the EUT to transmit and receive data at lowest, middle and highest channel frequencies individually.

#### 4.6.5 TEST RESULTS


The spectrum plots are attached below. D2 line indicates the highest level, D1 line indicates the 20dB offset below D2. It shows compliance with the requirement in part 15.247(C).




#### 4.6.6 NOTE ON BAND EDGE EMISSION

The band edge emission plot on page 43 shows 46.36dB delta between carrier maximum power and local maximum emission in restrict band (2.4834GHz). The emission of carrier strength list in table of page 24 is 97.5dB  $\mu$  V/m, so the maximum field strength in restrict band is 97.5-46.36=51.54 dB  $\mu$  V/m which is under 54 dB  $\mu$  V/m limit.











#### 4.7 ANTENNA REQUIREMENT

#### 4.7.1 STANDARD APPLICABLE

For intentional device, according to FCC 47 CFR Section 15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device.

And according to FCC 47 CFR Section 15.247 (b), if transmitting antennas of directional gain greater than 6 dBi are used, the power shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6 dBi.

#### 4.7.2 ANTENNA CONNECTED CONSTRUCTION

The antenna used in this product is Dual monopole antenna. The internal connector used inside the product is MMCX. And the maximum Gain of this antenna is only 1.5dBi.
