### Product Description for Equipment Under Test (EUT)

The *DOPPIO MOBILE INTERNATIONAL LIMITED*'s product, model number: *SG401 (FCC ID: N2GSG401)* (the "EUT") in this report was a *Doppio Rubi*, which was measured approximately: 12.6 cm (L) x 6.4 cm (W) x 1.0 cm (H), rated input voltage: DC3.8V rechargeable Li-ion battery or DC5.0V charging from adapter. The highest operating frequency is 1.2 GHz.

### Objective

This test report is prepared on behalf of *DOPPIO MOBILE INTERNATIONAL LIMITED*. in accordance with Part 2, Subpart J, and Part 15-Subparts A and B of the Federal Communications Commission's rules.

### Test Methodology

All measurements contained in this report were conducted with ANSI C63.4-2014, American National Standard for Methods of Measurement of Radio-Noise Emissions from Low-Voltage Electrical and Electronic Equipment in the range of 9 kHz to 40 GHz.

All radiated and conducted emissions measurement was performed at Bay Area Compliance Laboratories Corp. (Dongguan).

### **Test Facility**

The Test site used by Bay Area Compliance Laboratories Corp. (Dongguan) to collect test data is located on the No.69 Pulongcun, Puxinhu Industrial Zone, Tangxia, Dongguan, Guangdong, China

Test site at Bay Area Compliance Laboratories Corp. (Dongguan) has been fully described in reports submitted to the Federal Communications Commission (FCC). The details of these reports have been found to be in compliance with the requirements of Section 2.948 of the FCC Rules on February 06, 2015.

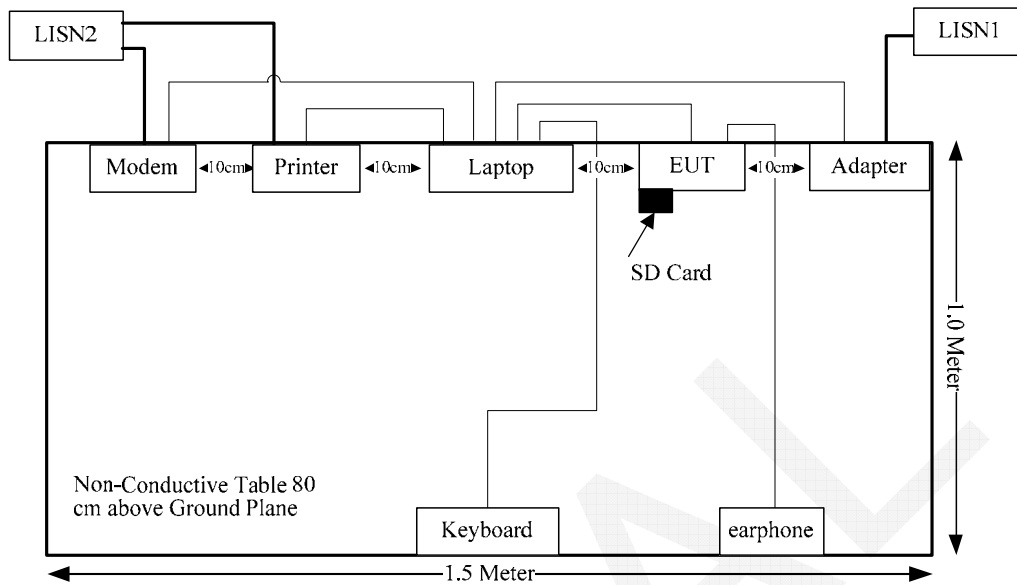

## FCC§15.107 - CONDUCTED EMISSIONS

### Measurement Uncertainty

All measurements involve certain levels of uncertainties, especially in field of EMC. The factors contributing to uncertainties are Receiver, cable loss, and LISN.

Compliance or non-compliance with a disturbance limit shall be determined in the following manner :

If  $U_{lab}$  is less than or equal to  $U_{cisp}$  of Table 1, then:

- compliance is deemed to occur if no measured disturbance level exceeds the disturbance limit;
- non-compliance is deemed to occur if any measured disturbance level exceeds the disturbance limit.

If  $U_{lab}$  is greater than  $U_{cisp}$  of Table 1, then:

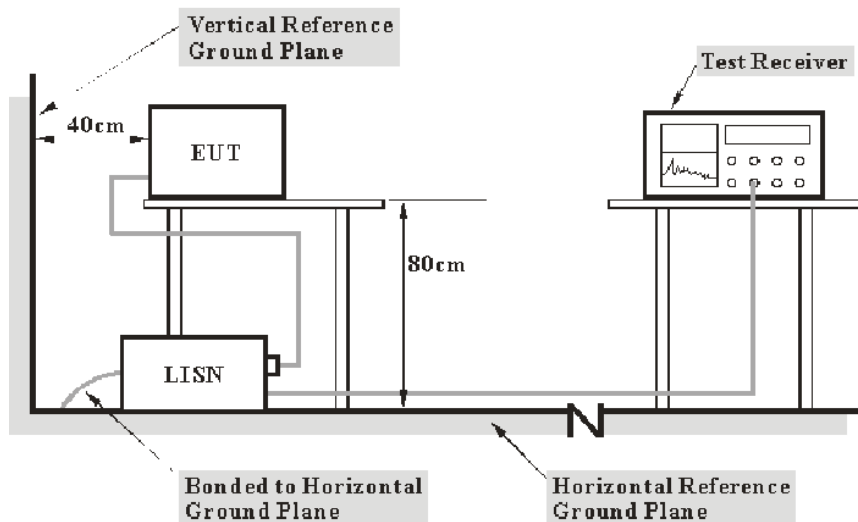
- compliance is deemed to occur if no measured disturbance level, increased by  $(U_{lab} - U_{cisp})$ , exceeds the disturbance limit;
- non-compliance is deemed to occur if any measured disturbance level, increased by  $(U_{lab} - U_{cisp})$ , exceeds the disturbance limit.

Based on CISPR 16-4-2: 2011, measurement uncertainty of conducted disturbance at mains port using AMN at Bay Area Compliance Laboratories Corp. (Dongguan) is 3.46 dB (150 kHz to 30 MHz).

### EUT Setup



- Note: 1. Support units were connected to second LISN.  
 2. Both of LISNs (AMN) 80 cm from EUT and at the least 80 cm from other units and other metal planes support units.



The setup of EUT is according with per ANSI C63.4-2014 measurement procedure. The specification used was with the FCC Part 15 B Class B limits.

The external I/O cables were draped along the test table and formed a bundle 30 to 40 cm long in the middle.

The adapter of laptop was connected to a 120V/60Hz AC power source.

### EMI Test Receiver Setup

The EMI test receiver was set to investigate the spectrum from 150 kHz to 30 MHz.

During the conducted emission test, the EMI test receiver was set with the following configurations:

### Test Procedure

During the conducted emission test, the adapter of laptop was connected to the outlet of the first LISN and the other support equipments were connected to the outlet of the second LISN.

Maximizing procedure was performed on the six (6) highest emissions of the EUT.

All data was recorded in the Quasi-peak and average detection mode.

### Corrected Amplitude & Margin Calculation

The basic equation is as follows:

$$V_C = V_R + A_C + VDF$$

Herein,

$V_C$ : corrected voltage amplitude

$V_R$ : reading voltage amplitude

$A_C$ : attenuation caused by cable loss

VDF: voltage division factor of AMN or ISN

The “**Margin**” column of the following data tables indicates the degree of compliance within the applicable limit. For example, a margin of 7dB means the emission is 7dB below the maximum limit. The equation for margin calculation is as follows:

$$\text{Margin} = \text{Limit} - \text{Corrected Amplitude}$$

### Test Results Summary

According to the recorded data in following table, the EUT complied with the FCC Part 15 B Class B, with the worst margin reading of:

**7.20 dB at 0.312220 MHz** in the **Line** conducted mode

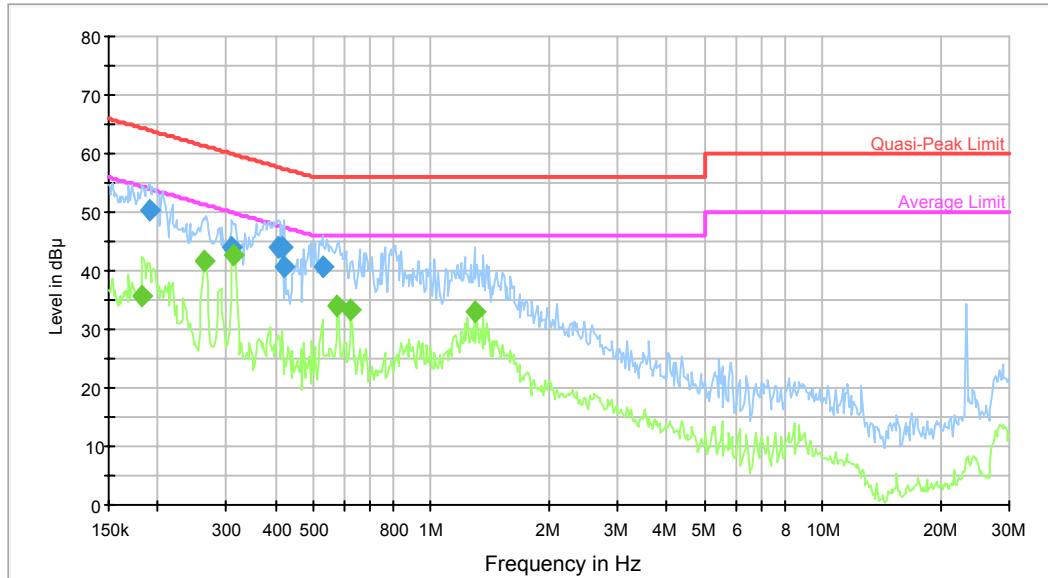

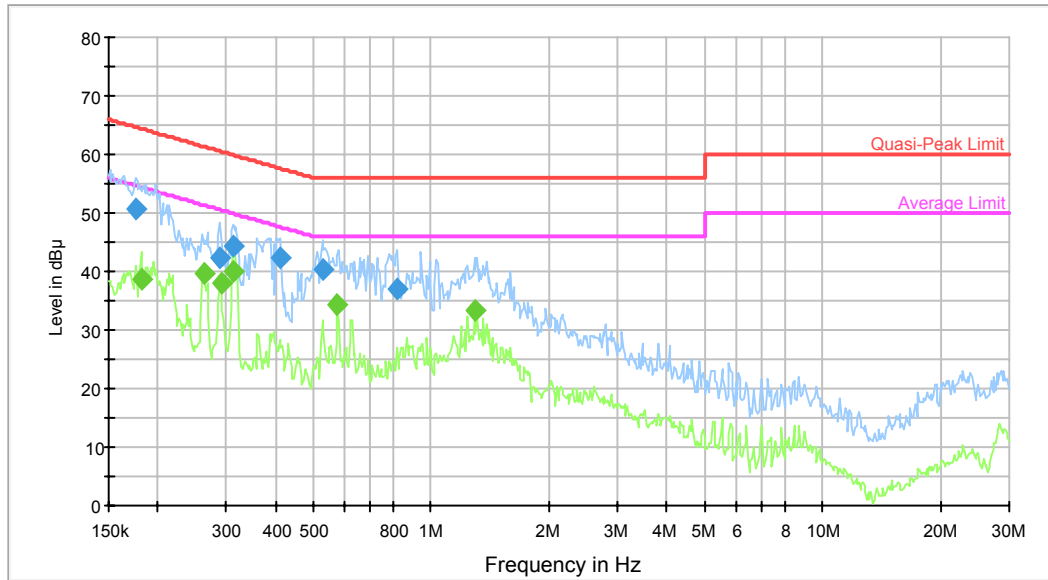

## FCC §15.109 - RADIATED SPURIOUS EMISSIONS

### Measurement Uncertainty

Compliance or non-compliance with a disturbance limit shall be determined in the following manner :

If  $U_{lab}$  is less than or equal to  $U_{cisp}$  of Table 1, then:

- compliance is deemed to occur if no measured disturbance level exceeds the disturbance limit;
- non-compliance is deemed to occur if any measured disturbance level exceeds the disturbance limit.

If  $U_{lab}$  is greater than  $U_{cisp}$  of Table 1, then:

- compliance is deemed to occur if no measured disturbance level, increased by  $(U_{lab} - U_{cisp})$ , exceeds the disturbance limit;
- non-compliance is deemed to occur if any measured disturbance level, increased by  $(U_{lab} - U_{cisp})$ , exceeds the disturbance limit.

Based on CISPR 16-4-2: 2011, measurement uncertainty of radiated emission at a distance of 3m at Bay Area Compliance Laboratories Corp. (Dongguan) is: 30MHz~200MHz: 5.0 dB; 200MHz~1GHz: 6.2 dB; 1GHz~6GHz: 4.45 dB, 6GHz~18GHz: 5.23 dB

The radiated emission tests were performed in the 3 meters chamber test site, using the setup accordance with the ANSI C63.4-2014. The specification used was the FCC Part 15.109 Class B limits.

The system was investigated from 30 MHz to 6 GHz.

### Test Procedure

Maximizing procedure was performed on the highest emissions to ensure that the EUT complied with all installation combinations.

The data was recorded in the Quasi-peak detection mode for below 1 GHz, peak and average detection mode above 1 GHz.

### Corrected Amplitude & Margin Calculation

The Corrected Amplitude is calculated by adding the Antenna Loss and Cable Loss, and subtracting the Amplifier Gain from the Meter Reading. The basic equation is as follows:

$$\text{Corrected Amplitude} = \text{Meter Reading} + \text{Antenna Loss} + \text{Cable Loss} - \text{Amplifier Gain}$$

The “**Margin**” column of the following data tables indicates the degree of compliance with the applicable limit. For example, a margin of 7 dB means the emission is 7 dB below the limit. The equation for margin calculation is as follows:

$$\text{Margin} = \text{Limit} - \text{Corrected Amplitude}$$

According to the data in the following table, the EUT complied with the FCC Part 15 B Class B, with the worst margin reading of:

**8.60 dB at 214.3000 MHz in the Horizontal polarization**
