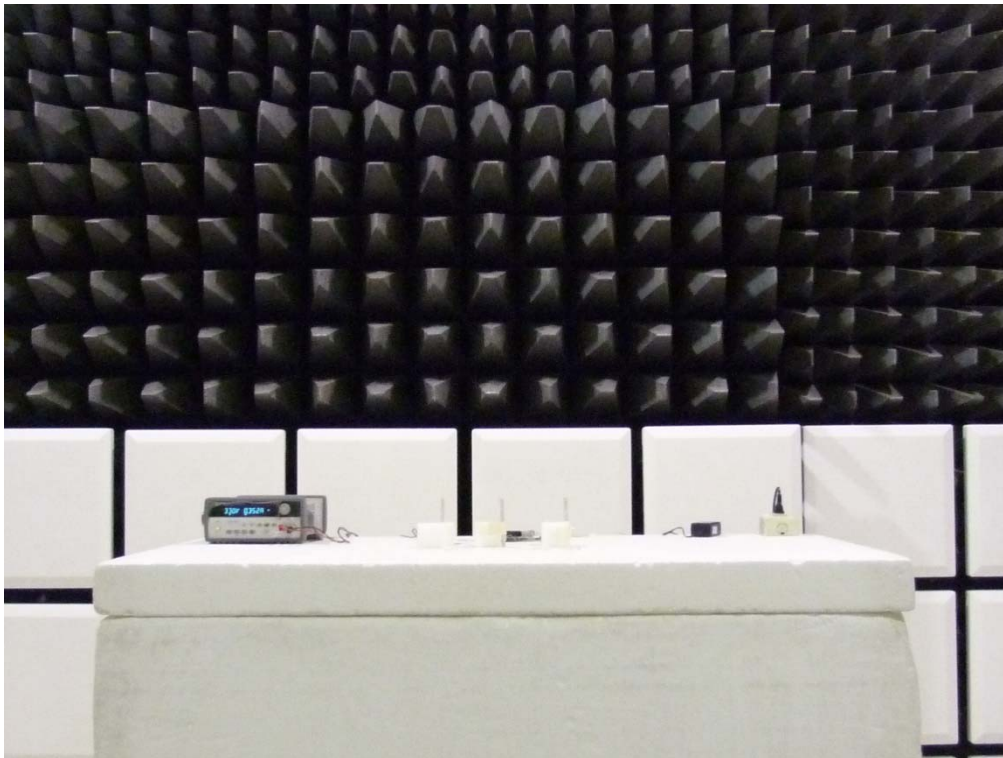

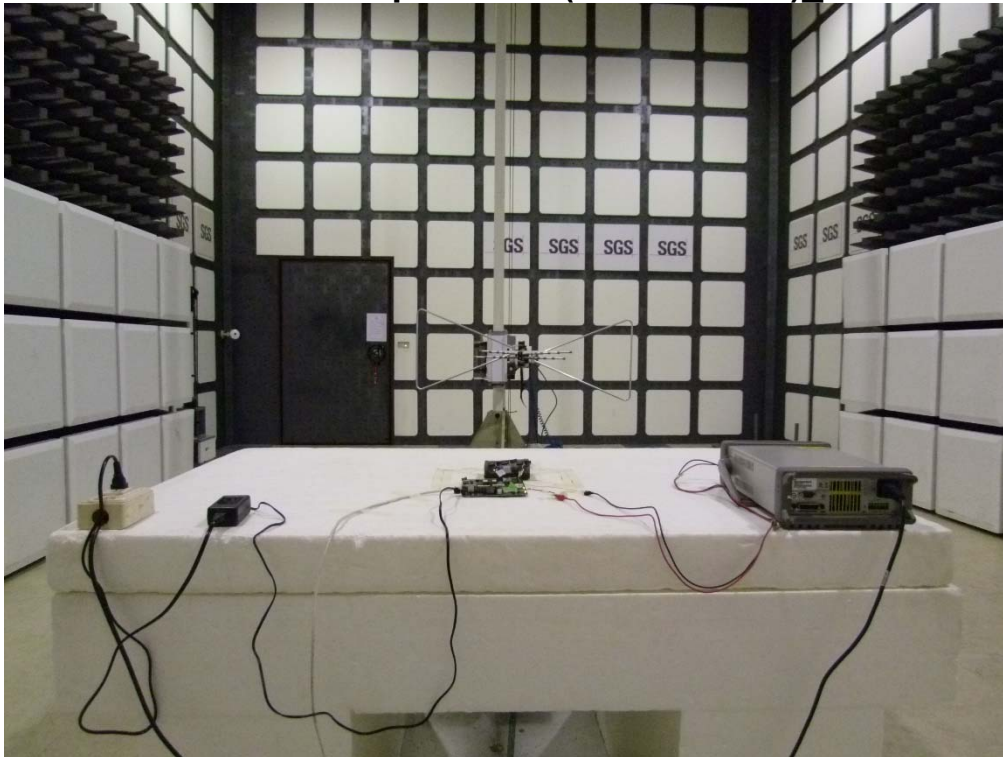

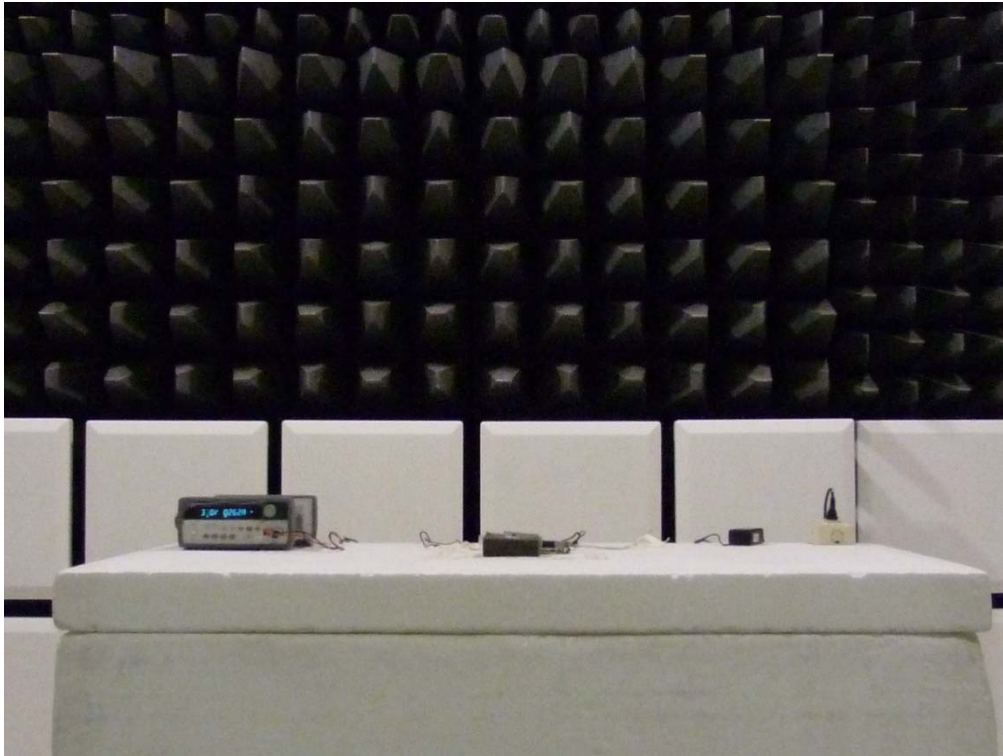

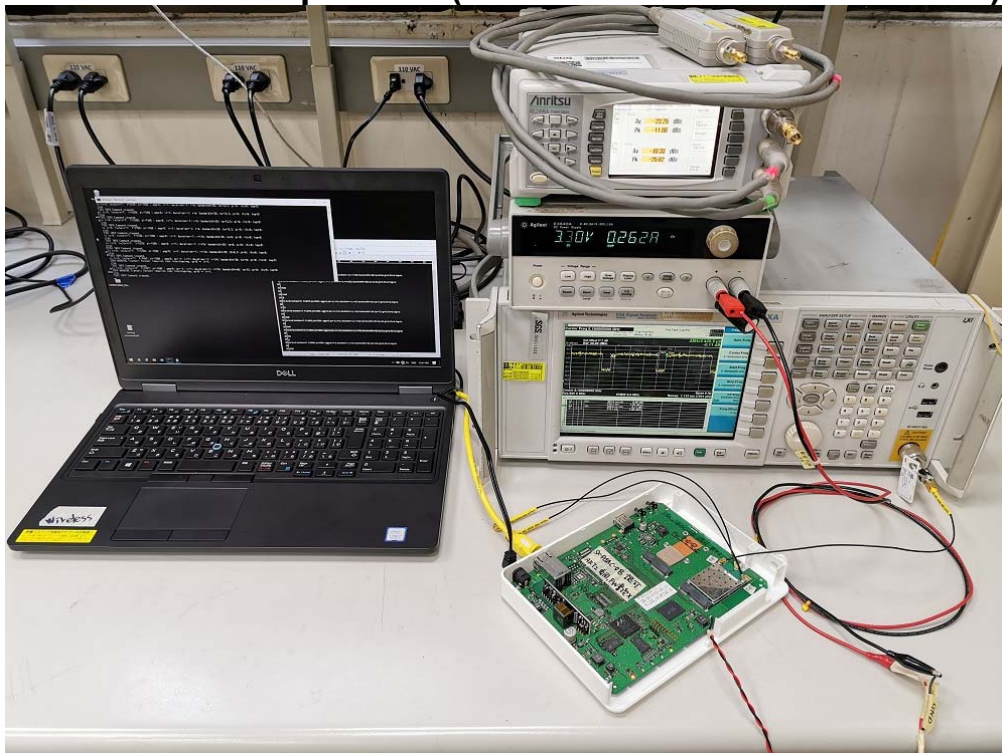
AC Power Line Conducted Emission Set up Photos_PCB Antenna
