### Objective

This type approval report is prepared on behalf of *HANGZHOU CENTURY CO., LTD* in accordance with Part 2-Subpart J, and Part 15-Subparts A and C of the Federal Communication Commission rules.

The tests were performed in order to determine Compliant with FCC Part 15, Subpart C, and section 15.203, 15.205, 15.207, 15.209 and 15.247 rules.

### Test Methodology

All measurements contained in this report were conducted with ANSI C63.10-2013, American National Standard of Procedures for Compliance Testing of Unlicensed Wireless Devices.

All radiated and conducted emissions measurement was performed at Bay Area Compliance Lab Corp. (Kunshan). The radiated testing was performed at an antenna-to-EUT distance of 3 meters.

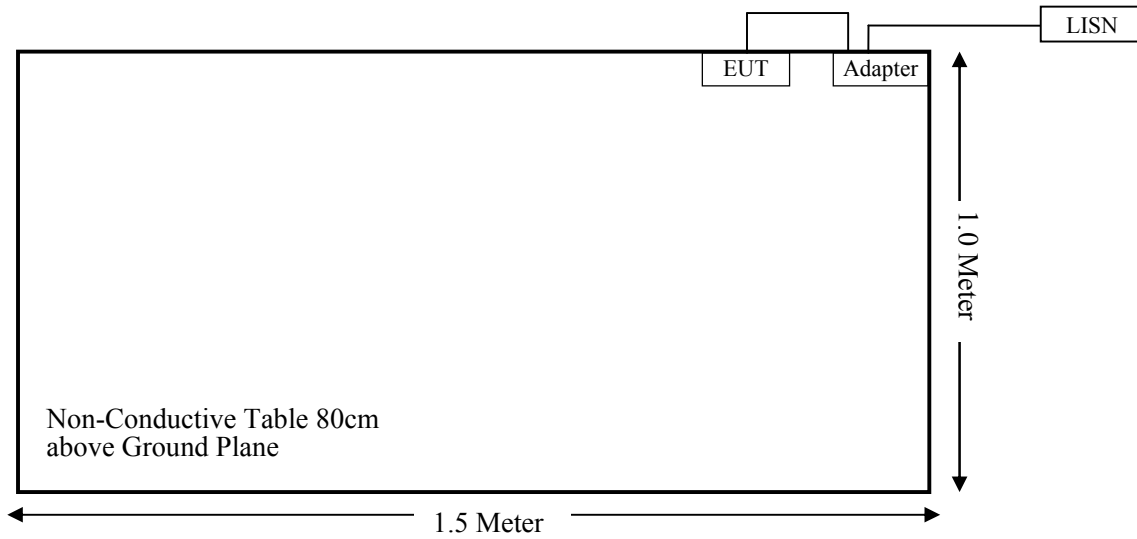

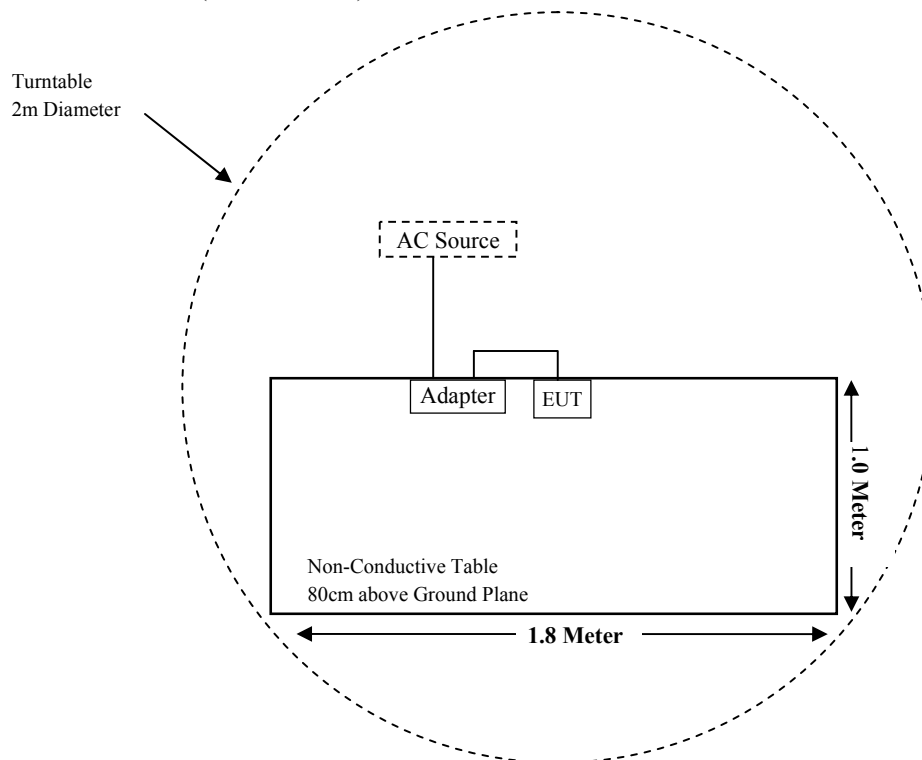

## Block Diagram of Test Setup

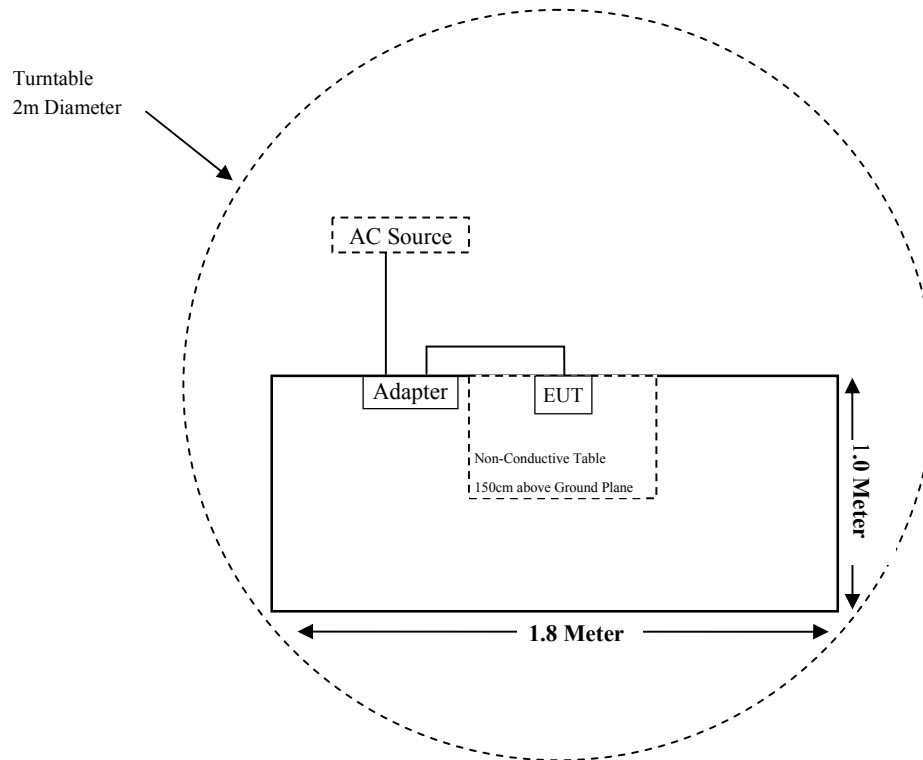
For Conducted Emissions:

The EUT has an omni antenna with RP-SMA connector, antenna gain is 2.94 dBi, fulfill the requirement of this section, please refer to the EUT photos.

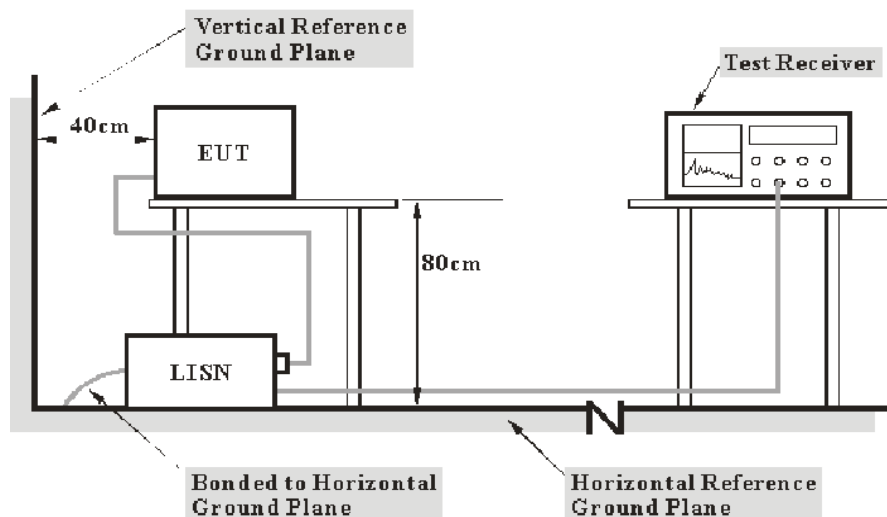

The measurement procedure of EUT setup is according with ANSI C63.10-2013. The related limit was specified in FCC Part 15.207.

The spacing between the peripherals was 10 cm.

### EMI Test Receiver Setup

The EMI test receiver was set to investigate the spectrum from 150 kHz to 30 MHz.

During the conducted emission test, the EMI test receiver was set with the following configurations:

## Test Procedure

ANSI C63.10-2013 clause 6.2

During the conducted emission test, the adapter1/adapter2 was connected to the outlet of the LISN.

Maximizing procedure was performed on the six (6) highest emissions of the EUT.

## Factor & Over Limit Calculation

The Corrected Factor is calculated by adding LISN VDF (Voltage Division Factor), Cable Loss and Transient Limiter Attenuation. The basic equation is as follows:

$$\text{Factor (dB)} = \text{LISN VDF (dB)} + \text{Cable Loss (dB)} + \text{Transient Limiter Attenuation (dB)}$$

The “**Over Limit**” column of the following data tables indicates the degree of compliance with the applicable limit. For example, an over limit of 7 dB means the emission is 7 dB above the limit. The equation for over limit calculation is as follows:

$$\text{Over Limit (dB)} = \text{Read level (dB}\mu\text{V)} + \text{Factor (dB)} - \text{Limit (dB}\mu\text{V)}$$

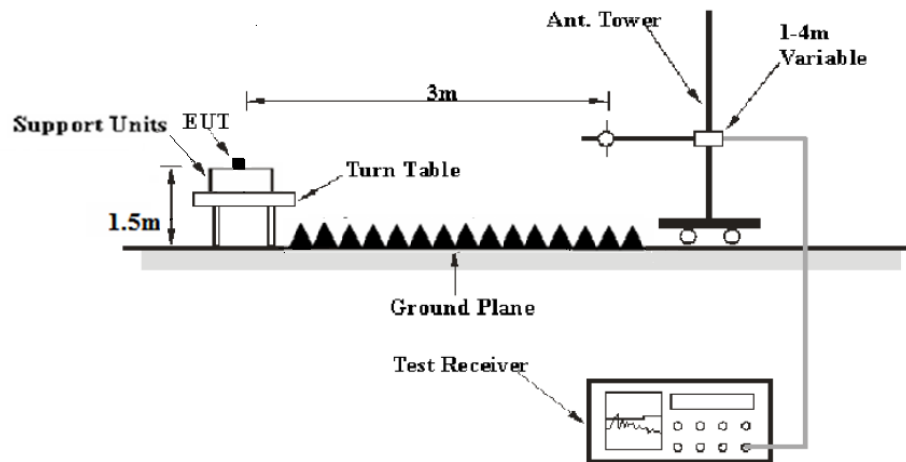

The radiated emission and out of band emission tests were performed in the 3 meters chamber test site, using the setup accordance with the ANSI C63.10-2013. The specification used was the FCC 15.209/15.205 and FCC 15.249 limits.

The external I/O cables were draped along the test table and formed a bundle 30 to 40 cm long in the middle.

### Test Equipment Setup

The system was investigated from 30 MHz to 25GHz.

During the radiated emission test, the EMI test receiver Setup was set with the following configurations:

### Test Procedure

Maximizing procedure was performed on the highest emissions to ensure that the EUT complied with all installation combinations.

Data was recorded in Quasi-peak detection mode for frequency range of 30 MHz-1 GHz, peak and Average detection modes for frequencies above 1 GHz.

### Corrected Amplitude & Margin Calculation

The Corrected Amplitude is calculated by adding the Antenna Factor and Cable Loss, and subtracting the Amplifier Gain from the Meter Reading. The basic equation is as follows:

Corrected Amplitude (dB $\mu$ V/m) = Meter Reading (dB $\mu$ V) + Antenna Factor (dB/m) + Cable Loss (dB) - Amplifier Gain (dB)

The “**Margin**” column of the following data tables indicates the degree of compliance with the applicable limit. For example, a margin of 7dB means the emission is 7dB below the limit. The equation for margin calculation is as follows:

Margin (dB) = Limit (dB $\mu$ V/m) - Corrected Amplitude (dB $\mu$ V/m)

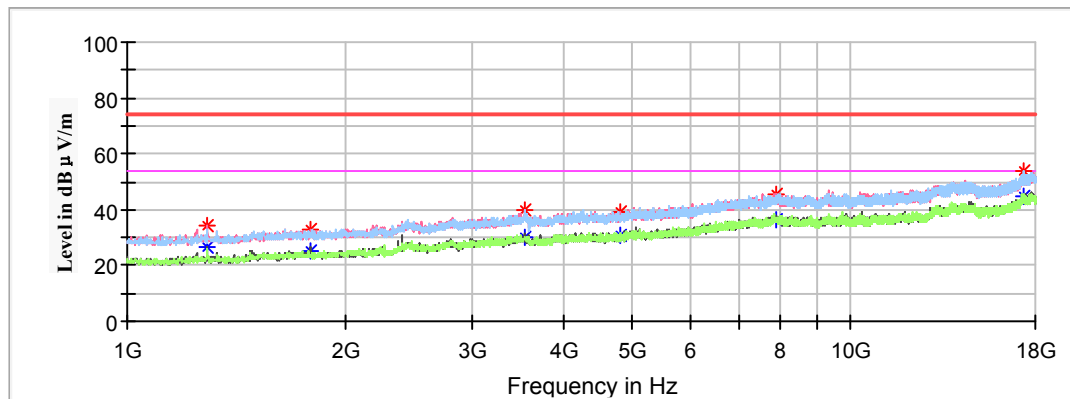

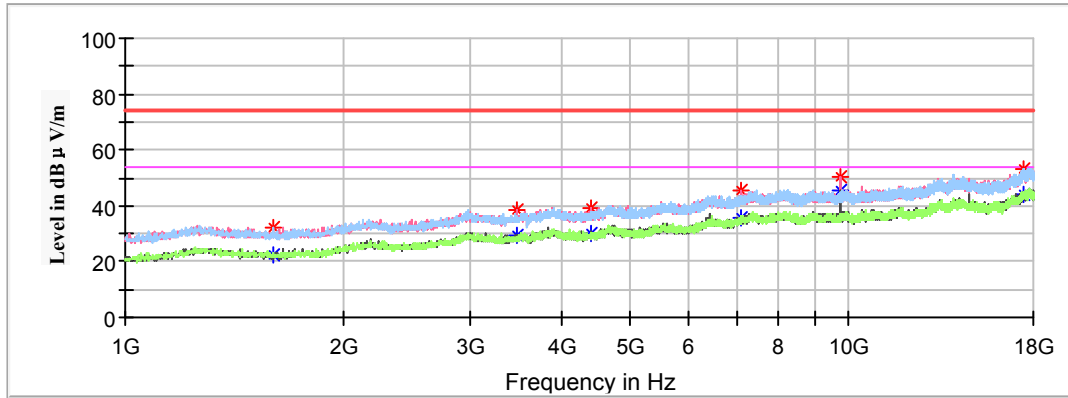

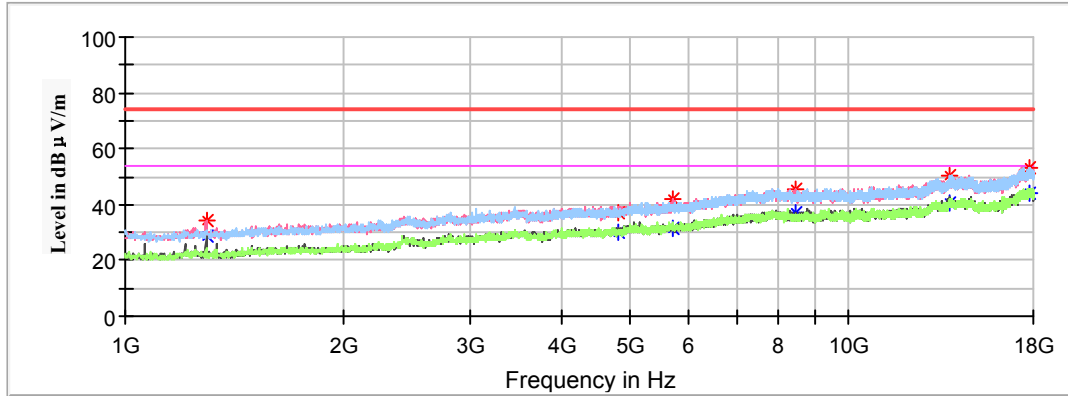

## Low Channel



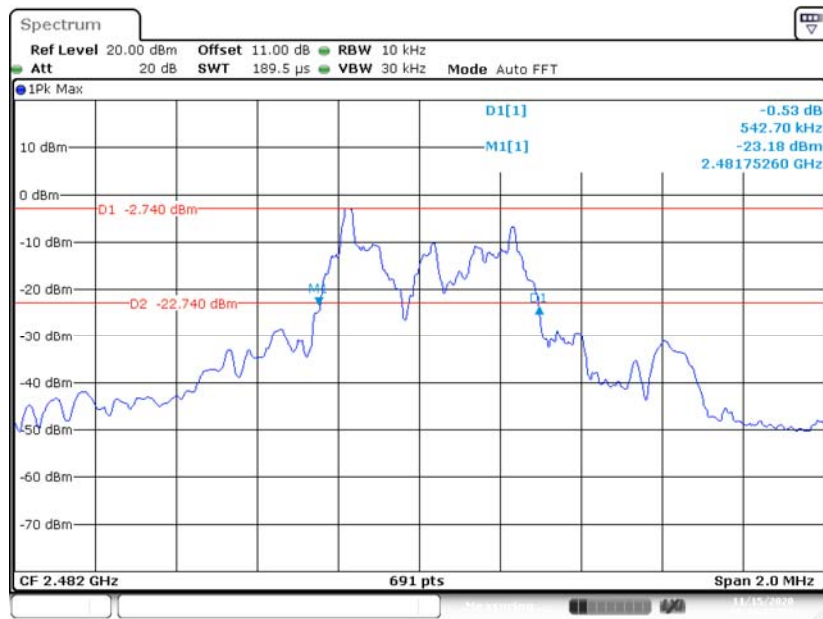
