


Fig.1 Photograph of the SAR measurement System




Fig.2.1 Photograph of the Tissue Simulant Fluid liquid depth 15cm for Flat (Body)




Fig.2.2 Photograph of the Tissue Simulant Fluid liquid depth 15cm for Flat (Body)






Fig. 2.3 Photograph of the Tissue Simulant Fluid liquid depth 15cm for Flat (Body)




Fig.3 Front side.




Fig.4 Back side.




Fig.5 Top side.




Fig.6 Bottom side.




Fig.7 Right side.
