Request for Modular Approval

Dear Sir/ Madam,

Sierra Wireless Inc., MC8700 GSM/UMTS/GPRS/EDGE/ HSDPA/HSUPA/HSPA+ module, FCC ID: N7NMC8700 would like to request for a modular approval. The requirements of Public Notice DA00-1407 are shown on the following statements:

| Item | Requirements | EUT |

| 1 | The modular transmitter must have its own RF shielding. | Yes, the EUT does provide a RF shielding. Refer to EUT picture. |
| 2 | The modular transmitter must have buffered modulation/data inputs. | Yes, the EUT has buffered data input it's integrated in chip MDM8200. |
| 3 | The modular transmitter must have its own power supply regulation. | Yes, the EUT has its own power supply regulation and it's integrated in chip: PM7540 |
| 4 | The modular transmitter must be tested in a stand-alone configuration, i.e., the module must not be inside another device during testing. This is intended to demonstrate that the module is capable of complying with Part 15 emission limits regardless of the device into which it is eventually installed. | The EUT was tested in a stand-alone configuration via a test kit. Please see section photographs of test configuration in the test report. |
| 5 | The modular transmitter must be labeled with its own FCC ID number, and, if the FCC ID is not visible when the module is installed inside another device, then the outside of the device into which the module is installed must also display a label referring to the enclosed module. This exterior label can use wording such as the following: "Contains Transmitter Module FCC ID: XYZMODEL1" or "Contains FCC ID: XYZMODEL1." Any similar wording that expresses the same meaning may be used. The Grantee may either provide such a label, an example of which must be included in the application for equipment authorization, or, must provide adequate instructions along with the module which explain this requirement. In the latter case, a copy of these instructions must be included in the application for equipment authorization. | Please see label sample for the FICC ID of this module. FCC ID: N7NMC8700. |
| 6 | The modular transmitter must comply with any specific rule or operating requirements applicable to the transmitter and the manufacturer must provide adequate instructions along with the module to explain any such requirements. | The EUT is compliant with all FCC rules. Details instructions of maintaining compliance are given in the user manual. |
| 7 | The modular transmitter must comply with any applicable RF exposure requirements. | The EUT is compliant with RF exposure requirement MPE evaluation. The MPE report is addressed in the RF exposure exhibition. |
