Question #1: Please provide Part 22/24 test report to address fundamental ERP/EIRP and radiated spurious emission in portable configuration.

<answer> As indicated in the Class II permissive change request letter, alternate antenna of same type with lower gain is requested to be installed in new laptop computer as portable device. The host platform included in this Class II permissive change filing is R60 Series which has same mechanical design and antenna is installed at the same location as T60 Series. T60 series has been approved as original application on Jan 30, 2006. The antenna used in the R60 series and T60 series is same type with same antenna pattern. As the result, Part 22/24 ERP/EIRP investigations were not performed due to similar host type, same antenna type, same antenna installation location and lower antenna gain.
