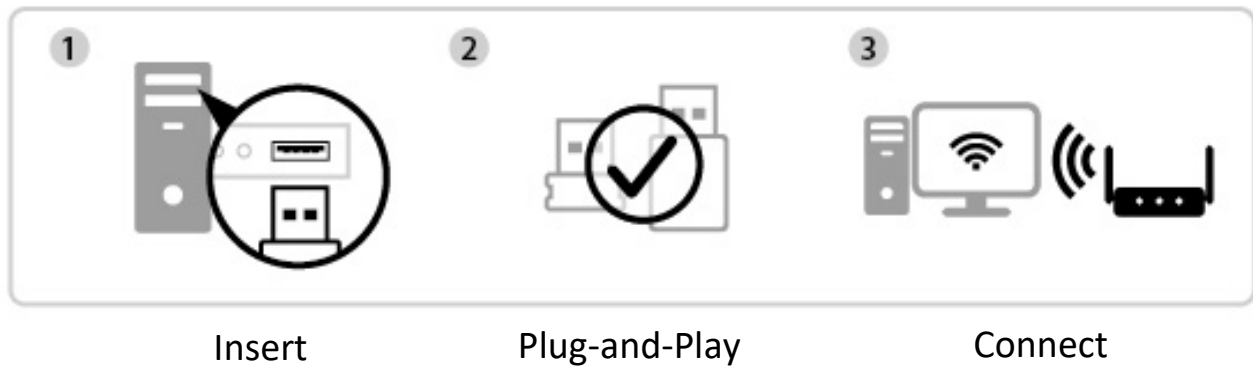

Insert the USB adapter into your computer.

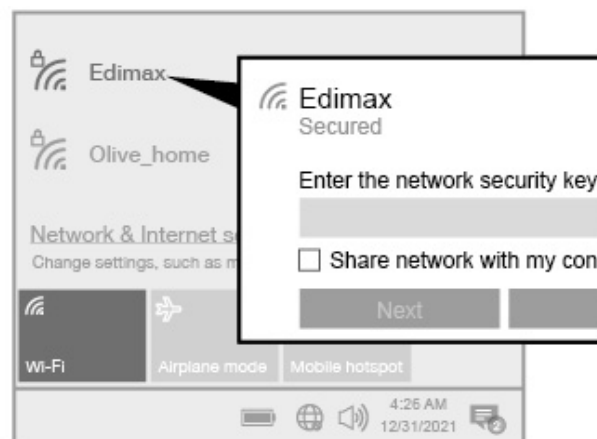
I-2. Plug-and-Play

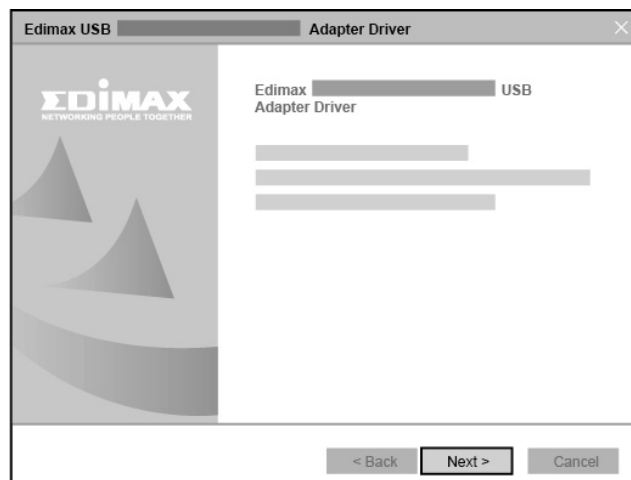

2. Unzip the downloaded file and run the setup.exe. Follow the instructions to complete the driver installation.

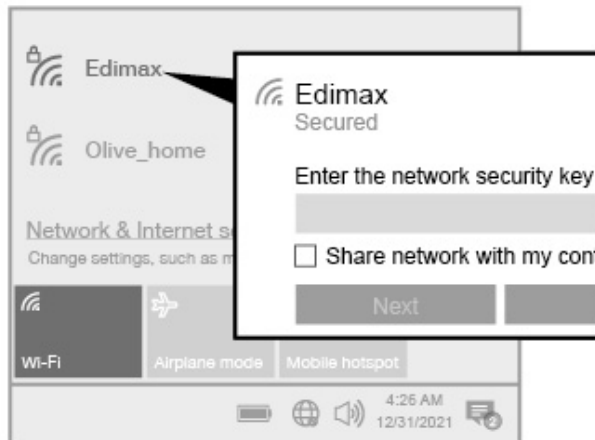


II-3. Connect to the Wi-Fi Network
