Placement tip:

Place your ADT Smart Home Hub in a central location within your home with a strong Wi-Fi signal, and away from any metal objects and appliances that generate heat.

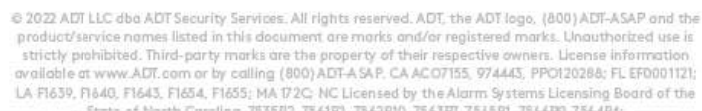

5. Do not place this device in a confined space such as a bookcase or a similar unit without proper ventilation.
6. Do not set up near any heat sources such as radiators, heat registers, stoves or other devices (including amplifiers) that produce heat.
7. Do not expose the device to water (dripping or splashing), and no objects filled with liquids, such as vases, shall be placed on the device.
8. Only use attachments/accessories specified by the manufacturer.
9. Disposing of your device and old battery: ADT is committed to environmental protection and sustainability. 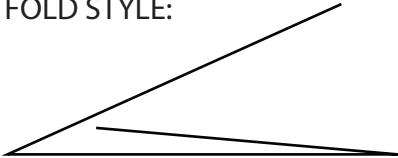

Arm Away

Arm States

Delays – Countdown for entry/exit.

Motion – Alarm will sound if motion is detected.

Arm Stay

Delays on, motion off.

Use when people or pets are home.

Arm Away

Delays on, motion on.

Use when leaving home and no pets are home.

Arm Night

Delays off, motion off.

Use at night when home.

Disarm + System Status

Indicates system is disarmed, has open sensors, or has errors.

Emergency

Press an emergency button, release, then press and hold same button for 3 seconds to activate. Dispatch requires paid monitoring.

Police

Siren sounds. Dispatch occurs if enrolled in paid monitoring.

Medical

Siren sounds. Dispatch occurs if enrolled in paid monitoring.

Fire

Siren sounds. Dispatch occurs if enrolled in paid monitoring.

Cancel

Use to cancel PIN entry.
