







Otherwise the emissions that did not have 10 dB margin would be re-tested one by one using peak, quasi-peak or average method as specified and then reported in a data sheet.


RADIATED MEASUREMENT SETUP




RADIATED MEASUREMENT SETUP

RADIATED RF MEASUREMENT SETUP






RF PORT COUNTED MEASURE SETUP
